2016 Bus Proposition

Shall the school bus proposition set forth in the notice of this meeting authorizing the purchase of one 30 passenger school bus at a maximum estimated cost of \$47,500, and one 7 passenger school suburban at a maximum estimated cost of \$45,025 and providing that such aggregate sum of \$92,525, shall be raised by a tax levy to be collected in annual installments, with District obligations to be issued in anticipation thereof in excess of its constitutional debt limit, be approved?

SEQRA Resolution

A RESOLUTION OF THE STOCKBRIDGE CENTRAL SCHOOL DISTRICT, MADISON AND ONEIDA COUNTIES, NEW YORK AS TO SEQRA DETERMINATION.

BE IT RESOLVED by the Board of Education of the Stockbridge Central School District, Madison and Oneida Counties, as follows:

<u>Section 1.</u> The Project which is the subject of this resolution is described as follows:

The construction, reconstruction and improvements to two (2) score boards located on the Stockbridge Valley Central School District athletic fields, including original equipment, extension of site electrical utilities and other incidental improvements and expenses in connection therewith, at a maximum estimated cost of \$50,000.

Section 2. It is hereby determined by the Board of Education that the Project is a Type II Action under the State Environmental Quality Review Act and the regulations promulgated thereunder, more specifically as defined in said regulations at 6 NYCRR Chapter VI, Part 615 (c)(8), and therefore no further environmental review is required.

Section 3. This resolution shall take effect immediately, and any and all actions taken in furtherance of the Project subsequent to July 7, 2015 and prior to this date are hereby fully ratified as if authorized prior to this resolution.
