High-Tech Security Features

Stockbridge Valley C. S. respectfully requests to amend this SSIP to decrease funds originally budgeted and approved for the installation of high-tech security as the district has completed the high-tech security project, filed the Final Cost Report with SED Facilities Planning on June 25, 2020, and filed a Claim with Smartschools on March 20, 2020. The claim paid for the high-tech security was \$279,641.18, leaving an overall SSIP Approved Budget Balance of \$34,270.82. At this time the District wishes to transfer available funds to be used for the purchase of equipment to meet needs for Classroom Learning Technology.
