"RESOLVED" that the Board of Education of the Stockbridge Valley Central School District, pursuant to Section 2509 of the Education Law and in compliance with Part 30.3 of the Rules of the Board of Regents, upon the recommendation of the Superintendent of Schools, does hereby appoint Kimberly Johnson to the position of 12:1:1 Students w/Disabilities Teacher in the tenure area of Students w/Disabilities Grades K-6 for a probationary period of four years, to commence on September 1, 2022, and to expire on September 1, 2026 (unless extended in accordance with the law). This expiration date is tentative and conditional only. Except to the extent required by the applicable provisions of Section 3012<sup>3</sup> of the Education Law, in order to be granted tenure the teacher must receive composite or overall annual performance review ratings pursuant to Section 3012-c and/or 3012-d of the Education Law of either effective or highly effective in at least three (3) of the four (4) preceding years, and if the teacher receives an ineffective composite or overall rating in the final year of the probationary period the teacher shall not be eligible for tenure at that time. Ms. Johnson will hold a valid New York State Certificate permitting her to serve in the field of Students w/Disabilities Grades K-6, AND BE IT FURTHER RESOLVED that during her first year of this appointment be paid at Step 5, \$48,640 plus Masters. There were 5 ayes and 0 nays. The motion carried.

"RESOLVED" that the Board of Education of the **Science Teacher** Stockbridge Valley Central School District, pursuant to Section 2509 of the Education Law and in compliance with Part 30.3 of the Rules of the Board of Regents, upon the recommendation of the Superintendent of Schools, does hereby appoint Jona Snyder to the position of 7-12 Earth/General Science Teacher in the tenure area of 7-12 Earth Science for a probationary period of three years, to commence on September 1, 2022, and to expire on September 1, 2025 (unless extended in accordance with the law). This expiration date is tentative and conditional only. Except to the extent required by the applicable provisions of Section 30123 of the Education Law, in order to be granted tenure the teacher must receive composite or overall annual performance review ratings pursuant to Section 3012-c and/or 3012-d of the Education Law of either effective or highly effective in at least two (2) of the three (3) preceding years, and if the teacher receives an ineffective composite or overall rating in the final year of the probationary period the teacher shall not be eligible for tenure at that time. Mr. Snyder will hold a valid New York State Certificate permitting him to serve in the field of 7-12 Earth/General Science, AND BE IT FURTHER RESOLVED that during his first year of this appointment be paid at Step 10, \$51,750 plus Masters. There were 5 ayes and 0 nays. The motion carried.

Upon the recommendation of the Superintendent of Schools, and on a motion by C. Garrett, seconded by H. Bingel, the Board accepted the Resignation of 7-12 Principal, Andrea Smith, effective July 22, 2022. There were 5 ayes and 0 nays. The motion carried.
