

**Rating Action: Moody's assigns Aaa to West Hartford, CT's GO Bonds; outlook stable**

New York, June 17, 2021 -- Moody's Investors Service has assigned a Aaa rating to the Town of West Hartford, CT's General Obligation Bonds, Series 2021B (Federally Taxable). The bonds have an expected par value of \$324.4 million. Moody's has also maintains a Aaa rating on the town's outstanding parity debt, totaling approximately \$117 million. The outlook is stable.

**RATINGS RATIONALE**

The Aaa rating reflects the town's large and growing tax base with strong income indicators. The tax base has grown in each of the last ten years and, despite the economic impact of COVID, is poised to continue to expand. Much of this growth is attributable to a robust local housing market that benefits from being equidistant from New York City and Boston. Residents from each of those cities have helped to drive up housing prices by approximately 11% on 16% higher sales volume.

The rating also captures the town's stable financial position that in fiscal 2020 saw a continuation of a six-year trend of operating surpluses. This helped to drive a modest increase to operating fund (general fund plus debt service funds) balance, which was \$34 million or 10.5% of revenues. While stable, this level of reserve is below the median for the rating category, and avoiding any material reduction to fund balance will be key to maintaining the rating. Beneficially, approximately 80% of the town's revenues are derived from stable and predictable property tax receipts. The town also maintains significant reserves outside the general fund that can be used to support operations. The fiscal 2021 budget projected a \$1.5 million reduction of reserves that the town is unlikely to realize. The town now expects a modest surplus on the strength of revenues, particularly conveyance tax and building permits, tracking well above budget while expenses have been in line with expectations. For fiscal 2022, the town anticipates additional tax base growth, a 1.5% tax increase, and the receipt of a third of approximately \$37 million in ARPA funds to help maintain operating consistency.

The rating also reflects the issuance of the current sale of GO bonds that have final maturity in 2046 and will increase the net direct debt to approximately \$460 million or a quite high 4.6% of ENGL. While the issuance will increase pension assets substantially, the town will face increased vulnerability to market volatility, and potentially increased required contributions, in the event that assets do not meet investment return assumptions. In conjunction with the issuance, the town has created a Pension Bond Reserve Fund and will deposit an amount equal to the fiscal 2022 required contribution (\$26.9 million) into the fund to offset potential increases to annual contributions or POB debt service. The town's rating could face negative credit pressure in the event that assets do not meet return expectations and fixed costs increase significantly.

**RATING OUTLOOK**

The stable outlook reflects the expectation that the town will continue to benefit from tax base expansion, leading to growing property taxes to support fiscal stability.

**LEGAL SECURITY**

The bonds are general obligations of the Town of West Hartford. The town pledges its full faith and credit,

including its ad valorem taxing power, to the payment of principal of and interest on the bonds.

#### USE OF PROCEEDS

Proceeds of the sale will be used to fund all or a portion of the West Hartford's unfunded actuarially accrued liability of the town's pension system.

#### PROFILE

West Hartford is located in central Connecticut, adjacent to the City of Hartford (Ba3 stable). The town has approximately 63,360 residents and population has been relatively stable over the last decade.
