

AGREEMENT

This Agreement is made as of the 21st day of November 2023, by and between Sweet Home Central School District, having an address of 1901 Sweet Home Road, Amherst, NY 14228 (the "District") and Evelyn Coggins, M.D., having an address of 120 West Eagle, Buffalo, NY 14202 (hereinafter called the "Provider").

For Good and Valuable Consideration, the sufficiency of which is hereby acknowledged, the parties agree as follows:

1. **Provision of Services.** Provider agrees to provide the District with the services set forth ON Schedule A attached hereto and made a part hereof (the "services"). To the extent requested by the District, the Services will be provided by the Provider at such time and location as are determined by the District.
2. **Payment of Services.** The District shall pay the Provider compensation and/or fees as set forth on Schedule B for the performance of the Services.
3. **Term/Termination.** The term of this Agreement shall be from 11/21/2023 through 11/21/2024 ("Term"). Either party may terminate this Agreement by giving ten ("10") days prior written notice to the Provider, and if this Agreement is terminated, no compensation will be due under paragraph 2 of this Agreement for services that were to be rendered during the period following the termination date.
4. **Amendment.** This agreement shall not be amended, changed, or modified in any manner except by an instrument in writing signed by a duly authorized representative of each of the parties hereto.
5. **Relationship Between the Parties.** The parties are independent contractors under this Agreement. Neither party shall have the authority to commit the other party to any binding obligation or to execute, on behalf of the other party, any agreement or other document creating legal obligations on the part of the other party, and neither party shall represent to any third party that it has such authority. Provider, as an independent contractor, and the Provider's personnel, shall not be considered employees of the District for any purpose.
6. This written Agreement, including the attached Schedules, contains the entire agreement between the parties. There is no other agreements or understandings concerning the terms of this Agreement.
7. This Agreement shall be binding upon and inure to benefit the executors, administrators, heirs, successors and assigns of the respective parties.


