A MESSAGE FROM THE SUPERINTENDENT



Dear Sweet Home Community,

The Sweet Home Central School District is proud to present to our community the proposed budget for the 2024-25 school year. When building our school budget, the goals are to place student interests and programming above all else, while remaining fiscally responsible to our school community. This budget accomplishes both of these goals and prepares us for a future where 21st century learning, and developing new skills to compete in a global economy, are more critical than ever.

Our Board of Education guides the work in terms of the budget. Their goals and priorities, in particular to enhance student programming while remaining fiscally responsible, provide the roadmap for District Office to start the process in the Fall. After they set their priorities, we then dive deep into the Sweet Home Strategic Plan to ensure we are positioned to meet the plan's goals and to have the resources necessary so students meet our graduation standards. We then communicate with our stakeholder groups to determine their needs and wants within our financial parameters. We are proud to say that our budget meets the goals and priorities set forth by the Board of Education, addresses the needs of our stakeholder groups, and remains fiscally responsible to the taxpayers of Sweet Home.

This doesn't mean we are free of challenges and concerns. Continual manipulation of the Foundation Aid formula by New York State makes it difficult to plan for our future. The promise by Albany to fully fund Foundation Aid (our general operating aid) lasted for one year (2023-24). That promise is now gone, and nearly \$615,000 of aid we would have had if the state kept its promise, is also gone. While we are financially sound as a District, Albany continues to change the playing field making the budget process more and more difficult. Next year, the state is attempting to alter how schools are funded, leaving more questions than answers. Finally, inflation continues to negatively impact our economy. Higher prices on goods and services seem like they are here to stay, yet paychecks are failing to keep up with inflation. We will of course continue to monitor developments in Albany, and advocate strongly for the students of our District.

The budget adopted by the Board of Education and being presented for your approval on May 21 totals \$100,410,422, a 3.6% increase from the 2023-24 school year. While this may seem significant, we are pleased to report that additional state aid due to an increase in our enrollment has offset that cost to our taxpayers. Even with a lower than expected foundation aid increase, our tax cap number, or maximum percentage tax increase allowed by law, is 3.90%. However, in keeping with our priorities set forth by the Board of Education, we are not asking our taxpayers to approve that increase, instead we are asking that our taxpayers approve a 1.8% tax increase.

Leading up to our annual district vote on May 21, we invite all members of our school community to our annual budget hearing and meet the candidate night on May 7 at 6:30 PM in the Vergils Community Center at District Office. The Board will also conduct a study session that evening. On May 14 at 6:30 PM the Board will hold a voting session where the public can also provide input and feedback on the budget. If between now and then you have any questions, comments, or concerns, please do not hesitate to contact the District Office.

It is critical that we reach our mission of "Every Student, One Community, Ready for the Future." We are extremely confident that this budget meets the goals of our Strategic Plan, enhances student programming, and provides a brighter future for all that we are fortunate to serve. We thank the Sweet Home community for your unconditional support of the work of our great District, and we look forward to seeing you on budget vote day, this May 21.

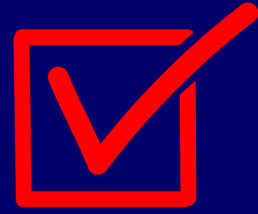

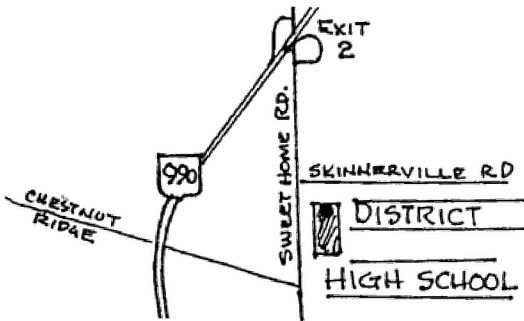

WHAT WILL YOU NEED?

TO VOTE, YOU MUST:

- Provide proof of residency
- Be a resident of the district for at least 30 days
- Be at least 18 years old
- Be a U.S. citizen

YOU NEED NOT:

- Be a registered voter
- Be a homeowner

PROOF OF RESIDENCY REQUIRED TO VOTE:

All eligible voters will need to provide proof of residency in order to cast their ballots at the Budget Vote on Tuesday, May 21, 2024. According to Chapter 775 of the Laws of New York, voters must present one form of proof which testifies to their legal address.

- Board of Elections card
- Post-marked mail
- Driver's license
- Rental/lease receipt
- Non-driver Identification card
- Utility bill

ABSENTEE BALLOTS

The Sweet Home Central School District allows for the use of Absentee Ballots at all district votes and elections.

1) Request an absentee ballot application by calling (716) 250-1402 or emailing District Clerk Sherry McNamara at smcnamara@sweethomeschools.org. The ballot will be included with the application.

If returning the application and ballot by mail, make your request no later than 4:00 PM on Tuesday, May 13, 2024. If returning the application and ballot in person, make your request on or before May 20, 2024.

2) Completed applications and absentee ballots will not be accepted after 5:00 PM on Tuesday, May 21, 2024, to the District Clerk's Office.

A MESSAGE FROM THE BOARD OF EDUCATION

At our April 16 voting meeting, the Sweet Home Board of Education adopted and recommended to the community the proposed 2024-25 school district budget. Our goal with any budget is to meet our mission of "Every Child, One Community, Ready for the Future," while balancing the considerations of the great taxpayers of our District. This budget meets those goals.

The 2024-25 Sweet Home Central School Budget totals \$100,410,422, a 3.6 percent increase from the previous year. This increase is supported through additional Foundation Aid (general operating funds) from New York State as a result of increases in our overall enrollment. While our tax cap number is 3.90%, it was a high priority of the Board not to pass that entire burden onto our taxpayers. Through the use of reserves and careful planning in terms of staffing, we are proposing a 1.8% increase in the tax levy for this budget.

When we adopted the Sweet Home Strategic Plan last year, we instructed the District Office to use it as a roadmap for key decision-making. We made it clear that the implementation of the plan is and will remain a priority, and that providing the resources to do just that is critical for us to meet our mission as a District. This budget will continue to meet the needs of our students, help them prepare for an ever-evolving landscape, and develop them into the Sweet Home graduate as described in the Strategic Plan.

While enhancing programming, the Board's commitment to the social and emotional well-being of all students remains strong. This budget enhances support for student services; provides resources at the District and building levels in the areas of Multi-Tiered Systems of Support and Leader in Me; and allows for the District to assess areas of student need and address those needs.

Our Diversity, Equity and Inclusion (DEI) initiatives remain strong and will continue to drive change in the District. This year, the DEI committees worked on the theme of belonging to ensure that all students and stakeholders have a voice at Sweet Home. We appreciate the work of the DEI Teaching and Learning committee as they continually monitor the progress of the Strategic Plan. The DEI Workforce Diversity Committee laid out new training and enhanced hiring practices to ensure we are finding the very best candidates to serve the students of our District. Also, the DEI Community Engagement committee continues to partner with the Northwest Amherst Community Center to provide programming for all members of our Sweet Home community.

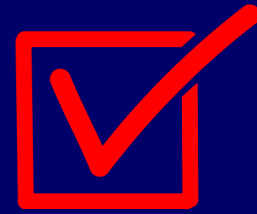
The budget also provides resources to continue the planning process for our next major capital project. Community input for the project this year was strong and it was clear that the priority of our next capital project must be on our elementary buildings. We know, through your participation in the ThoughtExchange and focus groups, that the project must address spacing issues, as well as enhance our buildings to support 21st century learning. Planning work will continue in 2024-25 as we complete the scope of the project, study our increasing enrollment, and prepare for a late Fall 2025 vote. Next school year will certainly be an exciting time for our District.

Also, it goes without saying that we greatly appreciate the work of our administration, faculty and staff, especially those that are entering the next phase of life. For those that have called Sweet Home home for decades, we sincerely thank you for your service to our students and want you to know that you will be sorely missed. It is the people that make our District great, and your work will never be duplicated or forgotten. We wish you nothing but the best in retirement and we are proud to say that you are Panthers for life.

Finally, we could not do this work without the support of our great community. We believe next year's budget will enhance student programming, provide for the social and emotional needs of our students, and prepare us for our future. 2024-25 BUDGET VOTE

SWEET HOME HIGH SCHOOL, MAY 21, 2024 7AM-9PM



During its voting meeting on Tuesday, April 16, the Board of Education of the Sweet Home School District approved the adoption of the proposed budget for the 2024-25 school year.

The proposed \$100,410,422 budget, includes the spending of \$929,278 for three (3) 70-passenger electric buses and three (3) 30 passenger buses. The District has been awarded \$661,000 in grant funding to aid in the purchase of the electric buses.

The total budget will see a 3.6% increase over last year. The proposed budget represents a 1.8% tax levy increase which falls within the New York State imposed tax cap for the District of 3.90%. Because the budget stays within the property tax levy limit, it needs only a simple majority to pass.

The Town of Amherst will move to full valuation for the coming year with its equalization rate moving from 62% to 100%. The District used 2023 assessed values from the Town of Tonawanda and projected full value assessments supplied by the Amherst Town Clerk to estimate tax rates. While tax rates and tax bills will be officially established in August, estimated homestead tax rates for the 2024-25 District budget are \$9.16 per thousand for the Town of Amherst and \$39.20 per thousand for the Town of Tonawanda. On a home in Amherst assessed at \$150,000, residents can expect a tax bill of \$1,374. On a similar home in the Town of Tonawanda, residents can expect a tax bill of \$1,411. Basic STAR savings are not included in the figures. Basic STAR savings for the Town of Amherst is \$363 and \$353 for the Town of Tonawanda. Once again, please note that these are estimates based on current year assessments for the Town of Tonawanda and projected assessments for the Town of Amherst.

In the school board election, Danyelle Anthon, Bill Kenney, Jonathan Makeley, Alan Plath and Dirk Rabenold will seek election to the Board's two open seats. The top vote-getter will be elected to a five-year term expiring on June 30, 2029 and the runner-up will fill the remainder of the term vacated by the resignation of Kailey McDonald. That term expires June 30, 2025.

There will also be an additional proposition on the ballot seeking authorization to use general funds in the amount of \$52,920 over the next two budgetary years to pay for lease expenses in order to maintain the temporary classrooms on the Maplemere campus. Since 2021 those expenses have been funded by federal grants. With the last of federal grants set to expire in September, the District must seek voter approval to use general funds for these expenses.

The Annual District Budget Vote & School Board Election will be held Tuesday, May 21 from 7 AM to 9 PM in the Vergils Community Center of Sweet Home High School, 1901 Sweet Home Road in Amherst.

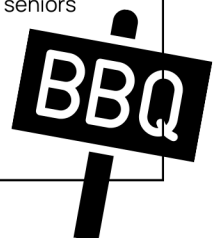

- **Election of two Board of Education members** - The term of Joshua Feldmann expires on June 30, 2024. Another seat is available following the resignation of Kailey McDonald. That term expires on June 30, 2025. Five candidates seek election to the two open board seats: Danyelle Anthon, Bill Kenney, Jonathan Makeley, Alan Plath and Dirk Rabenold.
- **Under the Property Tax Levy Cap** - The proposed budget seeks an increase in the overall tax levy of 1.8%, falling below the State imposed Tax Cap for the District of 3.9% and well below the rate of inflation.
- **Maintains Current Program and New Buses** - Proposed budget maintains current programming at all levels and authorizes the spending of \$929,000 for a total of six (6) new busses.
- **Proposition to expend \$52,920 in general funds to maintain temporary classrooms** on the Maplemere Elementary campus for the next two (2) school years.

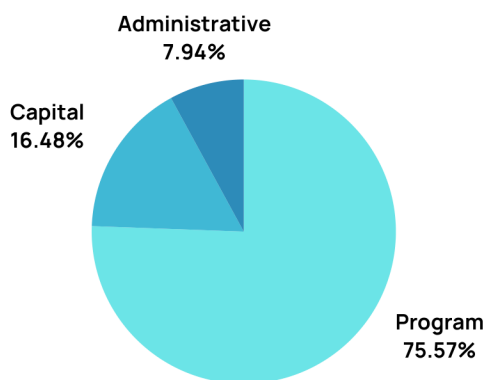

PROGRAM

2023-24 Budget: \$73,860,212

2024-25 Budget: \$75,882,180

The instructional component accounts for the instruction and educational support for the district's 3700 students. Salaries of teachers, guidance counselors, psychologists, social workers, coaches, therapists, teachers aides, computer technicians, and related clerical/support staff are included, as are their fringe benefits. Transportation (including contracted transportation), instructional computers, supplies, and textbooks, special education services, and expenses for summer school are included in this component.

ADMINISTRATIVE

2023-24 Budget: \$7,486,677

2024-25 Budget: \$7,975,762

The administrative component of the budget provides for the overall general support and management activities including the Board of Education, superintendent's office, curriculum and staff development, printing and publishing, and supervision and support in each of the six schools. Also included are expenses for legal services, liability and property insurance, and salaries and benefits for the administrative staff.

CAPITAL

2023-24 Budget: \$15,539,699

2024-25 Budget: \$16,552,479

Includes buildings and grounds salaries, equipment, vehicles, repairs, rentals, contracts, and supplies for all the custodial, grounds, and maintenance of all district buildings. Includes judgments and claims and refund of prior year property taxes due to reassessments and/or town clerical errors. Includes debt service principal and interest and interfund transfers for existing capital projects. Includes all fringe benefits for above employees.

TAX BILLS WITH EQUALIZATION RATES

Based on Average Assessed Value Using 2023-24 Assessed Values for the Town of Tonawanda and; 2024-25 Projected Assessed Values for the Town of Amherst as provided to the District by the Town Clerk's office.

The Sweet Home School District and its residents benefit from a strong commercial and residential tax base. Sweet Home homeowners realize further tax reductions through a lower tax rate called a homestead tax rate. Sweet Home's application of this concept, known as homesteading, serves as the model for successful tax differentiation programs across the state. These factors, combined with strong fiscal management by the Board of Education, allow the district to provide a first rate education for one of the lowest costs in Western New York. The impact on an average home is displayed below.

PROPERTY TAX CAP - HOW IS IT FIGURED?

Chapter 97 of the Laws of 2011 (Part A - Property Tax Cap) established a tax levy limit ("property tax cap") that affects all local governments, most school districts in New York State, except New York City, and a host of other independent taxing entities such as library, fire, and water districts.

Under this law, the growth in the property tax levy begins at the lesser of 2% or the Consumer Price Index (CPI). The CPI for this year is 4.1%. However, this rate can be increased by several local factors including:

- Local tax base growth factor
- Pension costs above a 2% increase
- Court orders/judgments above 5% of levy in prior year
- Capital expenditures related to construction or local expenses
- Changes in payments in lieu of taxes (PILOT)

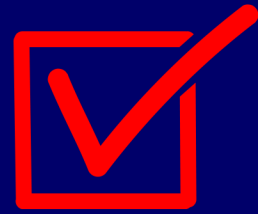
The 2024-25 Sweet Home Tax Cap after consideration of all local factors is \$55,403,513 or a 3.90% increase from 2023-24.

The proposed tax levy for the 2024-25 budget of \$54,268,072 falls within the state imposed property tax cap of 3.90% for Sweet Home Central School District requiring only a simple majority of voters to pass. The 2024-25 tax levy increase in the proposed budget is 1.8%.

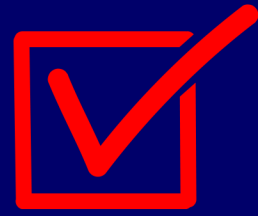
This year, I have been involved in raising awareness and support for Sweet Home teachers during contract negotiations, encouraging community engagement.

Thank you. Go Panthers.

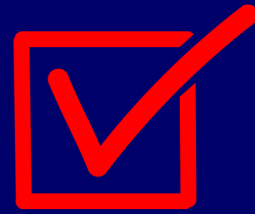

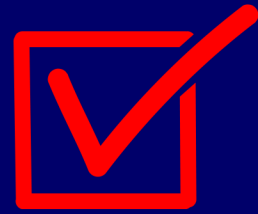

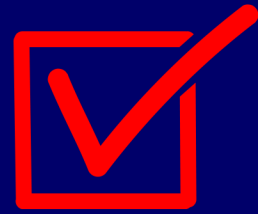
