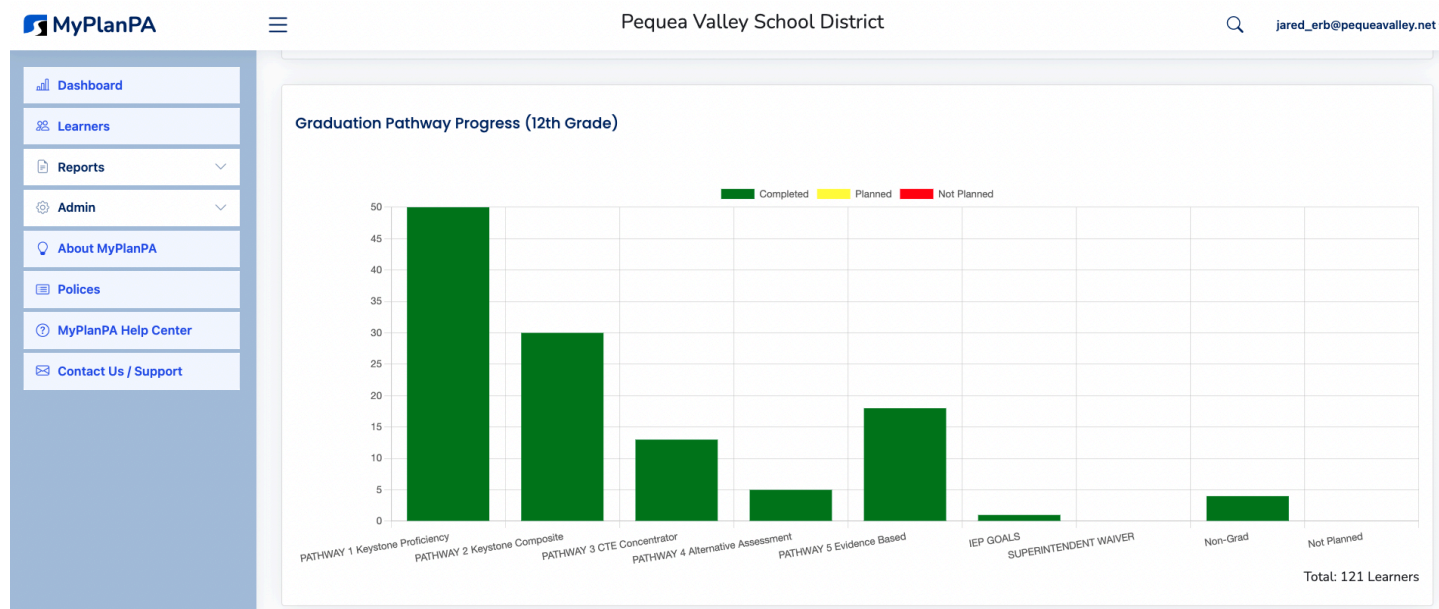

# Sierra Thomas EMT Internship

(Grade 11)



**INTRODUCTION:** My name is Sierra Thomas. I interned at Modena Fire Company under the supervision of Luann Thomas (Modena EMS Supervisor). Throughout this experience, I learned about how to help others and that this field comes with a lot of responsibility as well as challenges. Overall, this was a very rewarding experience.

**ACTIVITIES:** For my internship, I went on many different types of calls and learned more about the challenges and the responsibilities you pick up along the way as well as how to keep someone calm in the ambulance when taking them to the hospital. A typical day for me was heading over to MFC and seeing night or day shift clock out and I would get started on chores around the firehouse. These chores included washing the

ambulance off, mopping the floors, taking trash out, and mainly making sure the ambulance was stocked up on supplies. Some days will either be slow or fast paced. There are days we won't have calls and there are other days where we get calls back and forth. Some of these calls can affect the time you get back to the station to clock out. Some projects I got to work on were seeing patients in need and seeing them in their pre-hospital state. Also dealing with things like cardiac arrests and having to learn more CPR. Also seeing the medics give certain narcotics to patients during certain calls like broken limbs, etc.

**CONCLUSION:** This experience has helped me become more responsible and more social with others.

Working on a team and getting the job done together even if the calls are stressful we end up getting it done right. Without a doubt, this internship has solidified my decision of becoming a paramedic and continuing helping others in need. So, I plan to start my EMT training in August to continue on this journey to the next level.
