3. The School District does not guarantee to me, the Participant, that insurance proceeds will be available in the event of a mishap or accident involving such event.

4. I hereby release from liability, and waive any claims against the School District, its employees, school board members or officers, for any injury, loss or damages arising from me participating in the Alumni Soccer Game, including any claims for or pertaining to personal injury, wrongful death or costs relating to personal injury or wrongful death.
