2. Whitney ISD receives Title I, Part A funds and currently has two identified campuses serving Schoolwide Programs: Whitney Elementary School and Whitney Intermediate School. Our goal is to plan and implement effective parent and family involvement activities to improve student academic achievement and school performance.
