Recognized September as Suicide Prevention Month and his gratitude to our team
as we prioritize mental health across our system. Suicide, much like other mental
health conditions, can affect anyone regardless of age, gender, or background.
Every year thousands of individuals die by suicide, leaving behind their friends and
family members to navigate the tragedy of loss. About 80% of teens who die by

suicide show warning signs, 90% of teens who die by suicide have another mental health concern, and suicide is the 2nd leading cause of death in people ages 10-34. In efforts to support our students and families we have a team of Fresno Unified School Psychologists and School Social Workers who are providing prevention information and training to our students and staff about suicide this month as well as providing ongoing crisis support and interventions during and after a tragedy. Our district has an after-hours crisis team to respond to immediate needs of students, we've steadily increased our staffing and social emotional supports across the district, and we've expanded partnerships with CareSolace, TalkSpace, and more to support students, families and staff. If you or anyone you know may be struggling with mental health, please don't hesitate to send a referral to our teams by clicking the "social emotional wellness" icon on our homepage at www.fresnounified.org, or by calling the Central Valley Suicide Hotline at 1-888-506-5991.

- Shared the district is actively hiring substitutes across the district. We need substitute teachers to help ensure our students have a high quality teacher each day, we need substitute bus drivers to get our students safely and efficiently to and from school, we need substitute nutrition services workers to keep our students fed whether they're learning in-person or at home, we need substitute paraprofessionals to help us in the classroom and as we expand our after school programs, and we need substitute clerical staff to help us keep up with contact tracing across the district. Our teams have been working incredibly hard in this area, both through recruitment and through partnering with outside organizations. Just to give some context, we have almost 1,800 substitutes in our system right now, with 1,000 being certificated and the other almost 800 being classified subs. Of that list, less than 1/3 are taking regular sub days with us this year. We are making it work and have been deploying certificated and classified managers to school sites and classrooms, but the need is real. If you've ever wanted to serve our students, we need you now more than ever. We need our "coalition of the willing" with us side by side as we serve our students, in yet another difficult year due to this pandemic. - Announced the administration of this year's Confidential Family Survey (CFS) will begin later this month. This annual survey collects important household and income data from identified Fresno Unified families. ITEM DESCRIPTION: Included in the Board binders is an Independent Contractor Services Agreement for Lion and Fox LLC. This partnership would facilitate the creation of a tool that will allow the College and Career Readiness Department to identify and collect data efficiently and accurately for reporting and tracking required by the California Department of Education. There are currently 15 different types of work-based experiences that Fresno Unified needs to report to the California Department of Education as a component of the College and Career Indicators found on the state dashboard. These require data collections on the number of students participating in recognized pre-apprenticeship programs, state and federal job programs, and transitional work-based learning experiences both inside and outside of the classroom. The California Department of Education has also highlighted areas where data may potentially be collected and reported in the future, including student internships, student-led enterprises, simulated work-based learning, and the Armed Services Vocational Aptitude Battery-Armed Forces Qualification Test Score.

- b. Contractor hereby agrees that it shall not disclose Confidential Information, and any materials, discussions, or other communications concerning Confidential Information to any person or entity, except to its own employees, contractor personnel, and to its attorneys, accountants, consultants and other professional advisors having a "need to know," and who are themselves bound by similar nondisclosure restrictions (collectively, "Representatives"). If Contractor becomes aware of any disclosure or use not in compliance with this Agreement, Contractor shall notify the Committee in writing within three (3) business days. Contractor shall use at least the same degree of care in safeguarding Confidential Information as it uses in safeguarding its own confidential information. Representatives shall be bound to comply with all terms of this Paragraph 13.B. Upon the request of the Committee Contractor shall provide a written acknowledgement from each of its Representatives that said Representative is bound by the terms of this Paragraph 13.B.
- c. Contractor's obligation under this Agreement to not disclose Confidential Information shall not apply to information that: (a) becomes generally available to the public other than as the result of unauthorized disclosure by Contractor or a third party; (b) is independently developed by Contractor without the aid, application or use of Confidential Information; or (c) was received by Contractor on a non-confidential basis prior to receipt from the District or from a third-party lawfully possessing and lawfully entitled to disclose such information.
- d Disclosure of Confidential Information shall not be precluded if such disclosure is: (a) required pursuant to a valid court order; or (b) in the opinion of legal counsel for Contractor, is otherwise required by law, provided that in either circumstance:
 - i. Contractor shall furnish the District with a copy of the demand, summons, subpoena or other legal process to compel such disclosure;
 - ii. Contractor shall give the District reasonable prior notice of its intention to disclose Confidential Information in order to allow the Committee an opportunity to seek appropriate protection; and
 - iii. Contractor shall take all reasonable steps including, without limitation, the pursuit of a protective order, to restrict the disclosure of Confidential Information to the greatest extent possible.
- e. All Confidential Information provided by the District to Contractor is and shall forever remain the sole and exclusive property of the Committee and District. - or misuse of the District's Confidential Information. Such an action for a restraining order or injunction is in addition to and does not limit all other remedies provided by law or in equity or by agreement between the Parties.
- 15. <u>Indemnification and Hold Harmless</u>. To the fullest extent allowed by law, the Contractor shall defend, indemnify and hold District, its agents, employees, Board of Trustees, members of the Board of Trustees, officials, officers, volunteers, and representatives ("Indemnitees") free and harmless from any and all claims, demands, negligence (including the active or passive negligence of Indemnitees, regardless of whether sole or otherwise, as allowed by law), causes of action, costs, expenses, liabilities, losses, damages or injuries, fines, penalties in law or equity, regardless of whether the allegations are false, fraudulent, or groundless, to property or persons, including wrongful death, (collectively "Loss") to the extent arising out of or incident to: 1) the performance or breach of any of the terms and conditions of the contract (including but not limited to) the Contractor's use of the site; or 2) any acts, omissions, negligence, in connection with the performance of Services or otherwise arising from this Contract ("Indemnification"); or 3) the willful misconduct of the Contractor or their respective agents, subcontractors, employees, material or equipment suppliers, invitees, or licensees. The Contractor's Indemnification includes, but is not limited to, the payment of all damages and attorney's fees, fines, penalties and other related costs and expenses.
 - a The Contractor's defense obligations (with counsel approved by District), shall arise immediately upon tender of any of the Indemnitees, and the defense shall be paid at Contractor's own cost, expense and risk, for any and all such aforesaid suits, actions or other legal proceedings of every kind that may be brought or instituted against any of the Indemnitees, notwithstanding whether liability is, can be or has yet been established.
 - b. The Contractor shall pay and satisfy any judgment, award or decree that may be rendered against any of the Indemnitees, in any such suit, action or other legal proceeding. The Contractor shall reimburse Indemnitees, and each of them, for any and all legal expenses and costs incurred by each of them in connection therewith or in enforcing the indemnity herein provided.
 - c. Acceptance of insurance certificates and endorsements required under the contract does not relieve the Contractor from liability under this indemnification and hold harmless clause. The requirements of this Section (Indemnification and Hold Harmless) shall apply whether or not such insurance policies shall have been determined to be applicable to any of such damages or claims for damages.
- 16. Insurance. Without limiting "Contractor" indemnification, it is agreed that "Contractor" shall secure and maintain in force during the term of this Agreement a Commercial General Liability policy (Contractual liability included) utilizing an occurrence policy form, with limits of not less than one million (\$1,000,000) dollars per occurrence, two million (\$2,000,000) annual aggregate limit. Business automobile Liability Insurance shall be maintained for owned, scheduled, non-owned or hired automobiles with a combined single limit not less than one million (\$1,000,000) dollars per occurrence. In the event "Contractor" is working with students individually or providing professional services to students, "Contractor" shall maintain a policy providing coverage for sexual molestation and/or abuse claims. In the event that "Contractor's" Commercial General liability policy excludes coverage for sexual molestation and/or abuse claims shall be required to procure a separate or supplemental policy providing such coverage. The limits of coverage for the abuse and molestation policy shall be not less than \$1,000,000 per claim and \$3,000,000 aggregate. If any of the required policies provide coverage on a claims-made basis then the following shall apply; 1) The retroactive date must be shown, and must be before the date of the contract or the beginning of contract work; 2) Insurance must be maintained and evidence of insurance must be provided for at least five (5) years after completion of the contract work; (3) If coverage is canceled or non-renewed, and not replaced with another claims-made policy form with a retroactive date prior to the contract effective date, the Contractor must purchase "extended reporting" coverage for a minimum of five (5) years after completion of work. Self-insured retentions must be declared to and approved by District. The District may require "Contractor" to provide proof of ability to pay losses and related investigations, claims administration and defense expenses within the retention. The policy shall provide, or be endorsed to provide, that the self-insured retention may be satisfied by either the named insured or the District.

The District shall be named as an additional insured on the policies by separate endorsement. A Certificate of Insurance and endorsements shall be attached to the Agreement as proof of insurance. The "Contractor" policy shall provide that it is primary such that insurance maintained by the District, if any, shall be excess and not co-primary. - 17. <u>Independent Contractor Status</u>. While engaged in carrying out the terms and conditions of the contract, the Contractor is an independent contractor, and not an officer, employee, agent, partner, or joint venture of the District.
- 18. <u>Workers' Compensation Insurance</u>. Contractor agrees to provide all necessary workers' compensation insurance for Contractor's employees, if any, at Contractor's own cost and expense.
- 19. Fingerprinting Requirements. Contractor hereby acknowledges that, if applicable, it is required to comply with the requirements of Education Code Section 45125.1 with respect to fingerprinting of employees who may have contact with the District's pupils. The Contractor shall also ensure that its consultants on the Project also comply with the requirements of Section 45125.1. CONTRACTOR OBLIGATIONS. Unless specifically stated otherwise on this Cover, Contractor shall provide all labor, materials, supplies, and equipment necessary to perform all obligations required of Contractor as set forth elsewhere in this Agreement and the following "Services":

What Services will Contractor provide: Contractor shall be responsible for the following:

I. Service I: 2021 YOUNG WRITER'S ACADEMY REGISTRATION FEES:

A. United We Lead Foundation ("Contractor") will recruit "Credentialed Teachers" (Teachers") and Bilingual paraprofessionals ("Tutors") to implement the 2021 Young Writer's Academy (hereafter "Program").

- B. Programming will focus on improving students' academic proficiency in the subject area of ELA. Through a 7-week Saturday academy series of ELA classes, writing labs, workshops, along with empowerment, guidance, mentoring, and 1:1 support, participating students will be able to navigate the often-daunting college and career readiness process and foster creativity, self-expression and unleash their excitement about writing and college. Contractors' curriculum, personnel, and resources will focus on ELA, ELD, and writing structure and its implementation of expository text.
 - a. The Young Writer's Academy will provide students services in: English Language Arts, Social-Emotional Learning, Writing Skills, College & Career Readiness, Leadership Skills and Self-Pride.
- C. Contractor will be responsible for the planning, implementation, and delivery of the Program as well as provide direct instruction and guidance to incoming 7th-10th grade migrant students enrolled in the Program.
- D. Contractor shall conduct sessions as in a virtual setting due to state and local public health guidelines pertaining to Covid-19.
- E. Contractor shall design and provide curriculum that aims to increase vocabulary and writing skills to improve students' ELA/ELD proficiency, self-pride, cultural self-pride, college & career readiness, and parent engagement.
- F. Contractor shall provide personnel, lesson plans and all materials and supplies necessary to implement and conduct the distance learning Program.
- G. Contractor will perform the live programming on the following dates:
 - a. Fall Cohort: October 16 December 4, 2021
 - Session I: Saturday, Oct. 16, 2021
 - Session II: Saturday, Oct. 23, 2021
 - Session III: Saturday, Oct. 30, 2021
 - Session IV: Saturday, Nov. 6, 2021
 - Session V: Saturday, Nov. 13, 2021
 - Session VI: Saturday, Nov. 20, 2021
 - Session VII: Saturday, Dec 4, 2021
- H. Contractor will provide daily instruction from 9:00am 2:30pm on the dates listed above or as otherwise agreed upon both parties.
- I. Contractor will conduct a 1-day professional development/orientation for all personnel involved in the program. Training shall include program goals, objectives, and a brief overview about the unique needs of migrant students.
- J. Service amount of \$39,800.00 is based on a per pupil cost of \$995. Program shall accommodate up to 40 eligible students.

II. Service II: STUDENT SUPPORT & RECRUITING SERVICES

- A. Recruit and provide one (1) Bilingual Service Support Staff "Staff" to assist FRESNO UNIFIED SCHOOL DISTRICT, MEP with the identification and recruitment efforts of the 2021 Young Writer's Academy.
- B. Staff shall provide 1:1 support and registration assistance prior and throughout the duration of the contract.

- C. Staff shall complete an initial contact via phone to identify and register future participants.
- D. Staff shall identify and enroll up to 40 eligible participants.
- E. Contractor shall log all family contact including telephone calls with each family to ensure successful participant enrollment.
- F. Service amount of \$2,995 is based on a one-time flat rate to recruit up to 40 program participants.

III. Service III: SOCIAL-EMOTIONAL LEARNING (SEL) WORKSHOP

- A. Contractor shall provide one (1) Bilingual school social workers with a M.A in Social Work and a PPSC credential "School Social Worker" to assist FRESNO UNIFIED SCHOOL DISCRICT, MEP with the planning, implementation, and delivery of a 90-minute workshop in the subject of Social Emotional Learning (SEL).
- B. Content shall be formulated in a way in which participants can develop skills to cope with the extreme uncertainty surrounding "Covid-19" and developing coping skills to adapt to difficult circumstances. During this workshop, participants shall be given activities that create an intersectionality between their student's learning behaviors, early development, and their social emotional skills.
- C. School Social Worker shall provide direct instruction to eligible migrant parents identify and recruited by FRESNO UNIFIED SCHOOL DISTRICT, MEP in a distance learning setting.
- D. Service amount of \$475 is based on a one-time flat rate for a 90-minute workshop.

FRESNO UNIFIED SCHOOL DISTRICT, MEP OBLIGATIONS.

FRESNO UNIFIED SCHOOL DISTRICT, MEP shall perform all obligations required of FRESNO UNIFIED SCHOOL DISTRICT, MEP as set forth elsewhere in this Agreement and the following:

- I. FRESNO UNIFIED SCHOOL DISTRICT, MEP shall be responsible for submitting rosters of eligible participants to recruit for the Program under Service I and II.
- II. FRESNO UNIFIED SCHOOL DISTRICT, MEP shall be responsible for the recruitment and identification of participants for Service III.
- III. FRESNO UNIFIED SCHOOL DISTRICT, MEP shall assist UWLF in the coordination and management of all Services.

In consideration of the covenants, conditions, and promises in and for good and valuable consideration and the mutual benefits to be derived from this Agreement, Contractor and FRESNO UNIFIED SCHOOL DISTRICT, MEP, separately referred to as a "Party" and collectively as the "Parties," have reviewed and understand and hereby enter into this Agreement. Unless the context requires otherwise, any reference to a Party in this Agreement includes, as applicable, its governing body and members thereof, officers, employees, and agents. GENERAL TERMS AND CONDITIONS

1.0. Contract Term and Termination.

1.1. This Agreement takes effect immediately as of the Effective Date and remains in full force and effect until the Contractor has completed the Services as per *Scope of Services* and any written extension thereto (the **"Contract Term"**), unless earlier terminated under this Section 1.

2.0. Contractor Services.

2.1. During the Contract Term, the UWLF shall may engage the Contractor to provide services as per *Scope of Services* (the "Services"), or other such services as mutually agreed upon in writing by the Parties.



2.2. The work performed by the Contractor shall be performed as per *Scope of Services*. FRESNO UNIFIED SCHOOL DISTRICT, MEP shall remit payment to the Contractor within 45 30 days of receiving the invoice from the Contractor.

3.0. Independent Contractor Status.

- 3.1. The Parties intend that the Contractor and any Contractor Personnel be engaged as independent contractors of UWLF. Nothing contained in this Agreement will be construed to create the relationship of employer and employee, principal and agent, partnership or joint venture, or any other fiduciary relationship.
- 3.2. FRESNO UNIFIED SCHOOL DISTRICT, MEP may not act as agent for, or on behalf of, the UWLF, or to represent the UWLF, or bind the UWLF in any manner.

4.0. Representations.

4.1. Both Parties represent that they are fully authorized and empowered to enter into this Agreement, and that the performance of the obligations under this Agreement will not violate or infringe upon the rights of any third-party or violate any agreement between the Parties and any other person, firm or organization or any law or governmental regulation.

5.0. Indemnification.

5.1. The Contractor shall indemnify and hold harmless the Fresno Unified School District, MEP UWLF, its affiliates, and its respective officers, directors, agents and employees from any and all claims, demands, losses, causes of action, damage, lawsuits, judgments, including attorneys' fees and costs, arising out of, or relating to, the Contractor's services under this Agreement.



6.0. Payment.

6.1. As full consideration and compensation for Contractor's performance of this Agreement, FRESNO UNIFIED SCHOOL DISTRICT, MEP shall pay Contractor the Contract Amount in accordance with the Payment Schedule stated on page 1 of this Agreement.

7.0. Liability.

EXCEPT WITH RESPECT TO THE PARTIES' INDEMNIFICATION OBLIGATIONS, NEITHER PARTY SHALL BE LIABLE TO THE OTHER FOR ANY SPECIAL, INDIRECT, INCIDENTAL, PUNITIVE, OR CONSEQUENTIAL DAMAGES ARISING FROM OR RELATED TO THIS AGREEMENT, INCLUDING BODILY INJURY, DEATH, LOSS OF REVENUE, OR PROFITS OR OTHER BENEFITS, AND CLAIMS BY ANY THIRD PARTY. THE FOREGOING LIMITATION APPLIES TO ALL CAUSES OF ACTION IN THE AGGREGATE, INCLUDING WITHOUT LIMITATION TO BREACH OF CONTRACT, BREACH OF WARRANTY, NEGLIGENCE, STRICT LIABILITY, AND OTHER TORTS.

8.0. Disclaimer of Warranty.

THE WARRANTIES CONTAINED HEREIN ARE THE ONLY WARRANTIES MADE BY THE PARTIES HEREUNDER. EACH PARTY MAKES NO OTHER WARRANTY, WHETHER EXPRESS OR IMPLIED, AND EXPRESSLY EXCLUDES AND DISCLAIMS ALL OTHER WARRANTIES AND REPRESENTATIONS OF ANY KIND, INCLUDING ANY WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, TITLE, AND NON-INFRINGEMENT. THE UWLF DOES NOT PROVIDE ANY WARRANTY THAT OPERATION OF ANY SERVICES HEREUNDER WILL BE UNINTERRUPTED OR ERROR-FREE.

9.0 Miscellaneous Provisions.

- 9.1. This Agreement, and any accompanying appendices, exhibits, duplicates, or copies, constitutes the entire agreement between the Parties with respect to the subject matter of this Agreement, and supersedes all prior negotiations, agreements, representations, and understandings of any kind, whether written or oral, between the Parties, preceding the date of this Agreement.
- 9.2. This Agreement may be amended only by written agreement duly executed by an authorized representative of each party.
- 9.3. This Agreement shall not be assigned by either party without the express consent of the other party.

Why Are We Doing This?

- Every 10 years the federal government conducts the Census, and each school district must update its trustee areas to reflect the latest population counts, so that they are equal in population.
- Requirement is both statutory, see Education Code § 5019.5(a), and constitutional, see Reynolds v. Sims, 377 U.S. 533 (1964).







Redistricting Process: Key Dates

- August 12, 2021: Census Bureau released PL94-171 redistricting data
 - Usually released in Feb/March of year following Census
- February 28, 2022: deadline for completion of redistricting process.
 (Educ. Code § 5019.5)
- January 12, 2022: anticipated completion date (to allow ample time for implementation by the Fresno County Elections Office)
 - If necessary, additional action can be taken at Board Meeting on Feb. 2, 2022



Redistricting Process: Anticipated Board Meetings/Hearings

August 25, 2021	Presentations at Board meeting re (1) legal and policy criteria governing redistricting, and (2) demographics of existing trustee areas. Receive public comment on appropriate criteria.
September 15, 2021	Board receives further public input and additional testimony regarding appropriate criteria; adopts criteria and provides instructions for the preparation of alternative draft redistricting plans.
October 27, 2021	Demographic consultant to present initial draft trustee area plans; Board solicits testimony on draft plans.
November 17, 2021	Board receives public input and additional testimony regarding draft plans; holds first public hearing on draft plans; Board may order modifications to any of the plans.
January 12, 2022	Board holds second public hearing on alternate plans, votes to choose one plan. If Board orders further modifications, another public hearing will be required.

Process: Effect on Current Trustees

- No trustee's term cut short (see Educ. § 5021;
 Elec. Code § 22000(e)), but
- When his or her term ends, an incumbent can only run from the new trustee area in which he or she resides.







Federal Criteria: Equal Population

- Overriding criterion is total population equality, see Reynolds v. Sims, 377 U.S. 533 (1964).
- Unlike congressional districts, local electoral districts do not require perfect equality—some deviation acceptable to serve valid governmental interests.
- Total deviation less than 10% presumptively constitutional.
 (Caution: the presumption can be overcome!)



Federal Criteria: Voting Rights Act

- Section 2 of the federal Voting Rights Act prohibits electoral systems (including district plans), which dilute racial and language minority voting rights by denying them an equal opportunity to nominate and elect candidates of their choice.
- "Language minorities" are specifically defined in federal law to mean persons of American Indian, Asian American, Alaskan Natives or Spanish heritage.




Federal Criteria: Voting Rights Act (cont.)

"'Packing' refers to the practice of filling a district with a supermajority of a given group or party. 'Cracking' involves the splitting of a group or party among several districts to deny that group or party a majority in any of those districts."

> -Vieth v. Jubelirer, 541 U.S. 267, 286 n.7 (2004)

 Creation of minority districts required only if the minority group can form the majority in a single member district that otherwise complies with the law.
 Bartlett v. Strickland, 556 U.S. 1 (2009).






Four districts of even "Blue" and "Gold" party voters, OR one "packed" district of 14 Blue voters and two Gold voters with the remaining 18 Blue voters "cracked across the other three districts. The result is a 3-1 advantage for the Gold party

Federal Considerations: No Racial Gerrymandering

- The Fourteenth Amendment restricts the use of race as the "predominant" criterion in drawing districts and the subordination of other considerations. Shaw v. Reno, 509 U.S. 630 (1993); Miller v. Johnson, 515 U.S. 900 (1995).
 - Such predominant use must be justified as narrowly tailored to fulfill a compelling state interest *i.e.*, strict scrutiny
- Looks matter! Bizarrely shaped electoral districts can be evidence that racial considerations predominate. (See, e.g., North Carolina CD 12, which stretched 160 miles across the central part of the State, for part of its length no wider than the freeway right-of-way.)




- But bizarre shape is not required for racial considerations to "predominate."
- Fourteenth Amendment does not, however, prohibit all consideration of race in redistricting. *Easley v. Cromartie*, 532 U.S. 234 (2001).
 - Focus on communities of interest.

Other Permissible Criteria

Some other legitimate criteria include:

- Minimize shifting voters from one election year to another/retaining core of existing districts
 - Voters currently in districts scheduled to vote in 2022 could be redistricted into a 2024 district, meaning there would be a six-year gap between their voting in Board elections
- Respect will of the voters / avoid head-to-head contests

Introduction

The District's Initial Contract Proposal to the Fresno Teachers Association – Social Workers Bargaining Unit is based on the following Guiding Principles and Supporting Goals and Priorities. By continuing to adhere to these Principles and Goals, the District reiterates its investment in the students we serve. All subsequent District proposals, as well as Association proposals, will be assessed by the District according to whether they further the accomplishment of these criteria.

<u>Guiding Principle: Accelerating Learning for All Students In Order to Prepare Career Ready</u> Graduates

In order to promote and secure the preservation and future of Fresno Unified School District as a viable, locally governed academic institution that exists to serve children, District resources, energy and effort must be dedicated to the overriding goal of accelerating learning for all students in order to prepare career ready graduates.

Supporting Goals and Priorities

- 1. <u>Fiscal Health and Budget Certainty:</u> The concerted effort to accelerate student learning cannot be diluted, and the focused efforts of all District personnel in this enterprise cannot be distracted or derailed by the uncertainty inherent in the state's funding of public education. The District's commitment to sustaining its fiscal solvency despite historic instability in the economy at the state and local levels requires that we continue to build and maintain healthy reserves.
- 2. <u>Build Educational Programs</u>: The Governing Board must have the discretion and ability to build educational programs that accelerate learning and guarantee student achievement.
- 3. <u>Identify Appropriate Revenues Available for Adjustments to Employee Compensation:</u> Student learning cannot be accelerated, and students cannot achieve academic success without the efforts of skilled educators and staff who are dedicated to this effort. In order to attract and retain the most qualified and committed individuals to fill these roles, the District will seek to make an appropriate and "equitable allocation" of increased District revenue for employee compensation. In order to be "equitable and appropriate," the level of such allocation must support all of the Goals and Priorities set forth above.

Consideration of and responses to Association proposals will be consistent with the District's Guiding Principle, Supporting Goals and Priorities. The District looks forward to collaborative, objective and reality-based negotiations with Fresno Teachers Association as we prepare to meet the challenges facing all stakeholders of the District community.

With these goals, priorities and economic constraints in mind, the District proposes as follows:

DISTRICT INITIAL PROPOSAL:

Developing a Collective Bargaining Agreement That Meets the Needs of Social Workers, Students, Families and the District

The District is interested in developing a collective bargaining agreement with the Social Workers unit that best serves our stakeholders and promotes positive labor relations. To that end, the District will provide proposals on working conditions specific to the Social Workers unit with these goals in mind.

Term of Agreement

The District proposes a three year term for the parties' contract commencing July 1, 2021 and ending June 30, 2024.

Economic Articles

The District is interested in:

- Maintaining fiscal stability levels in order to preserve and protect quality education services for students in furtherance of our primary mission to improve student achievement;
- Recognizing and rewarding the continuing efforts of dedicated District staff both certificated and classified employees – that make it possible for the District to deliver quality education services for students; and
- Exploring the reallocation and re-purposing of current compensation expenditures in furtherance of the interests listed above.

Conclusion

The Governing Board and District administration are committed to achieving the goals and priorities set forth in this Initial Proposal. There is only one goal all must strive to achieve: Accelerating learning for all students in order to prepare career ready graduates. Failure to achieve this goal is not an option.
