- \* (10) Assist teacher in monitoring Individual Education Plan goals for students with disabilities.
- \* (11) Assist in supporting, transporting, and assisting students with physical disabilities.

### **Administrative/Management**

- \* (12) Use time efficiently.
- \* (13) Provide student supervision before, during, and after school while they are loading, riding, and unloading buses, on the playground, in the cafeteria, in a learning or practice situation, following appropriate training, as assigned.
- \* (14) Assist in maintaining the security of records, materials, and equipment.
- \* (15) Assist the teacher in the enforcement of classroom rules and the maintenance of appropriate records.
- \* (16) Maintain a clean and orderly environment for students.
- \* (17) Check objective tests and mark errors but not assign a grade.

- \* (27) Assist students with personal hygiene, health and safety issues, or grooming if required.
