All Board Meetings will be live-streamed and recorded and may capture images and sounds of those attending the meeting. Recordings will be available for public viewing on the District's website.

Public comments may be made by any person attending the Board meeting in person. Individual speakers shall be allowed three (3) minutes to address the Board on each agenda or non-agenda item. Please note that speaking time cannot be delegated to another person. The Board shall limit the total time for public input on each item to 20 minutes. With Board consent, the President may increase or decrease the time allowed for public presentation, depending on the topic and the number of persons wishing to address the Board Members of the public utilizing a translator to address the Board shall be limited to six (6) minutes unless the Board agrees to extend the time beyond six (6) minutes. Pursuant to Brown Act, Government Code section 54954.3(a). All public comment cards must be submitted to the designated staff member prior to the calling of the agenda item in which you wish to address the Board. The Board President, or designee, will call you at the appropriate time to hear your comment.

The meeting procedures for agendized items include: Board President announces the Agenda item; Supervising Administrator reports/presents; Board questions; Public Comment; Board discussion/deliberation; Motion; Board vote.

The Board understands that the First Amendment provides strong protection for speech. However, the Board expects that all speech and expression will comport with norms of civil behavior on district grounds, in district facilities, during district activities or events, and in the use of district electronic/digital systems and platforms.

Civil behavior is polite, courteous, and reasonable behavior which is respectful to others and includes integrity, honesty, acceptance, timeliness, dependability, observance of laws and rules (such as SB1100, Section 54957.95), and effective communication.
