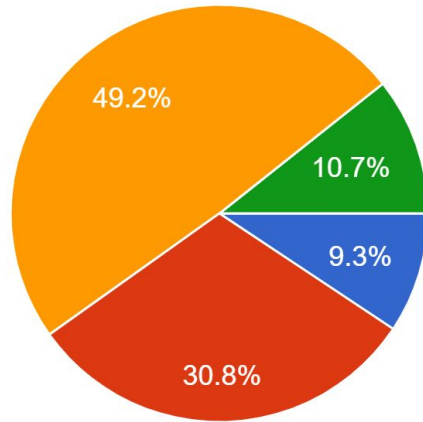

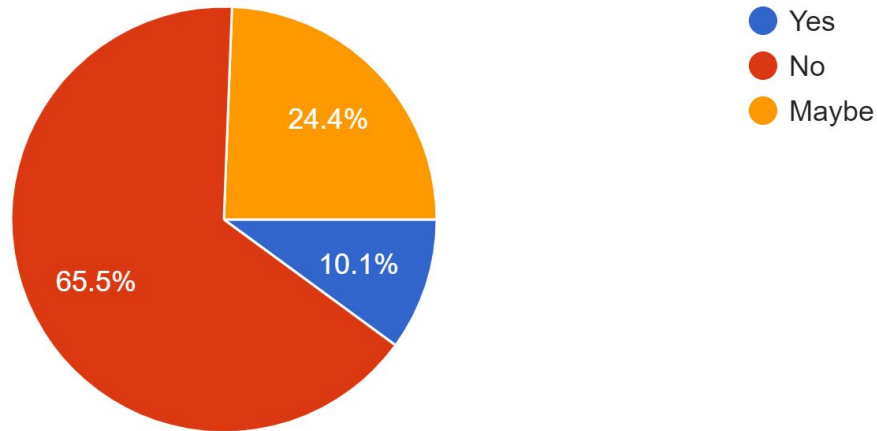

Parent Survey:

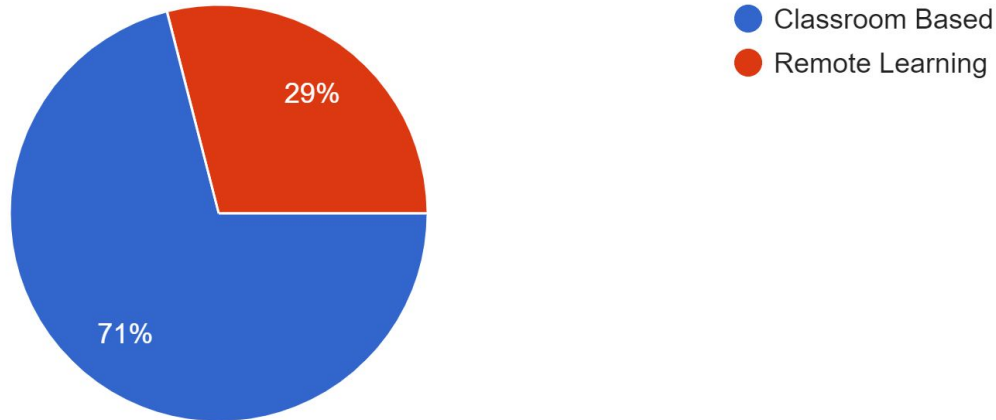
Would your family prefer to continue with remote learning in the fall?

2,635 responses



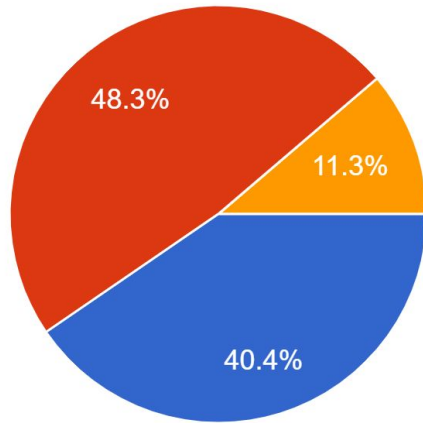
Parent Survey:

2,631 responses

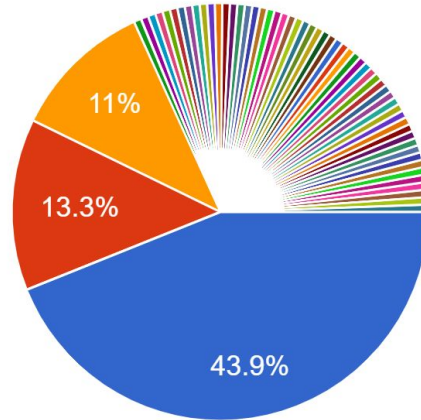


- Obtaining greater social distancing, even if 6 ft. of separation cannot be achieved in the classroom, is more important than attending 5 days per week.

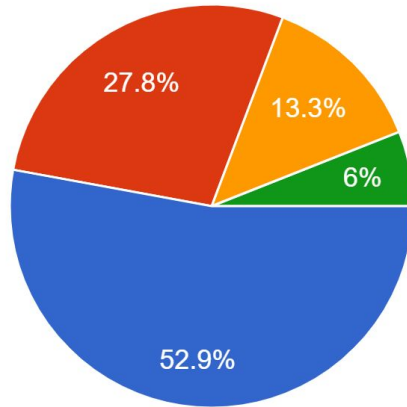

Option 1 - Traditional

- All students return and attend full day, 5 days per week.
- Assemblies, field trips, gathering before school would not occur.
- Conditioned on low rate of COVID19 within Buckeye Boundaries.

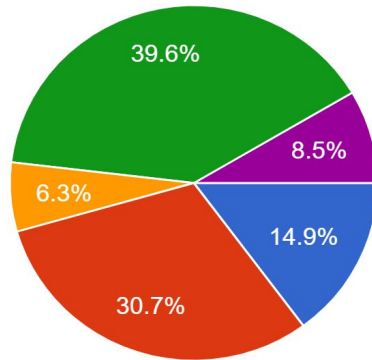
Option 2 - Rotating Cohort

- Population is split in half and students attend every other day.
- Could obtain 6ft of desk separation in many elementary classrooms.
- Many middle school and some upper elementary would only achieve 4-5 ft. of separation.
- Classrooms with collaborative furniture would not achieve separation.
- Distancing cannot be achieved on buses.

Option 2 - Rotating Cohort
