Failure to do so may result in a premature opening of or failure to open such bid. No bids will be received after 9:00 a.m. on May 3, 2021. Faxed or emailed bids are acceptable. Bids will be received on standard bid forms or forms which indicate clearly the total amount of money to be paid to the school district or to be received from the school district for the performance of the work under the terms and conditions as described in this Notice.

Bids submitted prior to the time of bid opening may be withdrawn by written facsimile or telegraphic request. Bids which are withdrawn may be changed and resubmitted, provided they are received prior to the time set for opening of the bids. All bids will be publicly opened at the time set for opening specified in this notice. Each bid shall be subject to acceptance or rejection by the board within 15 working days following the bid opening. The bidder whose bid is accepted will, within the time established in the bid, enter into a written contract with the school district. The Board retains the right to reject any or all bids.

Roofing Contractor to provide and comply with the following items:

Proposal must meet the minimum requirements listed. Any deviations must be clearly noted in order to be considered for evaluation.

*Roofing Contractor will furnish the labor and material to replace the roof in the following manner:*

Tear off existing roof to the existing tapered insulation and haul away debris. Existing taper insulation to remain.

Replace any rotten metal decking if necessary.

Mechanically attach base layer of 1.5' polyisocyanurate insulation.

Install new tapered iso, tapered at 1/4" per ft. set in Carlisle Flex Fast.

Install new Carlisle 1/2" HD cover board set in Carlisle Flex Fast.

Install new 115 mil Carlisle Fleece Back TPO set in Carlisle Flex Fast.

Flash parapet walls with 115 mil Carlisle Fleece Back TPO set in Carlisle Cav-Grip.

Flash new roof curbs with 115 mil Carlisle Fleece Back TPO set in Carlisle Cav-Grip.

Remove and replace existing scupper liners with new Carlisle TPO scuppers.

Install new pitch pans filled with pourable sealer.

Install new 24-gauge pre-finished metal coping cap with cleat.

Install new 24-gauge pre-finished gutter, metal edge, counterflashing and downspouts.

Install TPO walk pad in front of all roof top units.

Manufacturer to provide a **Twenty-year** NDL warranty upon completion.

Owner to furnish project sales tax exemption certificate.
