Draft C complies with the basic districting criteria and incorporates the following direction, public input and Communities of Interest (COI):

- District E follows Board instruction to separate unincorporated Fairview from unincorporated Cherryland. District E is primarily composed of the Fairview, East Ave, and Stonebrae elementary attendance areas.
- District A keeps the Treeview Elementary attendance area with South Hayward. District A is primarily composed of the Treeview, Ruus, Palma Ceia, and Tyrell elementary school attendance areas
- District B combines the elementary school attendance areas for the Lorin Eden, Southgate, Eden Gardens, and Longwood elementary schools
- District C keeps Jackson Triangle together with the Harder/Tennyson neighborhoods.
 - New input requested Cherryland to be grouped with the neighborhood to its south, through Tennyson Rd. The area described is the size of two districts; this district is one of the two.
- District D is composed of Cherryland, Burbank, most of the Park, and part of the Fairview elementary school attendance areas. It separates unincorporated Cherryland from unincorporated Fairview, per Board instruction. Castro Valley is divided along A St.











