3. **Knight Prep** -Re-stripe basketball courts.
4. **QHHS**- No R&R of Concrete driveway. Seal coat, not slurry coat, as indicated in original scope of work. Bid out as crack fill, seal coat and re-stripe of all areas outlined on aerial map.
5. **All Sites**- Miscellaneous asphalt skin patching in areas outlined on the aerial map, as needed.
