Dear Parents/Guardians,

The health and safety of our students and staff will always be the highest priority. The Gainesville R-V District also understands the importance of providing in-person instruction to our students. The lack of internet services within our school boundaries has impacted the planning process. The district is striving to do what is best for kids, and we believe inperson instruction is necessary in our community.

The Gainesville R-V administrative team and Board of Education (BOE) have developed a school re-opening plan. Guidance from the Ozark County Health Department, Missouri Department of Elementary & Secondary Education, Missouri School Boards Association, and the Missouri Department of Health and Senior Services has been considered throughout the planning process. Consensus from a very wide-range of studies suggest students are the least likely population to contract and have complications with the Corona Virus.

The district understands that we must provide a safe learning environment for all students and staff. A three-level plan has been developed to outline our re-opening procedures and precautions. Gainesville schools will begin in **Level 2** of the plan even though the county has experienced very few positive cases. The district would rather have a proactive mindset to our current situation than react to positive cases. The administrative team and BOE will evaluate the situation on a regular basis.

We strongly encourage all parents to help us keep everyone healthy by **not** sending your child if he or she exhibits the following symptoms:

- Fever/Chills/Nausea/Vomiting
- Cough/Shortness of breath/difficulty breathing
- Fatigue/muscle aches not exercise related
- New loss of taste or smell
- Congestion/runny nose

The current Gainesville attendance policy will be adjusted accordingly to support the re-opening plan. Distance learning can be discussed with building administrators by appointment. We understand some students may have underlying health conditions, or they may live with family members who are at high risk.

Once again, the Gainesville R-V District cares about the health and safety of all our students, staff, and community members. We strongly believe in-person schooling is the best option for kids in most cases. We understand that the reopening plan to this unique situation is not perfect, but we will strive to adapt as necessary to help ensure the safety of all our patrons.

## Gainesville R-V School District BACK TO SCHOOL PLAN

Gainesville R-V School District will use Level Indicators to define health and safety restrictions to provide guidelines for students, staff, parents, and community stakeholders.

This plan has been created based on a team decision with input from medical professionals and the Ozark County Health Department and may be adjusted as restrictions change throughout the area and information about the virus continues to be modified.

## **Traditional School**

All classes will take place in school buildings. Staff and students will maintain normal routines and school safety/security procedures. Parents, visitors, and guests follow all normal school security protocols.

All classes will take place in school buildings. Extra cleaning and safety protocols for staff and students will be followed. There are restrictions on visitors and traveling in the buildings.

All classes will take place on campus in their classrooms. Students will eat meals in classrooms with sanitization occurring between all movements and transitions to new areas in the building. Sanitization stations will be placed throughout the buildings and on all school buses. Temperature checks will occur upon entry into the buildings. Water bottles will be strongly encouraged.

Learning may potentially be transitioned to AMI (Alternative Methods of Instruction). Teachers will be available for students both by appointment in person and online to aide in instruction. Zoom, Remind, and Class Dojo may be utilized in the instructional process.

#### Overview

The Gainesville R-V School District has taken steps to prepare for the health, wellness, and safety for all students and staff as we prepare for the 2020-2021 school year. Information listed below outlines general guidelines and expectations for location/service. Decisions will be made in coordination with local health officials. To define health and safety measures, level indicators will be used. Each level will build on the previous level.

#### Seated School Instruction with Health Precautions Cases, No large spike in Visitors will be limited and based on pre-approval from the Administration Level 1: No District community cases Students will eat lunch in the cafeteria with distancing Masks for students, faculty, and staff are optional Buses will be appropriately sanitized after use with sanitation stations on each bus Personal water bottles are encouraged/limited drinking fountain availability Students will use hand sanitizer or hand washing upon arrival into classrooms Common areas will be restricted where feasible Students will participate in daily outdoor recess, weather permitting, with handwashing/sanitizer upon re-entry of buildings Seated Instruction with Additional Safety Procedures Level 2: Upon consideration of community Students report to homeroom upon arrival. Students temperatures are checked daily upon arrival Breakfast and Lunch will take place in the classroom and district COVID cases. Personal water bottles are encouraged/no drinking fountain availability Movement throughout the building may be reduced Masks for students, faculty, and staff are optional Modified bus loading and unloading procedures/buses will be appropriately sanitized after use Students will participate in daily outdoor recess, weather permitting, with handwashing/sanitizer upon re-entry of buildings No use of facilities by outside groups Entry into schools will be restricted to staff and students. Other visitors and volunteers must receive pre-approval from the Administration If a child needs to be picked up for any reason, personnel will accompany the child to the front door and await the arrival of the parent/guardian Possible event guidelines for participation/attendance in school events. Seated Instruction or AMI with Additional Restrictions Level 3: Significant community Possible temporary closure of classroom/building for cleaning Possible Alternative Method of Instruction and district spread Lower capacity of bus transportation Limited attendance and/or guidelines at sporting or other events Possible cancellation of large group activities, field trips, assemblies, athletics Masks possibly recommended for certain grade levels to continue face to face learning Movement throughout the building may be reduced or limited If there is a closure of certain grade levels/buildings, teachers will be available at the school by appointment (via phone, virtual, possible face to face) Lessons may be delivered via packets or flash drives for students without internet. An alternative school calendar may be adopted to provide more time for sanitation of school buildings

If school is moved to AMI, all student work will be graded. Proof of learning will be required for students' grades just like in a face to face setting. Special needs students will have their Alternative Learning Method implemented by the IEP team.
