- SPSA Goal 1.2- ELA
 - CR: \$293 for ELA curriculum and materials
 - Motion to approve: Valerie; seconded: Jon; all approved
 - CR: \$21,000 to fund virtual aide
 - Unique situation in that we have an aide who has been with our program for 2 years, virtually, and has been instrumental in providing support in the area of ELA, so Mr. Angelo would like to hang onto her for help with reading support/writing tutoring.
 - She has been effective in her role as a virtual aide
 - She is evaluated yearly like all other classroom aides
 - Motion to approve: Valerie; seconded: Jon; all approved
 - BP: \$100 Smekens subscription for teacher
 - English teacher would like to continue her subscription to this program which is through a professional development provider
 - Motion to approve: Julie; seconded: Valerie; all approved
 - BP: \$50 HDMI cable
 - We would think the district would provide these, but they haven't
 - Smith needs one for her Smart Board
 - Motion to approve: Julie; seconded: Jon; all approved
- SPSA Goal 1.3- Social Studies and Science
 - CR: \$250 for Science curriculum and materials
 - Motion to approve: Valerie; seconded: Jon; all approved
 - CR: \$250 for Social Studies curriculum and materials
 - Motion to approve: Jon; seconded: Julie; all approved
- SPSA Goal 1.4- English Learners
 - No action needs to be taken
 - District wants councils to know that the LCAP has not yet been approved
 - Process has been delayed because of district turnover
 - LCAP to pay for EL Liaisons for all schools
 - Julie has been in that position for the last 7 years
 - If Title 3 is available to CR, LCAP will pay for a bilingual aide
 - LCAP is usually approved when presented
 - Goes through a similar process as SSC
- SPSA Goal 2.3- Mental Health
 - BP: \$3000 Counselor training: Counselor has requested to go to a training involving young women's support groups; would cover lodging, transportation, registration, and the training
 - Motion to approve: Valerie; seconded: jon; all approved
- SPSA Goal 3.1 Broad Study
 - BP: \$1205 volleyball, flag football, cornole, weight lifting, other equipment
