



Replacement Construction Bond:

Safety. Growth. Preparing all students for their futures.

A school construction bond will be on the Nov. 5, 2024 ballot. This replaces the 2005 construction bond, which will be paid off in 2025. This bond continues the district's commitment to improve the safety and security of our schools, address the impacts of growth in our community, and replace aging school buildings with ones built to today's safety and educational standards—equipped to prepare all students for their futures.

The school construction bond would provide funding for:

- Secure campus fencing, entry and portable security improvements at nine schools;
- · A new elementary school;
- Modernization and expansion of Glenwood and Skyline Elementary schools;
- Lake Stevens Middle School modernization and expansion;
- New spaces for special education services at eight schools;
- New gymnasiums at Glenwood, Hillcrest, Mt. Pilchuck and Skyline Elementary Schools and Lake Stevens Middle School;
- A new Innovative Learning Center to provide secondary students non-traditional learning opportunities to be successful;
- A new district central kitchen to keep up with growth at our elementary schools, and;
- Athletic field improvements at Cavelero Mid High School, Lake Stevens Middle School and North Lake Middle School.

These projects were selected after a comprehensive study conducted by the community Facilities Needs Advisory Committee (FNAC). The FNAC was composed of parents and caregivers, employees, students and community members. They thoroughly reviewed each facility's Building Condition Assessment, which ranks schools' structure, systems and safety components. They also studied enrollment projections and community growth trends.

Bond history and past projects

In the last 20 years, our community has approved two bond measures to fund school construction, facility improvements and modernizations throughout the district. The proposed 2024 projects build on that work to address safety needs and growth in our schools.

The 2005 bond (which expires in 2025) included:

- Building of Cavelero Mid High School;
- Modernization of Hillcrest, Mt. Pilchuck and Sunnycrest Elementary Schools; and
- Facilities improvements at Lake Stevens High School, including the new stadium.

The 2016 bond (which expires in 2037) included:

- Building of Stevens Creek Elementary School and Early Learning Center;
- Modernization and expansion of Lake Stevens High School;
- Track replacements and
- Updates to safety, security and infrastructure systems at all schools.

The 2024 bond (which will replace the 2005 bond) would fund:

- Balancing enrollment at the elementary school level by building a new elementary school, and expanding Glenwood and Skyline Elementary Schools as a part of their modernizations;
- Modernizing Lake Stevens Middle School to protect the community's past investment and extend the school's life while adding capacity for future growth;
- Districtwide safety and security updates, building on the work approved by the 2016 bond.

Taxpayer investment

The proposed \$314 million school construction bond would fund improvements across all schools. For a homeowner with a property assessed at the average value of \$625,000, the cost of the bond would be \$1.76 per \$1,000 of assessed property value. This rate translates to about \$29 per month, or approximately \$350 per year, which is roughly \$1 per day.

Our Board of Directors prioritizes fiscal responsibility and strives to minimize taxpayer costs. With the 2005 bond set to be repaid next year, the proposed 2024 bond is designed to replace its cost, thereby maintaining a stable tax rate. Additionally, the financial impact of this bond is lower compared to the previous two bonds. As our community has expanded, the increased number of property owners, along with the growth in commercial and retail properties over the past eight years, helps distribute the costs more broadly beyond just homeowners.

State construction assistance funds and impact fees from developers

The projects maximize approximately \$60 million in state construction assistance funds to minimize the costs to our taxpayers. These funds are only available to school districts after the successful passage of a school construction bond. In addition, school impact fees paid by developers of new homes will also go towards the projects.

Your top questions answered on the 2024 Replacement Construction Bond

Q: The bond projects will address the elementary and middle school levels, but what about the high school?

A: At the elementary level, there are currently more than 30 portables used as temporary classrooms, serving more than 800 students, with 14 more used for music, PE and other support services. The community Facilities Needs Advisory Committee determined that our most immediate need was to add permanent classroom space at the elementary level by modernizing and expanding Glenwood and Skyline Elementary Schools, building a new elementary school, and modernizing and expanding Lake Stevens Middle School.

Lake Steven High School (LSHS) was modernized and expanded with funding from the 2016 bond. The expansion at LSHS was built to accommodate future growth based on enrollment projections from the Office of the Superintendent of Public Instruction.

The new Secondary Innovative Learning Center, one of the projects included in the 2024 bond, will also draw enrollment from LSHS and our secondary schools by offering non-traditional learning opportunities for students who need additional support.

Q: When will Cavelero Mid High School turn into a second high school?

A: Cavelero was opened in 2007 to address overcrowding at the middle and high school levels. The school currently serves grades 8-9, and will continue to do so for a while based on secondary enrollment projections from the state, county and district.


Cavelero is expandable to become a second high school when enrollment in grades 9-12 reaches a point when it becomes necessary, but we are not at this point yet.

Q: If you're building a new elementary school to address capacity, won't that mean that we will need another middle school and high school?

A: Yes, but not yet. The most immediate need is in our elementary schools where there are more than 800 students learning in temporary classrooms.

As part of the bond, Lake Stevens Middle School will be modernized and expanded to support more students. Future bond projects could include modernizing and expanding North Lake Middle School, once it becomes eligible for state construction assistance funds. This will further support middle school capacity.

School construction bond will fund improvements across all schools



Before Cavelero can become a second high school, we would need to build a third middle school. Eighth-graders would return to middle schools and ninth-graders would move up to the two high schools. If Cavelero were to become a high school right now, there would be approximately 25 unused classrooms between it and LSHS.

While our enrollment is growing districtwide, the most immediate need is in our elementary


Q: Why is the district proposing a new elementary school so close to Stevens Creek? Why not use the land at Lochsloy?

A: The majority of current and expected residential growth in our community is in the northwest portion of the district. The districtowned Lake Drive property, across from Stevens Creek, is located in this growth area and already has the infrastructure in place (road, sewer, utilities) to support another school. When built, start and dismissal times for the two elementaries and the Early Learning Center will be staggered to reduce traffic and neighborhood impacts.

It is not uncommon for districts to build several schools on the same property, as land acquisition for districts can be very expensive and difficult. While we do own the Lochsloy property, it is in unincorporated Snohomish County, outside the Urban Growth Area, where development is not expected to occur and where schools are difficult to permit and build.
