NOTICE IS HEREBY GIVEN that the Board of Trustees of Dallas Independent School District has called a bond election to be held within the Dallas Independent School District on Tuesday, November 3, 2020. Below is a substantial copy of the Order adopted by the Board of Trustees calling the bond election. AN ORDER BY THE BOARD OF TRUSTEES OF DALLAS INDEPENDENT SCHOOL DISTRICT CALLING A BOND ELECTION TO BE HELD WITHIN THE DISTRICT; MAKING PROVISIONS FOR THE CONDUCT AND THE GIVING OF NOTICE OF THE ELECTION; AND CONTAINING OTHER PROVISIONS RELATING THERETO

WHEREAS, the Board of Trustees (the "Board") of Dallas Independent School District (the "District") finds that an election should be held to determine whether the Board shall be authorized to issue bonds of the District in the amounts and for the purposes hereinafter set forth; and

WHEREAS, the Board finds and determines that all facilities to be acquired, constructed, renovated, improved or equipped pursuant to Proposition A herein will be used predominantly for required classroom instruction and essential administrative operations for faculty and staff; and

WHEREAS, the Board, pursuant to the applicable provisions of the Texas Election Code, has or will enter into an agreement to conduct a joint election with other political subdivisions within Dallas County (the "County") and contract with the Dallas County Elections Administrator (the "County Elections Administrator") for election services (collectively, the "Election Agreement"); and

WHEREAS, the Board finds and determines that the meeting at which this Order is considered is open to the public, and that the public notice of the time, place and purpose of the meeting was given, as required by Chapter 551, Texas Government Code, as amended;

NOW, THEREFORE, BE IT ORDERED BY THE BOARD OF TRUSTEES OF DALLAS INDEPENDENT SCHOOL DISTRICT:

Section 1. Findings. The statements contained in the preamble of this Order are true and correct and are hereby adopted as findings of fact and as a part of the operative provisions hereof.

Section 2. Election Ordered; Date; Proposition. A bond election (the "Election") shall be held in the District on Tuesday, November 3, 2020 ("Election Day"), a uniform election date as established by Section 41.001(a) of the Texas Election Code, as amended (the "Code"). At the Election, the following propositions (the "Propositions") shall be submitted to the qualified voters of the District in accordance with law:

Dallas ISD – Proposition A

Shall the Board of Trustees (the "Board") of Dallas Independent School District (the "District") be authorized to issue and sell at any price or prices bonds of the District in the amount of \$3,271,600,000 for the construction, acquisition, and equipment of school buildings, and the purchase of necessary sites therefor, which bonds may be issued in various issues or series, shall mature serially or otherwise not more than 40 years from their date, and shall bear interest at a rate or rates, not to exceed the maximum rate now or hereinafter authorized by law, as determined by the Board within the discretion of the Board at the time of issuance; and shall the Board be authorized to levy and pledge, and cause to be assessed and collected annual ad valorem taxes on all taxable property in the District sufficient, without limit as to rate or amount, to pay the principal of and interest on said bonds and the costs of any credit agreements executed or authorized in anticipation of, in relation to, or in connection with the bonds; said bonds to be issued and said taxes to be levied, pledged, assessed, and collected under the constitution and laws of the State of Texas including the Texas Education Code?

Dallas ISD – Proposition B

Shall the Board of Trustees (the "Board") of Dallas Independent School District (the "District") be authorized to issue and sell at any price or prices the bonds of the District in the amount of \$270,000,000 for the acquisition and updating of District technology equipment, which bonds may be issued in various issues or series, shall mature serially or otherwise not more than 40 years from their date, and shall bear interest at such rate or rates, not to exceed the maximum rate now or hereafter authorized by law, as shall be determined by the Board within the discretion of the Board at the time of issuance; and shall the Board be authorized to levy and pledge, and cause to be assessed and collected, annual ad valorem taxes on all taxable property in the District sufficient, without limit as to rate or amount, to pay the principal of and interest on said bonds and the costs of any credit agreements executed or authorized in anticipation of, in relation to, or in connection with the bonds; said bonds to be issued and said taxes to be levied, pledged, assessed, and collected under the constitution and laws of the State of Texas including the Texas Education Code?

Dallas ISD – Proposition C

Shall the Board of Trustees (the "Board") of Dallas Independent School District (the "District") be authorized to issue and sell at any price or prices the bonds of the District in the amount of \$53,300,000 for the construction, acquisition, and equipment to provide improvements and renovations to existing District stadiums, which bonds may be issued in various issues or series, shall mature serially or otherwise not more than 40 years from their date, and shall bear interest at such rate or rates, not to exceed the maximum rate now or hereafter authorized by law, as shall be determined by the Board within the discretion of the Board at the time of issuance; and shall the Board be authorized to levy and pledge, and cause to be assessed and collected, annual ad valorem taxes on all taxable property in the District sufficient, without limit as to rate or amount, to pay the principal of and interest on said bonds and

the costs of any credit agreements executed or authorized in anticipation of, in relation to, or in connection with the bonds; said bonds to be issued and said taxes to be levied, pledged, assessed, and collected under the constitution and laws of the State of Texas including the Texas Education Code?

Dallas ISD – Proposition D

Shall the Board of Trustees (the “Board”) of Dallas Independent School District (the “District”) be authorized to issue and sell at any price or prices the bonds of the District in the amount of \$66,100,000 for the construction, acquisition and equipment of a performing arts facility and the purchase of a necessary site therefor, which bonds may be issued in various issues or series, shall mature serially or otherwise not more than 40 years from their date, and shall bear interest at such rate or rates, not to exceed the maximum rate now or hereafter authorized by law, as shall be determined by the Board within the discretion of the Board at the time of issuance; and shall the Board be authorized to levy and pledge, and cause to be assessed and collected, annual ad valorem taxes on all taxable property in the District sufficient, without limit as to rate or amount, to pay the principal of and interest on said bonds and the costs of any credit agreements executed or authorized in anticipation of, in relation to, or in connection with the bonds; said bonds to be issued and said taxes to be levied, pledged, assessed, and collected under the constitution and laws of the State of Texas including the Texas Education Code?

Dallas ISD - Proposition E

Shall the Board of Trustees (the “Board”) of the Dallas Independent School District (the “District”) be authorized to issue and sell at any price or prices the bonds of the District in the amount of \$33,500,000 for the construction, acquisition, and equipment to provide improvements and renovations to existing District natatoriums, which bonds may be issued in various issues or series, shall mature serially or otherwise not more than 40 years from their date, and shall bear interest at such rate or rates, not to exceed the maximum rate now or hereafter authorized by law, as shall be determined by the Board within the discretion of the Board at the time of issuance; and shall the Board be authorized to levy and pledge, and cause to be assessed and collected, annual ad valorem taxes on all taxable property in the District sufficient, without limit as to rate or amount, to pay the principal of and interest on said bonds and the costs of any credit agreements executed or authorized in anticipation of, in relation to, or in connection with the bonds; said bonds to be issued and said taxes to be levied, pledged, assessed, and collected under the constitution and laws of the State of Texas including the Texas Education Code?

Section 3. Official Ballot. The official ballots for the Election shall be prepared in accordance with the Code so as to permit the electors to vote “FOR” or “AGAINST” each Proposition which shall be set forth on the ballots substantially in the following form:

Section 4. Bilingual Election Materials. All notices, instructions, and ballots pertaining to the Election shall be furnished to voters in both English and Spanish and persons capable of acting as translators in both English and Spanish shall be made available to assist Spanish language speaking voters in understanding and participating in the election process.

Section 5. Persons Qualified to Vote. All resident, qualified electors of the District shall be eligible to vote at the Election.

Section 6. Election Precincts, Voting Locations and Voting Hours on Election Day. The polling places for the Election are hereby designated to be those locations identified by the Elections Administrator (as defined herein). Such locations are listed on Exhibit A attached hereto, which is incorporated herein by reference and made a part hereof for all purposes; provided, however, such locations may be changed if so directed by the Elections Administrator without further action of the District. The Elections Administrator is hereby authorized and directed to make such changes in polling locations as may be necessary for the proper conduct of the Election, without further action by the District, and the President of the Board or his designee is hereby authorized to update Exhibit A to reflect the locations designated by the Elections Administrator, which locations are hereby approved. Each polling place shall be open from 7:00 A.M. to 7:00 P.M. on Election Day.

Section 7. Early Voting Locations Dates and Times. (a) The County Elections Administrator is appointed as the Early Voting Clerk for purposes of this Election (the “Early Voting Clerk”). The early voting places and the addresses for early voting by mail for the Election are hereby designated as set forth in Exhibit B; provided, however, such locations may be changed if so directed by the Elections Administrator without further action of the District. The Elections Administrator is hereby authorized and directed to make such changes in locations as may be necessary for the proper conduct of the Election. The President of the Board or his designee is hereby authorized to update Exhibit B to reflect the locations designated by the Elections Administrator, and such locations are hereby approved. The Elections Administrator and/or Early Voting Clerk are hereby authorized to appoint the members of the Early Voting Ballot board and the presiding judges and alternate judges for each polling location in accordance with the requirements of the Code. Each of the presiding judges shall be authorized to approve the necessary election clerks to assist in conducting the Elections.

(b) Early voting by personal appearance shall be conducted on the days and during the hours set forth in Exhibit B, as may be adjusted by the Elections Administrator without further Board action.

(c) Applications for early voting by mail shall be submitted to the Elections Administrator at the locations identified in Exhibit B.

(d) Voting times may be changed if so directed by the Elections Administrator without further action of the District. The Elections Administrator is hereby authorized and directed to make such changes in voting hours as may be necessary for the proper conduct of the Election.

Section 8. Appointment of Election Officers. The Election shall be conducted under the jurisdiction of the Dallas County Elections Office (the “Elections Administrator”) pursuant to a Joint Election Contract (the “Contract”) by and among the District, Dallas County and other participating entities, if any, described in the Contract. The Contract providing for the joint election and the conduct of the Election by the Elections Administrator shall be presented to the Board for consideration and approval. The Superintendent or the administrator responsible for the Office of Board Services is authorized to amend or supplement the Contract to the extent required for the Election to be conducted in an efficient and legal manner as determined by the Elections Administrator.

Section 9. Notice of Election. Notice of the Election shall be given by: (i) publishing a substantial copy of this Order, in English and Spanish, one time not earlier than the thirtieth (30th) day nor later than the tenth (10th) day prior to the date set for the Election, in a newspaper published in the District, (ii) posting a copy of this Order, in English and Spanish on the bulletin board used for posting notices of meetings of the Board and in at least three (3) other public places within the boundaries of the District, not later than the twenty-first (21st) day prior to the date set for the Election and (iii) posting a copy of this Order, in English and Spanish, on the District’s website, prominently and together with the notice of the Election and the contents of the Propositions and any sample ballot prepared for the election, not later than the twenty-first (21st) day prior to the date set for the Election through Election Day. Additionally, on Election Day and during early voting by personal appearance, this Order shall be posted in a prominent location at each polling place. Notice of the Election shall also be provided to the county clerk and voter registrar of Dallas County and not later than the 60th day before the Election Day; which notice each County is hereby authorized and directed to post to its website not later than the twenty-first (21st) day prior to the date set for the Election.

Section 10. Conduct of Election. The Election shall be held in accordance with the Code, except as modified by the Texas Education Code, the Texas Government Code, and the Federal Voting Rights Act of 1965, as amended, including particularly Chapter 272 of the Code pertaining to bilingual requirements.

Section 11. District's Outstanding Debt. As of the effective date of this Order, the District's aggregate principal amount of outstanding tax-supported debt was \$3,155,800,000 and the aggregate amount of outstanding interest on such tax-supported debt was \$1,490,255,337.90. The District's total ad valorem tax rate for the current fiscal year was \$1.310385, which is comprised of a maintenance and operations tax rate component of \$1.068350 per \$100 of taxable assessed valuation and a debt service tax rate of \$0.242035 per \$100 of assessed valuation. The District's taxable assessed valuation for calendar year 2019, as of the date that the current tax rate was established, was \$128,350,910.821.

Section 12. Issuance of New Debt. The District intends to issue the bonds authorized by the Propositions over a period of years in a manner and in accordance with a schedule to be determined by the Board based upon a number of factors, including, but not limited to, the then current needs of the District, demographic changes, prevailing market conditions, assessed valuations of property in the District and management of the District's short-term and long-term interest rate exposure. Market conditions, demographics and assessed valuations of property vary based upon a number of factors beyond the District's control, and therefore, the District cannot and does not guarantee a particular interest rate or tax rate associated with the bonds authorized by the Proposition. As such, the information contained in this paragraph is provided solely for illustrative purposes and does not establish any limitations or restrictions or create a contract with the voters. The District estimates that, based on the District's current taxable assessed valuation, current market conditions and estimated future growth in the District's taxable assessed valuation, if all of the bonds authorized by the Propositions were issued in accordance with the District's current project finance plan, the maximum interest rate on the bonds is not expected to exceed 5.00%.

Section 13. Voter Information Document. The President of the Board, the Superintendent of the District, or their designee, acting on behalf of the Board, in consultation with the District's attorney and bond counsel, is hereby authorized and directed to provide a voter information document, in the form prescribed by Section 1251.052(b), Texas Government Code (the "Information Document").

The President of the Board, the Superintendent of the District, or their designee, acting on behalf of the Board, is further authorized and directed to post the Information Document in the same manner as provided for notice of the Election under Section 9 of this Order, and additionally on the District's website in an easily accessible manner beginning not later than the twenty-first (21st) day before the date set for the Election and ending on the day after Election Day.

Section 14. Necessary Actions. The President of the Board, the Superintendent of the District, or their designee, acting on behalf of the Board, in consultation with the District's attorney and bond counsel, is hereby authorized and directed to take any and all actions necessary to comply with the provisions of the Code and the Federal Voting Rights Act in carrying out and conducting the Election, whether or not expressly authorized herein, including making changes or additions to polling places or procedures to the extent required or desirable or as may become necessary due to circumstances arising after the date of this Order.

Section 15. Severability. If any provision, section, subsection, sentence, clause or phrase of this Order, or the application of same to any person or set of circumstances is for any reason held to be unconstitutional, void, invalid, or unenforceable, neither the remaining portions of this Order nor their application to other persons or sets of circumstances shall be affected thereby, it being the intent of the Board in adopting this Order that no portion hereof or provision or regulation contained herein shall become inoperative or fail by reason of any unconstitutionality, voidness, invalidity or unenforceability of any other portion hereof, and all provisions of this Order are declared to be severable for that purpose.

Section 16. Appointment of Election Administrator. The Elections Administrator of Dallas County is hereby appointed Election Administrator for the District and agent for the custodian of voted ballots in the respective jurisdictions.

Section 17. Effective Date. This Order shall take effect immediately upon its approval.

EN VISTA DE QUE la Junta de Síndicos (la "Junta") del Distrito Escolar Independiente de Dallas (el "Distrito") halla que se debería celebrar una elección para determinar si la Junta será autorizada o no a emitir bonos del Distrito por las cantidades y para los propósitos descritos más adelante en la presente; y

EN VISTA DE QUE la Junta halla y determina que todas las instalaciones a ser adquiridas, construidas, renovadas, mejoradas o equipadas en virtud de la Proposición A de este documento serán utilizadas predominantemente para la instrucción requerida en salón de clase y operaciones administrativas indispensables para plantel docente y personal; y

EN VISTA DE QUE la Junta, en conformidad con las disposiciones pertinentes del Código Electoral de Texas, celebró o celebrará un convenio para realizar una elección conjunta con otras subdivisiones políticas dentro del Condado de Dallas (el

“Condado”) y un contrato de servicios electorales (en conjunto, el “Convenio de Elecciones”) con el Administrador de Elecciones del Condado de Dallas (el “Administrador de Elecciones del Condado”); y

EN VISTA DE QUE la Junta halla y determina que la asamblea en la cual se considera esta Orden está abierta al público y que se dio aviso público de la hora, el lugar y el propósito de la asamblea de acuerdo con lo requerido por el Capítulo 551 del Código de Gobierno de Texas y sus enmiendas;

AHORA, POR LO TANTO, LA JUNTA DE SÍNDICOS DEL DISTRITO ESCOLAR INDEPENDIENTE DE DALLAS ORDENA:

Section 1. Hallazgos. Las declaraciones contenidas en el preámbulo de esta Orden son verdaderas y correctas y, por la presente, se adoptan como determinaciones de hechos y como parte de las disposiciones operativas de la presente.

Section 2. Elección ordenada; fecha; proposición. Se realizará una elección de bonos (la “Elección”) en el Distrito el martes 3 de noviembre de 2020 (“Día de Elección”), una fecha de elección uniforme como se establece en la Sección 41.001(a) del Código Electoral de Texas y sus enmiendas (el “Código”). En la Elección se presentarán las siguientes proposiciones (las “Proposiciones”) a los votantes habilitados del Distrito en conformidad con la ley:

Dallas ISD - Proposición A

¿Se deberá autorizar a la Junta de Síndicos (la “Junta”) del Distrito Escolar Independiente de Dallas (el “Distrito”) a emitir y vender a cualquier precio o precios los bonos del Distrito por la cantidad de \$3,271,600,000 con el fin de construir, adquirir y equipar edificios escolares y comprar los predios necesarios para los mismos, y que dichos bonos puedan emitirse en varias emisiones o series, con vencimiento en serie o de otra manera en un plazo que no exceda los 40 años a partir de su fecha, y que devenguen interés a cierta tasa o tasas, sin que excedan la tasa máxima autorizada ahora o en el futuro por ley, según lo determine la Junta a su criterio al momento de la emisión; y se deberá autorizar a la Junta a imponer y comprometer y hacer determinar y recaudar impuestos ad valorem anuales sobre toda propiedad gravable en el Distrito, suficientes, sin límite de tasa o cantidad, para pagar el capital y el interés de dichos bonos y los costos de cualquier acuerdo de crédito ejecutado o autorizado en anticipación, relación o conexión con dichos bonos; y que dichos bonos sean emitidos y dichos impuestos aplicados, comprometidos, determinados y recaudados bajo la Constitución y las leyes del Estado de Texas, incluido el Código de Educación de Texas?

Dallas ISD - Proposición B

Se autoriza e instruye además al Presidente de la Junta, al Superintendente del Distrito o su representante designado, actuando en nombre de la Junta, a colocar el Documento de Información de la misma manera dispuesta para el aviso de Elección bajo la Sección 9 de esta Orden, y adicionalmente en el sitio web del Distrito en una manera con fácil acceso a partir a más tardar del vigésimo primer (21.er) día antes de la fecha programada para la Elección y hasta el día después del Día de Elección.

Section 14. Medidas necesarias. Por la presente se autoriza e instruye al Presidente de la Junta, al Superintendente del Distrito o a su representante designado, actuando en nombre de la Junta, en consulta con el abogado y el asesor de bonos del Distrito, a tomar todas y cada una de las medidas necesarias para cumplir con las disposiciones del Código y de la Ley Federal de Derechos de Votación para realizar y celebrar la Elección, sean expresamente autorizadas en la presente o no, incluso a hacer cambios o adiciones de lugares de votación o procedimientos electorales en la medida que sean requeridos o deseables o como puedan volverse necesarios debido a circunstancias que surjan con posterioridad a la fecha de esta Orden.
