 - i. Overview of MAP/CAI Data
 - 1. Reviewed data from Fall 2021 NWEA MAP test including Projected Proficiency Summary Report and Student Growth Summary Report– A little regression in Math due to unfinished learning from Covid, but Longfellow outperformed the district. Challenge of magnet schools is growth.**
 - 2. Reviewed CAI data for Math, Reading, and Science (Grades 6-8)**
 - 3. Mr. Tatum clarified that 8th graders applying for High School magnets can use the Spring 2021 STAAR OR Fall MAP results for application**

 - i. **Attendance Rate – Longfellow attendance rate is 96.3%, higher than 95% attendance rate goal for campuses.**
