Glossary

Minority-Owned Business

A business 51% owned & operated by a minority.

Woman-Owned Business

A business 51% owned & operated by a woman.

Certified M/WBE Business

A business 51% owned & operated by a minority or woman, who has been vetted by a third-party entity to verify operation, ownership, race and gender of the majority owner of the business.
