a. Superintendents Report Out

Winter ADM

The IDOE winter ADEM count was conducted on February 1st. Our winter count was 801, down 15 students from the fall count of 816. The breakdown of student reduction is as follows:

Elementary school - 9 new enrollees, 13 withdrawals for a total decrease of 4 students

Middle School - 2 new enrollees, 8 withdrawals for a total decrease of 6 students

High School - 8 new enrollees, 13 withdrawals for a total decrease of 5 students.

Within the board packet is a breakdown of where the students went upon withdrawal.

COVID-19 Update

As with the state and nation, the number of positive cases as well as quarantines within Covington Community Schools continues to decreases. It is the hope of administration that we are moving past this wave with this particular variant and are able to enjoy some semblance of normalcy.

Currently, the numbers are as follows:

CES – 0 current student cases with 1 in quarantine and 2 positive staff cases and 2 staff in quarantine.

CMS - 0 current student cases with 2 in quarantine and 0 positive staff cases and quarantine.

CHS - 0 current student cases with 2 in quarantine and 0 positive staff cases and 1 in quarantine.

Transportation Scheduling

In an effort to create more accuracy and efficiency with transportation, beginning with the 2022-2023 school year, Mike Howard will be handlingscheduling of all transportation and buses. This includes all field trips, extra-curricular activities, and sporting trips. I feel that centralizing this procedure will create more continuity along with the aforementioned accuracy and efficiency.
