Communications

Superintendent

Dr. Fitzgerald communicated the following to the Board:

- Dr. Fitzgerald congratulated Sarah Potter then thanked Trish McCarty and Beverly Knight for making CR a special place. He thanked Mrs. Wilson and her FCCLA class for preparing dinner tonight. He also thanked the F. Niel Postlethwait Middle School students and Mrs. Zober for their presentations.
- Dr. Fitzgerald congratulated the High School's Culinary Arts Team for winning the State's Pro Start competition next they travel to Washington, D.C. for the National Competition.
- Dr. Fitzgerald congratulated the cast and crew of the high school's production of "The Sound of Music."
- Dr. Fitzgerald congratulated our Unified Sports Team for a great season and a trip to the Bob Carpenter Center. He wished all of our spring sport teams a great season.
- Dr. Fitzgerald shared that today we showed off our Spanish Immersion Program to the Education Minister from Spain. This Thursday at the high school starting at 6 pm there will be a Spanish Immersion Festival.
- Also on Thursday, VOX will be preforming at Legislative Hall at 12:45 pm.
- Dr. Fitzgerald reminded the Board that the third marking period ends on Thursday, the 21st. Friday will be a half day and Monday the 25th is an In-Service Day. He reminded the Board of some upcoming dates: Wednesday, March 27th the high school will be administering the SAT to all 11th graders. Although, this test is free for our students it has some problems. Since it is mandatory for all students it gives a false representation of how CR ranks with others on this test. Report cards will be issued on April, 3rd.
- Monday, March 25th, Dr. Fitzgerald will be in Wilmington for his quarterly meeting with the Governor and Secretary
 of Education.
- Dr. Fitzgerald reminded the Board that this is the time of the year when we start preparing for the Spring Unit Count. This gives us our estimated unit count for next school year. At this point we have grown 170 students since September 30th. In other words, we are providing educational services for 170 in which we have not received funding. He understands that the House Education Committee is starting to look into that issue.
- Dr. Fitzgerald thanked Representative Williams for her legislation to fund Special Education basic units in the K12 formula and Representative Longhurst who has introduced legislation to add mental health counselors and
 psychologists to elementary schools. Dr. Fitzgerald shared that he has drafted a letter to our Kent County
 Legislators asking them once again for assistance with our elementary school project. Dr. Fitzgerald gave an
 updated status on receiving money for the New Elementary School. We are still hoping to receive funding. He
 plans to mail the letter tomorrow to our legislators.

President Marelli, stated she was seeing the spring sports teams practicing on their alternative fields. She thanked the parents and coaches for their patience during construction. Dr. Fitzgerald added they have held their first meeting regarding graduation and getting spectators in and out of the stadium.

Action Items

A. New Elementary School Bid

Mr. Marasco made a motion to approve the New Elementary School base bid as presented. Mr. Failing seconded the motion and the motion carried unanimously 4-0 (Marelli, Marasco, Failing and Wilson).

President Marelli stated this was a difficult decision for the Board. Four years ago they committed to build a school and they need to build it even though it is not what they anticipated it to be. There are alternates in place.

B. Board of Education Vacant Seat

Mr. Wilson made a motion to remove the motion from the table. Mr. Failing seconded the motion and the motion carried unanimously 4-0 (Marelli, Marasco, Failing and Wilson).

There were no nominations for the vacant position. Therefore, the motion dies.

Discussion Items

Directors' Reports

Directors' reports, which include their Supervisors' reports, were included for the Board's review.

Mr. Failing asked about the IPADs on the buses. Mr. Scott Kessel stated the IPAD will give a count of students, track maintenance, etc. He mentioned that Mr. Jason Bonner, Supervisor of Transportation, was vital in the implementation of this technology.

President Marelli asked about Illustrative Math Pilot. Mrs. Tara Faircloth explained Illustrative Math is only at the middle schools but could expand. There will be more feedback available at the end of the year.

State of DE Parental Leave Policy

The State of DE Parental Leave Policy was included for the Board's review. Dr. Michael Noel, Assistant Superintendent/Director of Human Resources, explained the state policy and stated we have a few staff members who will be utilizing this leave. There is state funding for substitutes but only at the state rate. Dr. Noel estimated the cost for the District. Dr. Fitzgerald explained this is a regulation/procedure and not Board Policy which requires three readings. Dr. Noel explained this is 12 paid work weeks and would pause over the summer for 10 month employees. This also applies for spouses. 12 Month employees would start at birth/adoption and runs the full 12 consecutive weeks. They do not need to be concurrent with a spouse. Dr. Noel stated there is no accrued sick time needed. This protects their sick leave to use at a later time. Dr. Fitzgerald reminded the Board of the shortage of qualified substitute teachers.

Middle School Looping Update

Mrs. Tara Faircloth, Director of Curriculum and Instruction, provided the changes being made at the middle school due to scheduling. She explained the reasoning behind not looping at the middle school level for 7th to 8th grades next year. Dr.

Kristina Failing and Ms. Kim Corbeil, Middle School Principals, shared that the teachers will be working more with their departments cross-teaming. Teacher collaborations are currently being utilized. Growth and scheduling was discussed. Grants are coming in for training teachers with Special Education and English Language Learners. New scheduling in ESchool will take place. Dr. Fitzgerald mentioned overcrowding issues. He asked about the possibility of shrinking class sizes and wants consideration on adding an extra class period as a possible pilot.

Executive Session

At 9:06 pm. Mr. Marasco made a motion to go into Executive Session. The purpose of which was to discuss Personnel Matters. Mr. Failing seconded the motion and the motion carried unanimously 4-0 (Marelli, Marasco, Failing and Wilson).

At 10:00 pm. Mr. Marasco made a motion to come out of Executive Session. Mr. Failing seconded the motion and the motion carried unanimously 4-0 (Marelli, Marasco, Failing and Wilson).
