Call to Order

At 6:00 p.m. School Board President Jessica Marelli called the October 24, 2017 Caesar Rodney School District regular meeting to order.

Roll Call

Adoption of Agenda

Mr. Bush made a motion to adopt the October 24, 2017 agenda as presented. Mr. Failing seconded the motion and the motion carried unanimously 5-0 (Marelli, Failing, Bush, Wilson and Marasco).

Approval of Minutes - September 19, 2017 Regular Meeting Minutes

Mr. Bush made a motion to approve the September 19, 2017 Regular Meeting Minutes as presented. Mr. Marasco seconded the motion and the motion carried unanimously 5-0 (Marelli, Failing, Bush, Wilson and Marasco).

Executive Session

At 6:02 p.m. Mr. Bush made a motion to go into Executive Session. The purpose of which is to address strategy and receive legal advice on a litigation matter which just arose and cannot be deferred. Mr. Marasco seconded the motion and the motion carried unanimously 5-0 (Marelli, Failing, Bush, Wilson and Marasco).

At 6:23 p.m. Mr. Wilson made a motion to come out of Executive Session. Mr. Bush seconded the motion and the motion carried unanimously 5-0 (Marelli, Failing, Bush, Wilson and Marasco).

Public Comments

President Marelli reiterated that the Board will not comment on personnel or student issues. She stated the intention of public comments is to listen to public comments and not to respond.

Diane Eastburn addressed the Board regarding the start time of this meeting and the removal of the sign-in sheet for public comments. She referenced a student fight which took place at the Caesar Rodney High School. She gave details about the incident and spoke about the students involved. She blamed the board and superintendent for the discipline action taken against the students involved. Mr. Wilson addressed Ms. Eastburn and reiterated that the discipline action taken was not the Board's decision. This was the decision of the police. The discussion continued until President Marelli stopped the discussion at 6:35 pm.

Cassandra Reeves from the Dover Alumni Chapter of Delta Sigma Theta gave an overview of her organization. She spoke about the history and their mission statement. She stated they have six chapters in Delaware. Their focus is on urban community relations. She mentioned the mascot incident and offered to be a part of the solution to ascertain that all students feel safe in their schools. She offered support to the district and offered a future collaboration, if needed.

Pat Savini, parent of a McIlvaine Early Childhood Center student, thanked the Board on the recent communications. He was appreciative of the notifications and letters from the superintendent and the Board of Education. He thanked the staff at McIlvaine for their parent communication. He spoke about how proud his daughter was to be selected as the class

representative in the parade. He stated his appreciation for all Board members who serve as they do not receive compensation.

President Marelli stated the communication Mr. Savini referenced was not a Global Connect call this evening regarding the start time of this meeting. It is her understanding that there was no call made today.

Communications

Superintendent

Dr. Fitzgerald communicated the following to the Board:

- Dr. Fitzgerald expressed that our thoughts and prayers go out to the families of Cindy Angermeier, retired school
 psychologist, who also served as president of DSEA. Cindy was a positive influence for students and staff. Also
 to the family of Charlie Bell, retired science teacher and Cross-Country and track coach, he spent his career at
 Dover Air Base Middle School and coached at Caesar Rodney High School. His impact is still being felt at both
 schools.
 - Our thoughts are also with the family of our Star Hill Foster grandparent, Janet Hurtt, (known as Ms. Janet), to students and staff. She helped work with our students for the last 12 years. Her daughter-in-law, Doris Ridenour, is a teacher at Brown Elementary. We will miss all three.
- Dr. Fitzgerald thanked the community for their understanding this morning. There were power outages throughout the area. This impacted our bus contractors, stoplights and at least three schools.
- Dr. Fitzgerald acknowledged our Spirit of Caesar Rodney award winner and congratulated all those recognized
 this evening for the job they do for the students of the Caesar Rodney School District.
 He also congratulated Kyle Hill for representing the District at the TOY dinner. Mr. Hill did a great job and
 continues to do a great job each and every day working with the children of Star Hill Elementary School.
- Dr. Fitzgerald thanked our community for their understanding of some recent events. Those events portrayed the
 high school and the district in a negative manner. He appreciated that our community knows that. That is not who
 we are and we ask for their continued understanding. While we are prevented from discussing individual students
 due to FERPA (The Family Educational Rights and Privacy Act) which protects student's educational records

such as report cards, transcripts, disciplinary records, contact information and class schedules – we know that not getting an answer to a question can be frustrating. He stated we are frustrated when we are prevented by law from responding, but we will continue to do our job and will provide the type of education that our community has come to expect.

- Dr. Fitzgerald thanked Rep. Yearick for his support of the district.
- Dr. Fitzgerald met with Senator Bonini and discussed some traffic concerns in Magnolia. There will be a future meeting with DelDot to see what can be done.
- Dr. Fitzgerald is meeting with DelDot tomorrow to discuss some issues as we move forward with the high school renovation and addition.
- Dr. Fitzgerald gave the statistics of student enrollment for each school and shared the school choice 85% rule for capacity. All of Caesar Rodney Schools are currently either at capacity with a wait list expected or near capacity with a wait list likely.
- Tomorrow night at 6:30 pm at the high school the Statewide School Consolidation Taskforce is meeting. Dr. Fitzgerald invited anyone who wishes to attend to join this meeting.
- Dr. Fitzgerald commended Dr. Darren Guido, Supervisor of Instruction, who had a nice article on the immersion programs in the *Delaware Today* magazine. These programs are not without issue, but the benefits to these students are immeasurable.
- Dr. Fitzgerald congratulated Jen Montano, District Registered Dietician, as she takes on the position of Food Service Supervisor for the Lake Forest School District.
- Now that September 30th has come and gone, Dr. Fitzgerald stated Fifer Middle School has qualified for an
 additional assistant principal. With the Board's permission and given that there are over 900 students at this
 school; Dr. Fitzgerald asked to move forward to advertise for an AP.
- Dr. Fitzgerald shared some important dates: Homecoming parade starts at 5:30 pm on Friday near the railroad tracks in Wyoming. The football game against Brandywine will follow at 7 pm. The 10th Annual Rider Pride Day is this Saturday, Oct. 28th from 9-2 at the high school! The first marking period officially ends on Thursday, November 2nd.

President Marelli thanked the principals and assistant principals for the job they do each day and night for our children in the Caesar Rodney School District.
