Opening

Call to Order

At 7:03 p.m. School Board President Jessica Marelli called the January 23, 2018 Caesar Rodney School District regular meeting to order.

Roll Call

Members present in addition to Mrs. Marelli were Mr. William G. Bush IV, Mr. Dave Failing, Mr. Michael Marasco, Base Liaison Lt. Col. Marshall Preston and Executive Secretary Dr. Kevin R. Fitzgerald. Mr. P. Scott Wilson was present after the roll call was given.

Adoption of Agenda

Mr. Bush made a motion to adopt the January 23, 2018 agenda and addendum as presented. Mr. Marasco seconded the motion and the motion carried unanimously 5-0 (Marelli, Failing, Bush, Wilson and Marasco).

Superintendent

Dr. Fitzgerald communicated the following to the Board:

- 1. Dr. Fitzgerald congratulated all of the reward recipients and the AP scholars who were recognized.
- 2. Dr. Fitzgerald stated our thoughts and prayers go out to the families of Linda Gehling and Joanna Simms. Both are former teachers at CRHS who recently passed away.
- 3. Dr. Fitzgerald congratulated Allen Frear Elementary School for being a distinguished Title I School and W. Reily Brown Elementary School for being a Delaware Recognition School for a second year.
- 4. Dr. Fitzgerald congratulated the VOX 1 students for their rendition of John Lennon's "Imagine" at the Martin Luther King Breakfast last Monday. They received a standing ovation.
- 5. Dr. Fitzgerald invited the Board to attend the T3 in-service which is scheduled for Friday, 1/26.
- 6. Dr. Fitzgerald shared some concerns over legislation:
 - School safety/new construction- renovation

- 9. Dr. Fitzgerald gave an update on the Consolidation Task Force. They met last night and there is nothing new to report at this time.
- 10. Dr. Fitzgerald shared the Department of Education is reviewing regulation 225. The Chief School Organization supports legislative action to address certain issues in the regulation.
- 11. Dr. Fitzgerald stated he knows all of our Eagles fans are excited about Super Bowl 52. He wished Duron Harmon one of the New England Patriots Co-Captains the best of luck as he goes for his third Super Bowl ring!
- 12. Dr. Fitzgerald wished Mr. Bush a happy early birthday!
