## Opening

#### Call to Order

At 6:04 p.m. President Jessica Marelli called the June 20, 2017 Caesar Rodney School District regular meeting to order.

## Superintendent

- Dr. Fitzgerald expressed our thoughts and prayers go out to Trish Alexander, Jen Martin and their families on their recent loss.
- Dr. Fitzgerald thanked our faculty, staff, administrators, students, parents and community members on another successful year. While the year was not without challenges, it was a year of continued success. With many schools, students and faculty members winning accolades.
- Dr. Fitzgerald stated we had 427 students graduate from the high school, 520 students completed McIlvaine Early Childhood Center and 83 students graduate at Welch. Seven students completed Project Search with five currently employed. John S. Charlton School graduated another seven students. We are proud of them all!
- Dr. Fitzgerald thanked Dr. Alois as she moves into her position as Deputy Secretary of Education for Delaware. She leaves us having made Caesar Rodney a special place for our children. The state's gain is our loss.
- Dr. Fitzgerald shared information regarding our new elementary school project. He stated we have become
  increasingly concerned over the projected estimates and a projected shortfall. In conversation with DOE and
  OMB, they were unable to help. However we reached out to Senators Bushweller, Bonini and representatives
  Yearick and Paradee who have been very supportive and have agreed to introduce language that will address the
  shortfall.
- Dr. Fitzgerald shared an update on the construction process which has begun at the high school. The field and
  track have been dismantled as have the trailers and soon the weight room/outside locker room will be dismantled.
  Rather than waste money on additional trailers that will eat into the budget, we are going to construct a pole
  building to meet our teams and students needs during the construction and renovation process. We can then
  dismantle the building and use it where ever there is a need. Also, for regular updates please check out Dr.
  Kijowski updates on Twitter.
- Dr. Fitzgerald shared that last Thursday Dr. Dave Robinson was recognized with the DIAA Lifetime Achievement Award for his work as an athlete, coach, administrator, committee member and Board member.
- Also last Thursday Dr. Fitzgerald moderated a panel for the Delaware Decision Makers pertaining to economic growth in Kent County.
- Dr. Fitzgerald shared that tomorrow evening the Chamber of Commerce will recognize the Caesar Rodney School
  District as one of the nominees for Large Employer of the Year. While we do have that distinction and being the
  largest school District in Kent County, he believes that it also speaks to the relationship that we have with our
  employees. He thanked the CREA leadership, Mr. Joe Hartman and his team for being a part of that positive
  relationship.

Dr. Fitzgerald reminded the Board that from June 27th -July 3rd he will be in Chicago speaking at the NFHS
Summer Conference. He also reminded the Board that our reorganization meeting will be on July 10th at 6pm in
the District Office Board Room.
