Recognitions

Daniel J. Farley, Director of Support Services, was recognized for his State of Delaware service of 25 years, 9 months and 25 days. His Caesar Rodney time of service was 1994-1997 and again from 2013-2017. Mr. Farley has worked for Capital and Red Clay School Districts along with the Department of Technology and Information. Under his leadership Caesar Rodney School District became a leader in technology in the State of Delaware. Mr. Farley was presented an engraved porcelain plaque shadow box along with a proclamation.

Communications

Superintendent

1. Dr. Fitzgerald congratulated Dan Farley and reminded the Board that his retirement celebration will be at Cool Springs restaurant on April 24th at 6pm.

- 2. Dr. Fitzgerald congratulated the Odyssey of the Mind teams from W.B. Simpson and the C.R. High School for qualifying for nationals which will be held in East Lansing, Michigan.
- 3. Congratulations went to the JR ROTC for once again winning the State Overall Drill Championship.
- 4. Dr. Fitzgerald recognized April as the Month of the Military Child. There are over 1,500 students currently attending Caesar Rodney Schools that are in some way connected to the military. Last week, students from Dover Air Base Middle, C.R. High School and Welch Elementary School were on hand as the governor signed the official proclamation. Later that day, students from Dover Air Base Middle School performed for the State Legislature and the Military Child of the Year. C.R. High School student, Myra Reid, addressed the House of Representatives.
- 5. Dr. Fitzgerald commended the work of our John S. Charlton School who along with Junior Achievement staged a competition at Delaware State University.
- 6. This is the time of the year the Board usually has to deal with adjusting the school year calendar due to snow days. This past winter we had only one day and that was built into the student's calendar. Since the maintenance and custodial staff worked hard on clearing the parking lots the day before, we were able to bring staff in. So there are no make-up days needed this year.
- 7. Dr. Fitzgerald informed the Board that based on the spring unit count projections the district is projected to grow by eight units next year. This means that at September 30th of this year, we earned 558 units. Next year we are projected by the state to earn 567 units with the state guaranteeing us 98% or 555.66 units.
- 8. The Equalization Committee has decided to recommend leaving the formula as is. This is a positive thing for the district.
- 9. Dr. Fitzgerald commended the schools for their submission of nine innovative grants that has the potential to bring in \$360,000.
- 10. Dr. Fitzgerald also informed the Board that he attended numerous meetings with the Department of Education, Office of Management and Budget and has met with state legislators over the last two weeks. Mr. Scott Kessel and Dr. Fitzgerald spoke to the Governor's Budget reset during the discussion period. Dr. Fitzgerald believes that it is prudent to ask the Board to move the May Board meeting to the week of May 8th with the board meeting being held on Wednesday, May 10th.
- 11. Dr. Fitzgerald reminded everyone that the school board elections for Mrs. Precourts' seat will be held on May 9th.
- 12. Dr. Fitzgerald announced that next week will be spring break. He informed the board that he will be at the NFHS Legal Summit and Board of Director's meeting from Tuesday through Friday.
- 13. In closing, Dr. Fitzgerald shared information from Dr. Sherry Kijowski, C.R. High School Principal, that currently students from the high school have been accepted to the following schools and universities: Penn, MIT, Harvard, Brown, Princeton, Bucknell, Carnegie Mellon, Lehigh, Michigan, UC Berkley, Delaware, Georgia, Auburn, Alabama, James Madison, William and Mary, Johns Hopkins, Northeastern, Boston, Penn State, Temple, NYU, Ohio State, Duke, Richmond, UVA, Emerson Pace, Hofstra, Purdue and Pittsburgh. Added were WVU and Mississippi.
- 14. Dr. Fitzgerald wished everyone a great spring break.
