## Caesar Rodney School District Monthly Financial Report Supplement – October 2020 COVID-19 Budget Implications

- Expenditures directly related to COVID-19 since March 2020:
  - **Safety Protocols** – Return to school and work guidance requires new and ongoing initiatives to enhance safety protocols such as purchasing additional disinfectant supplies and personal protective equipment. Costs incurred to date are approximately \$211,600.
  - **Remote Learning and Telecommuting** – Additional costs generated to ensure equipment and internet access is available for all students:
