- Expenditures directly related to COVID-19 since March 2020:
  - o **Safety Protocols** Return to school and work guidance requires new and ongoing initiatives to enhance safety protocols such as purchasing additional disinfectant supplies and personal protective equipment. Costs incurred to date are approximately \$240,300.
