Committee Reports -

Athletic –Mary Jane Keller/Jim Brown/Ivan Hampton – Mr. Hampton reported. Coach Hampton is going to make a little announcement. They have announced one time and the dates for the playoff games for both the girls and boys basketball teams. The boys will play at North Allegheny High School. They will play Hampton High School at 8:30 PM Friday night. The girls will play on Saturday afternoon, also playing Hampton High School, but that time has yet to be announced. At our regular Athletic Committee on February 6, 2017 we had a

presentation by Coach Gerald Grayson concerning two individuals who have contributed a lot to McKeesport's basketball team. The first was Billy Leonard who was the school's all-time leading scorer with over 700 points and ended up going to Towson State School and was a fine player that the players were watching in the early 80's and Coach Dan Pacella who won several conference championships for this district and also had a pleasing win/loss record. Mr. Grayson also mentioned the problem he is having with his weight program and the necessity of his players crossing campus in the wintertime to be able to lift weights. He asked for us to consider some change in that practices. (Dr. Holtzman responded from the audience, but is unable to be heard.)

Buildings & Grounds – Steve Kondrosky – Thank you Mr. President. We did meet this morning, Dr. Coughenour, Ed Fagan and myself and it took approximately two hours to discuss seven items and Dr. Skezas was wondering about the whereabouts of Dr. Coughenour. I understand why. We had some things that were very important and taken care of here. at McClure they had to replace a 185-gallon domestic hot water expansion tank, I guess this is mandatory when your hot water is not working. Completed a three-year testing for the elevators and wheelchair lift at South Hall. These tests are mandated by the Uniform Construction Code through the Department of Labor and Industry. Also completed the annual telescopic bleacher inspection at Twin Rivers and McClure which is required by International Building Code. This is the first time I heard about that. I guess the other schools that have the same type of bleachers will be done in the future. Replaced 12" VCT floor tile in room 225 at South Hall. Repaired the feed system for the boilers at Founders Hall which is very important and this is brand new, Ed began to use an electrostatic sprayer in certain areas of all the schools, especially the gyms and wrestling rooms. This machine sprays hospital grade disinfectant and kills a wide range of viruses and bacteria to prevent spores with up to seven-months residual effects. The Athletic Director and coaches were in-serviced with this product used and frequency and pleased with the procedure and how it is working out for any type of activity that we don't like to talk about when you sweat on the mats and you go other things like that. One more thing that they did, they had to replace a field float capacitor at boiler #1 at White Oak. It costs about \$600 to do it in house and would have been a \$1,200 job if they had people from the outside and I'm a little unhappy about still putting money in White Oak, I wish somebody would buy that. That about concludes my report. Mr. Seropian - The concrete company will be back out here starting on Monday to finish some of the concrete work around Founders Hall along Eden Park Boulevard. They ran out of weather, I guess you saw they did a lot of work, but they are coming back to finish that, so if you see them out there next week, you'll know why. Mr. Kondrosky – Mr. Fagan also brought up Dave, that there are a couple of cracked areas in front of the Administration Building that he is going to come to you about and see if they give us a price on that so we can fix that. Mr. Seropian – He called me late this morning about that so we're going to have them take a look at that and give

us a price. Mr. Kondrosky – Very good, thank you.

Career & Technology – Pat Maksin – We met on February 16th. There are a few items that we want to bring to the attention of the Board and the public. One is the covered patio/deck, the culinary deck that will be outside of the Tiger Inn. I do believe that has been started. It will be approximately 40'x20' and hopefully will be finished by graduation at the latest. They are hoping that if the weather is nice that it will be finished in May and hopefully will be a nice addition to the Tiger Inn. The library is moving forward with hardwood flooring to be extended and shelving to be extended and much of that will be accomplished during the 2017/2018 school year. And just as a reminder that is being paid for by the McKeesport Alumni & Friends. The collision repair, that new piece of equipment is being is a laser measuring system being used. They are also involved in a world of wheels competition and that project has been completed I do believe and should be on display if not now, but soon in the high school lobby. There was a redo on the Bobcat that we bought last year that I call Brie's Bobcat and it is now in pristine condition. That is good news. We had Skills USA regional competition and we had ten winners, first, second and third place winners and they will move on to the next level of competition and February is CTE month and on February 13th cookies were distributed to all CTE staff and students. Thank you, that's the end of my report.

Community Relations/Cultural Diversity – Jim Brown/Ivan Hampton – Mr. Brown reported. We did meet today to discuss some of the activity that we addressed at our African Coalition meeting today and that was pretty much the achievement gaps trying to narrow that down to a better position than where it's at right now.

Education/Legislation/Policy – Mary Jane Keller/Mindy Sturgess – Mrs. Keller reported. We did not have an Education meeting or Legislation/Policy committee meeting this month.

Finance/Grants/Outside Funding – Scott Smith – We met of February 15th. Naturally, the school district is working on the 2017/2018 school year budget. As we spoke earlier, there was an audit presentation last week, just two small points out of that audit. One was that everything was all accounting practices were found in good standing and two that our fund balance is up to \$4.1 million. We also discussed the State budget proposal, currently the presentation for the budget that the Governor has put together would put approximately \$380,000 of additional funds into the school district. That is my report.

Personnel – Mindy Sturgess/Steve Kondrosky – Mrs. Sturgess reported. The Personnel committee met on February 8th to discuss the personnel items reflected on this evening's green sheets. That concludes my report.

Safe Schools – Chris Halaszynski – Yes, we did have a meeting today, but I will refer to Dr. Skezas for the information. Dr. Skezas – I would like to share a couple of things that were discussed today and that was Twin Rivers and Francis McClure, both have been doing random searches and scans with buses and with car riders a couple of times a month. Mr. Wayne Wade said they were able to afford and perhaps can purchase a couple more wands. The problem is that they did not have enough staff to support that. So, we actually volunteered, Dr. Bauman, myself and anyone here from Central Administration that when they need extra people up there to scan or to search, we would be happy to go up there to help them. They feel that it's working out fine. At Founders Hall, the High School didn't have any concerns, but at Founders Hall we are going to revisit our guard schedule and police officer schedule to make sure they are where they need to be throughout the day. I know that there is a concern with the sixth-grade wing and perhaps adding an additional guard. We are taking a look at that, we actually are trying to see if we can tap into some of the Pre-K funding that we get a large amount of money with our Pre-K grant and perhaps to partially pay for a guard out of that for the 2017/2018 school year, especially having the little ones and the sixth-graders in the same wing. We will be revisiting the guard schedule and the police officer schedules so that the entire building is covered throughout the day. Thank you.
