Committee Reports -

Athletic –Mary Jane Keller/Jim Brown – Mr. Brown reported. Athletic Committee met Monday, April 11th. We discussed as far as fall sports coaching. We had our first intent signing not just for the football players, but all athletes, I thought that was great. I think we need to keep doing that for the athletes that don't get recognized as much as they should. Our second scrimmage for this upcoming football season will be against Obama Academy and that will be our second scrimmage for this upcoming season. The spring sports update, we have the softball who is holding a conference play 1 in 3 and their overall is 2 and 4. Our baseball team our conference play was 1 and 0 and overall was 3 and 2. We were on a 3 game winning streak going into that, I don't know what we did as far since then. Our track and field is upcoming meet they hosted Penn Hills and that was the 13th of April and they said our 8th grade volleyball team is super super strong. That is my report.

Buildings & Grounds – Steve Kondrosky – We met this morning, Mr. Fagan and Dr. Coughnour. He gave me a list of things he had accomplished since last month and I guess one of the most important things was that all of the boilers in each building were inspected for their annual inspection with new certificates until June 2017. I think that lacked the previous couple years. Someone brought it to his attention and he hit on it and did a nice job. They repaired the diving blocks for the pool, they repaired the boiler and booster pumps at McClure and installed new seal gaskets and fittings, new lights were put in the new main gym at South Hall. replaced a 1.5 horsepower motor on a rooftop handler for South Hall gym. The uninvent filters were changed at McClure and Founders and one uninvent and two outside ground units at South Hall library were removed and it was necessary because of the overhead garage door leading out into the courtyard that is going to be installed through the McKeesport Area School Alumni Association. They are doing a nice job out there. It's being done in house and I think a lot of the money is donated. We continue to work real close with the desk tickets. I guess is pretty much every complaint from any teacher, administrator in the school goes through Ed and he addresses them. The buildings and grounds continue to do the outside maintenance and in a few weeks will be checking all of the equipment that is used for the prom which is May 26th. That concludes my report. Discussion regarding the gas line at Founders Hall.

Career & Technology – Pat Maksin – We did meet on April 21st. As was mentioned by Dr. Skezas, we did go over the 339 review, the corrective action report and we talked about the National Technical Honor Society, the ceremony and reception that will be held at the high school, Tiger Inn on Tuesday, May 10th. We talked about the current enrollment. Our current MATC enrollment is 263 students. We talked a little bit about how to make the Tiger Inn a little bit more cost effective. We are a little bit in the red right now and we talked a few ways about how we can make that a little bit more break even. Lois Richards will be here on May 10th to do best practices with our MATC teachers and program approval is due by May 27,

2016. Thank you, that is my report.

Community Relations/Cultural Diversity –Trisha Gadson – I am going to start it and I'm going to ask Dr. Bauman to finish it for me. We had our monthly committee meeting today, but due to a work meeting, I was not able to get back to McKeesport in time. However, we have been working on some activities under the cover of the Diversity Committee that I can report on. I just want to reiterate to the Board Members that you are all invited to the two day Beyond Diversity training that is scheduled for June 28th and 29th with the Administrative team as well as members of the McKeesport Educational Coalition. The facilitator will be Dr. Virginia Hill, actually we were able to get the recommendation from Mrs. Sturgess. I was able to meet with Dr. Hill and actually she comes very highly recommended by Mrs. Sturgess as well as some of the educational facilitators with the University of Pittsburgh. In addition, the Diversity Committee has been looking at working on educational partnership with community members in the district to complete a teacher protection survey to understand the need of the teachers with regard to educating in an urban community and making sure resources are available to educate around cultural constructs. There has been a committee of community members partnering with members of the Administration team to create a survey that will be rolled out to the staff of the district, I believe, sometime this month. (Tomorrow) In addition to that, Dr. Bauman had presented a presentation on PVAAS testing from last month and it was a really good presentation and some community members took off from work to come in and hear the presentation that was presented again today, so I yield to you Dr. Bauman to cover that and anything else you feel I did not cover. Dr. Bauman – I will be real brief. I did present to the committee today the use of the PVAAS tool, Pennsylvania Value Added Assessment System. It's the idea of how teachers grade their students' achievement is tied directly to them and in these meetings over the last year or so we've had a couple of times where we have recognized teachers who have had a whole lot or a high percentage of their students achieve at high rates. We are now turning to use that data within this committee to maybe analyze some things that we can do to strengthen our teaching staff specific to how they instruct both the high level kids and the low level kids as well as the overall grouping of kids as well as sub-groups of kids including black and multi-raced identifying kids. It's early discussions, but we think there may be some value in exploring this tool so that we can strengthen our teaching staff to interact very well with our students. Last thing, we showed a video that we produced in house called "Did You Know". Dr. Skezas – Trish, we're going to show the video, but I will also send it in the update so you as Board Members can have it at your disposal if you want to share it as well. Dr. Bauman – with that video, so thank you Brie, Jane and Kristen for the hard work, thanks Ricky for always being always on the ball appreciate that and Mrs. Gadson, that concludes our report.

Education/Legislation/Policy - Mary Jane Keller/Mindy Sturgess - Mrs. Keller reported. The

Legislation and Policy Committee met on Wednesday, April 20th, all School Board Policies are now computerized and can be accessed through our MASD website. Our Board of Directors certainly and staff and residents give a very special thanks to Ms. Decker, Dr. Jane Coughenour and Ms. Kristen Davis for their dedication to this task. The Education Committee met also on Wednesday, April 20th. First a presentation to the committee was made by representatives from kindergarten through fifth teachers on the new report cards. The program will be given to all K-5 teachers. The Board must then approve each of those report cards for use next year. Second, discussions with administrators and staff are ongoing concerning the start times for the primary and the intermediate buildings. Dr. Holtzman has recommended a transition in-service day for 5th graders that would be moving to 6th and to continue step up day for the 8th graders transitioning to 9th grade. For the chapter 339 review suggested that a guidance plan would be put in place for the vocational department. We were reminded of a very special event coming up which is called Electricity, Robots and Lunch on Thursday, May 12th, from 11:30 AM to 1:00 PM and that's my report.

Mrs. Sturgess – I wanted to put a thank you out there I know that Pam Gordon has been working across both elementary buildings and was instrumental in taking a look at our grading system and trying to establish some consistency across classrooms across the district so that one teacher is not weighting homework assignments as 50% of the grade and another teacher is weighting it as 20% of the grade. It was really nice to see teachers from both schools and work together and work as grade level teams to make that happen. I am happy of a previous parent of a primary and intermediate age student and still currently with my stepson I think it is great that the district is looking at those proposed time changes based on the recommendations and concerns that parents have expressed over the years through the survey system. I am happy to see that is occurring.

Finance/Grants/Outside Funding – Mary Jane Keller – The Finance Committee met on April 20th also, the committee reviewed the preliminary budget for the 2016/2017 school year. Ms. Brie Adams gave us an update on the grant news, first a grant with G-Tech Strategies is still in the writing phase and it would be a fund that would be used for a green house at Twin Rivers School. A steam grant with Carnegie Mellon University was applied for and it was for engaging entrepreneurs. We applied for a Remake Learning grant in the amount of \$1,000 and it is to achieve more African-American students in our AP classes. Some of the students will then present a workshop for us on May 21st from 9:00 AM to 12:00 PM. The district received the 21st Century grant which will fund our summer school at Founders Hall grades 6-8 for approximately 90-100 students in the PAWS program. One of our art teachers, Ms. Nicole Givens wrote a grant also for art and she received it for \$500. That's my report.

Personnel - Mindy Sturgess/Steve Kondrosky - Mrs. Sturgess reported. The Personnel

Committee met on April 13th to discuss the items that were listed on the green sheets. An item that was certainly exciting for me and I'm sure for many of the Board Members and community members, is that we made our first hire for the NJROTC program that will begin at the high school in the fall. We still need to hire a commissioned officer. I would like to thank our Administrators for working very hard to make sure they are securing the most qualified and experienced person that we will have in our high school next year. So, that was very exciting. For those of you that don't know, we had to pull it from the green sheet last month because of the budget and the monies not being released. Of course, we got notification the next day that those monies were released. So, we're happy to get that approved this year. Another positive note is that we are able to continue our summer literacy camp this summer for our students and that has taken place for the last several summers at various locations where students in our elementary grades their parents can sign them up and they can come each week for a literacy session where they read with their parents often times the students leave with a book and we're also able to extend the Camp Invention summer school program that will be held at Twin Rivers this year. Last year we were only able to offer an AM session because of some of the grant funding that we weren't able to spend the beginning of the year. We were then able to extend that program this summer for both an AM and PM session. I know my niece participated in that last year, volunteered to get up at 8:00 AM on her summer break and absolutely loved it and is looking forward to participating again.

Safe Schools – Chris Halaszynski – Dr. Skezas reported. We had our meeting on the 25th of this month, this past Monday. There were quite a few items on the agenda, but two items that I would like to mention tonight, one is I just have to make a comment that our school probation county representative actually came to our safe schools meeting on Monday just to talk to us a little bit about communicating and collaborating with them. We have had a wonderful working relationship with our school probation officers that we've had here in the district and we have one full time and we share a half time probation officer with Steel Valley. Some ideas and changes that have occurred within the state of Pennsylvania with school probation, he came and shared with our entire administrative team which I thought was a good thing to do this past Monday. As well as we are continuing on with our Alice Training. Everyone should have gotten a log in to log in and give the information for the online training that's going to be June 10th and 13th. I know the Administration is going to be trained on May 27th which is a clerical day for staff. So, we have those two initiatives happening, the online training and then of course the training in person that I know that we're doing something with the McKeesport Police Department as well as the White Oak Police Department. That concludes our report.

Mrs. Sturgess – If I could add one more thing to Personnel. I wanted to thank Dr. Skezas and Mr. Seropian. We have been working over the past several months to look at our hiring practices for our Act 93, our Administrators, and some preliminary information we shared with

the Board this evening during Executive Session and we're hoping to move that forward next month, but they've done a lot of research and I'm hopeful that we'll have a system in place so our hiring practices are transparent and there is not that second guessing or trying to come up with starting salaries, it's all based on data and research that these folks have done. So, I would like to thank you for that and I'm looking forward to next month.

Mr. Lopretto – Well, Mrs. Sturgess, not only do they deserve thanks, so do you. I thought it was wonderful what you put together and I'm sure the whole Board in the back was impressed with everything. One last thing I want to talk about the mock.

Mrs. Gadson – Before you go off on another topic Mr. Lopretto, I just wanted to add as well in regards to the work that Mrs. Sturgess did, that when she was first appointed as the committee chair for Personnel, there was discussion around this work and she was new to the Board but she accepted the challenge and as you stated, I too was extremely impressed with the depth of research and detail that she gave to taking a look at it. I recognize that we have quite a bit of work to do to make adjustments across the board that she took the task much strategically. I appreciate it and as the chair of the Diversity Committee I appreciate her efforts to bring about equity to all employees across the board, so I do appreciate and support the work of Mrs. Sturgess.

Mrs. Sturgess – Thank you Mrs. Gadson.

Mr. Lopretto – One last thing, the mock DUI accident that we have every year before the prom. It will be held on Friday, May 13th, I believe around 9:00 AM. Any Board Members or anybody from the public that wants to come out and see this, it's really impressive and it really hits home especially once you see the way the first responders come in and our students play the parts in the vehicle accidents out there and it will give you the chills watching it. I have been on some real scenes and they make it look as real as real can be. I talked to Lt. Olinsky and he said that was going to be the day he had met with Ms. Barry, so that is when it's planned for so, unfortunately, it's Friday the 13th.
