Committee Reports -

Athletic –Mary Jane Keller/Jim Brown – Mrs. Keller reported. Mr. President, the Athletic Committee met on Tuesday, February 16th, discussion and review occurred for the following

items. First, the approval for our Spring and Summer coaches as reflected in the green sheets tonight. Number two, discussion about the Head Football Coach hiring at our Special Board Meeting on February 17th. That's my report.

Buildings & Grounds – Steve Kondrosky – Mr. President, we did meet today as a matter of fact, this morning, Dr. Coughenour, Ed Fagan and myself. There is only a few items on this list and I'm happy to say that most of the items on this list was done in house at a fairly low cost because of the staff that he has himself surrounded with. They did some work on the pool pump and that was by our sound man Ricky and Don Jackson. Walt Burton replaced two pumps on the hot water tanks at McClure. The heat pump filters were changed at McClure by Mr. Haliko. They rebuilt one pump with new seals at the White Oak boiler. It seems to me that there is only one boiler keeping that building maintaining a pretty decent temperature there. I don't know how long that's going to last, but I sure hope somebody takes that building off our hands before we have to put any more money into it. They replaced four (4) blower motors and two (2) motor housings at South Hall, heating univents in the classrooms and they used the ones that they removed from Founders Hall under the construction project in order to save money in that sense. I understand that the phone wasn't working correctly at South Hall for the PA system so they replaced that phone at a minimal cost and some fine gentleman removed all of ceiling mounted promethean projectors and stashed them in Dr. Coughenour's office much to her dismay, but too bad she has to deal with that. We continue to snow and ice removal whenever the good Lord puts it down upon us and we have to deal with it. Thank you, that concludes my report.

Career & Technology – Pat Maksin – We did meet this morning. It was a postponed meeting from the 18th due to Mr. Sebelia's funeral. We discussed five (5) items. The 339 review is scheduled for March 14, 15 and 16. Lois Richards who is a retired distinguished educator has been advising the district and making suggestions so that we're ready to go with that review next month. There was an update on the Tiger Inn lunches. As of this point we have taken in over \$10,000 between the Tiger Inn lunches and the Festival of Trees. Of course, that isn't profit, we use that money then to invest in the meal for the next week. But, it's a wonderful experience for our students and I think anyone who participates in buying the lunches also given a wonderful advantage. There is brochure that I want to bring to everyone's attention. This is the Cooperative Education Program. Jill Hershey who is our school to work coordinator created this brochure for the Cooperative Education Program which is part of the McKeesport Area Career & Technology Center. It is a program for seniors where they get the opportunity to go out into the community and work and also earn some credit for that. She did devise this, it's to be distributed to our students coming up, but we also want to get it out into the community so if anyone is interested, we do have the brochure that you can pick one of these up if there are any businesses in the community that might like to have some students work

with them and we'll try to get Ms. Hershey come and talk to you and see if that can work out. There is also a McKeesport Area High School and Technology Center career objectives, we would like to next year extend this to all of our high school students so it's a form that they fill out. It talks about all of their objectives and things that they have accomplished, the things that they hope to do. We talked about that today. It is CTC month, the month of February is CTC and that's why each of the Board Members was given one of these bracelets because all of the students in the CTC program this month were given one of these bracelets. So, we want to celebrate the CTC program.

Community Relations/Cultural Diversity –Trisha Gadson – We met today. There were several items on the agenda. The first was discussion around perceptions survey for staff. This agenda item came as a result of community meeting that occurred in the summer of last year or the early fall of last year around working toward bridging perceptions between school, community and staff. We are looking at moving that forward. We also discussed the Comprehensive Plan for the school district which covers 2016-2019 and we were discussing how to accurately reflect an effort by the district to recruit and retain minorities hiring for the district. In addition we talked about the McKeesport coalitions recommendations to the district around hiring policies and that was distributed to the committee and the chair of the policy committee, Mrs. Keller will bring it to the Executive Session of the Board for us to discuss. We also talked about the Black History course that is currently offered at the high school and identified that there are community resources within our district or African Americans within our district who are interested in serving as guest speakers within the time frame of that course. We talked about the Penn State talent search grant that was recently pursued through the district and we identified that as an opportunity for African American hiring. We discussed the PVAAS cumulative report in which we had asked for a report of the scores minus the names of the teachers so that we can take a look at the PVAAS scores and then use that to initiate some discussion about how to integrate some conversation around diversity conversations with those that coach. Last we discussed beyond diversity training. Coalition has been talking about having some type of training effort within the district. October Mrs. Sturgess offered a specific trainer through Pittsburgh Schools that I have been in contact with and a meeting is set up to bring back to the district so what we are hoping is some time in May to late June that training would be offered to the Administrative team, community members, it will be offered to School Board members so that we can initiate dialogue around diversity and inclusion and how that impacts the education of our students.

Education/Legislation/Policy – Mary Jane Keller/Mindy Sturgess – We met on Wednesday, February 17th. The agenda for the Education committee was relatively short. We discussed the revised summer school proposal that Dr. Bauman had explained to us the credit recovery and having it here. The benefit of having our students participate at a lower cost. We also

discussed the data share, the MOU which Dr. Bauman also explained to us through DHS that would allow us to get the specified queries and be part of that data sharing amongst districts and amongst the county. For Policy and Legislation that also occurred on February 17th and during that meeting we went over the second readings of policies 904, 905, 907 and 908, we went through the readings and voted on them today. That's my report.

Finance/Grants/Outside Funding – Scott Smith – We med on February 17th. In regards to grants, I believe it's due on Friday this week. The CITF grant which was a grant that would help with some safety improvements in regards to Eden Park and O'Neil Boulevards as well as the intersection. We have put in for a little over \$175,000 - we're hoping to get about \$150,000. Also, Founders Hall Middle School received a Fab Slim at Carnegie Science Center which will donate a 3-D printer to that school. In regards to finance, I know this is a shocker to everybody in the crowd, but we still don't have a State budget. I'm going to explain some of the problems it's creating for us. We have taken out a line of credit of \$3.6 million that is expected to last until possibly as long as mid-May. Naturally an additional line of credit in order to help us finish out the school year will more than likely have to be broached and I'm sure I think Mr. Seropian you had mentioned that's something we could possibly start talking about at the March meeting. We asked what are the estimated State budget funds due to us up to the end of March, and that would have been an additional \$8-\$9 million that we have not received. On top that we were also informed that we have not received in the 15/16 budget year we have not received the reimbursement of our debt service which left an additional \$1 million hole in our budget. Two other things, again Mr. Seropian, I believe you're working on the budget. I'm sure that's keeping you a little bit busy. As he had mentioned, we have the copiers that are out for bid and next month I think the Intent is to potentially start discussing award possibilities. That's my report.

Mr. Seropian – If I can, I just want to add one thing that just developed today. We discussed this issue in the past with the diversion of State subsidies to charter schools. I got notice today, because even though the budget hasn't been passed, that was the basic ed funding that has not yet been passed, but there are other fundings that we get for example social security reimbursement from the State, retirement reimbursement, Special Ed subsidy, etc. It appears the Department is going to divert, that we are not going to be receiving those funds because they're going to divert those to the charter schools. We just got notice that our social security payment was supposed to be \$1,000 that we were supposed to get next week and they deducted the entire amount to give to charter schools.

Mr. Lopretto – I thought you was going to give us some good news because Mr. Smith give us all bad news.

Mrs. Maksin – Is there anything we can do as a Board to let people know how upset we are?

Mr. Matta – There is a prime example. The funds that they are diverting are not even funds that are earmarked for charter schools. They're funds that are earmarked for a different payment. I'm going to contact, if the Board's fine with this, PSBA tomorrow and see if there is something that they are willing to do that we may be able be involved with. This has to be more than just a school district. I think that PSBA needs to address this issue. I'm going to talk to Stuart Knade tomorrow and if there is something I can report back, I will contact the Administration and send an email out to everybody to tell them their position. But, clearly, at least you could understand if it was funds that we were receiving that were to go to charter schools, but these funds have nothing to do with charter schools. It's just a travesty that that is where these funds are being earmarked for. It's probably because they weren't happy with some of the things that the State treasurer did earlier, and the State treasurer did the right thing several months ago.

Mr. Seropian – It's really not fair that the school districts won't get any money, but the charter schools will be funded as if there is not a budget impasse.

Personnel – Mindy Sturgess/Steve Kondrosky – Mrs. Sturgess reported. We met on Wednesday, February 10th to discuss the personnel items that are reflected on the green sheets. I do want to point out that we had two submissions for retirement, George Lepsch and Deborah Hose. Both will be looking at retirement in the future. We also discussed the creation of two positions for the 16/17 school year for the JROTC program Air Force program that will be happening at the high school. That will consist of one commissioned officer and non-commissioned officer and those would be individuals who are already retired from the Air Force so we're really looking forward to that program beginning. There were also some changes to the substitute lists and the deletions from that were either folks that have not responded or not subbed for us for quite a long time or have not had their clearances and kept their records updated so those names were removed. We also had an additional position that will be posted. We had one that was closing, the painter/maintenance helper. That position will be posted tomorrow for a carpenter/painter/plasterer/maintenance helper. That concludes my report.

Safe Schools – Chris Halaszynski – We had a meeting this past Monday, February 22nd. There was a good bit of staff and Administration there. We had building reviews from those individual administrators from those buildings. One of the concerns that I brought up last month that we're still dealing with is trying to make sure that we have cameras on all of our buses. We have been assured that there are cameras on a good bit of them, but we're falling short of all of them, which is obviously a safety concern across the board. Until there is

unfortunate of an incident happening, then we'll be fighting for those, they'll probably installed after and always after the fact. I am hoping that this administration dealing with PA Coach Lines can get this squared away sooner than later. I know it's on a contract, I know the ball is in their court because it's something they should be doing, it's something that's worded, butwe need to get cameras on these buses for sure. Also, we talked about more importantly besides the bus cameras, we spoke of the Alice training, which I mentioned last month, it's an active shooter training. The district paid for two police officers to go to this training, I believe it was on February 17th, Lt. Craig from McKeesport Police and Officer Bell from White Oak Police went to the training. I talked to Lt. Craig briefly on it, he had nothing but high praise of this training and they will at some point get together with our Administration and figure out a way to actually teach this training to 400 staff members and whoever needs to go through the line here. But, that it itself was a necessity to have done and we got it done quickly, so I'm glad to see that is accomplished. That's my report.

Mr. Lopretto – Those two officers that the school district sent are probably two of the most qualified to do the job and I don't think anybody that goes through the course will be disappointed. I think they'll learn a lot because they're good, they really are.

Mrs. Gadson – I just want to know, after the officers go through the training and then they bring it back, will our students have to have drills? How do you implement that?

Mr. Halaszynski – Doc, can you actually touch better base on that? I know that the staff will actually be taught this training, correct?

Dr. Bauman – They will do it through a multi-media. They'll do it online. There is a four-hour sessions on line that they will go through for two different years, but in addition the two officers we have to as Chris mentioned, we have to have conversations with those officers and facilitate how that might look and from what they have been trained we'll do whatever they might suggest as the best way to educate our community, our students and our staff. Those decisions haven't been made yet.

Mrs. Gadson – Just curious about that. Thank you.

Dr. Skezas – I just want to chime in here. Bart Rocco, the Superintendent of Elizabeth Forward School District and I have been in communication and they just did a training at EF, so he has given me some pointers on how they facilitated it, how they broke it up, you can't have too many people being trained at one time so and they used the same kind of Alice training and I've talked to Mr. Wayne Wade about it and he seems like he has a good handle on how he's going to organize it and how all of our staff members are going to get trained, then of course we'll be

sending letters home to parents so that they know that our children will be going through various drills.

Mr. Halaszynski – Just to go back a little bit, regarding the cameras on the buses, I would encourage, if it's not out of line, any parent who has children on these buses, feel free in my opinion to call PA Coach Lines and if there is not a camera on your child's bus, I would make a big concern and a big gripe that the safety of your child, the safety of that bus. There is a lot of different ways to look at it, but I think he realizes or this company realizes they are not following what is the letter of their contract, then maybe people calling, an overwhelming amount of phone calls might get them started in the right direction. That's it.
