Committee Reports -

Athletic –Mary Jane Keller/Terri Kisan – Mrs. Keller reported. The Athletic Committee met on Tuesday, August 11th. We reviewed and approved the following items. Athletic Director Kiss reported on two resignations and 14 employee hires as reflected on tonight's green sheets. The lettering Neenie Campbell Gymnasium on the outside of the building has been installed. The new lettering for Tiger Stadium and the new scoreboard is being done right now. Banners on the inside of the Neenie Campbell Gym are still to come. Ms. Brie Adams is researching outside grant money for a pre-season maintenance project on our girls' softball field at the high school. That's my report.

Buildings & Grounds – Scott Smith – We did not meet; however, I do have a report. Other than the normal summer maintenance which we all know is a lot, the maintenance group took on a special project, the alternative education construction project at the high school. That project is expected to be done and ready to be occupied at the beginning of October. What I can say is that by doing it in house, we probably have saved in my opinion about 66% of what it would cost to outsource it. In putting the Alt Ed center where it's at, DocuTech needed to be moved, that's also part of that expense savings. During the construction at the Alt Ed center, we found a roof drain that was from the original construction of the building that was cut in 2003 and never reconnected by the contractors. That has been resolved. It solves a big issue in part of a corner of a building so we were happy that we found that and it was taken care of also primarily in-house with a little bit of outside help because we were dealing with some footers that had to be dealt with as well. There was 3.5 ton roof top air conditioner that was at the Cornell school that was salvaged and actually installed in the graphic arts center area which was also relocated as part of the Alt Ed center which we can estimate saved approximately \$5,500 by salvaging that unit. Founders Hall parking areas as well as South Hall throughout the summer have received several hot asphalt patching to help make it safer for the kids that use the facility as well as the vehicles that drive through the facility. That's my report. (Mr. Seropian – In addition to the cost savings that resulted from our own staff doing this, our custodial/maintenance staff does a phenomenal job if you see the work out there and the product that they are producing, it's amazing, they do a great job.)

Career & Technology – Terri Kisan – Thank you Madame President. Our committee was named CTC – Career Technology Center, but now on the leadership of Dr. Rula Skezas, we have a new name it's McKeesport Area Technical Center (MATC). (Dr. Skezas – Actually that's what

it's been called for years upon years, but it was never referred to as that.) Thank you for your leadership and we also have an Assistant Director now, Dr. Mark Holtzman is also the Assistant Director of the MATC. So, we were happy to meet on August 13th and at that meeting we discussed the robotics, our three period engineering class. On the green sheets, a conference request for the PACTA conference. We also have an approved program evaluation along with our comprehensive technical center evaluations that we're working on for the 15/16 school year. We discussed the culinary and we will continue to visit Kane Hospital once a month for the service to those residents and culinary and cosmetology. Under culinary we will continue again with the lunches, however, it will be two days a week as I had reported last meeting, but the price has gone up from \$4.50 to \$5.00 per lunch. Save the date for career expo fair will be October 22nd. Thank you Madame President.

Community Relations/Cultural Diversity –Trisha Gadson – We had our first official meeting for the school year today, however, we have been meeting all summer in preparation for the third annual Back to School Bash. Today we met to finalize the details as Dr. Skezas indicated in her report the Back to School Bash will occur on Saturday, August 22nd, at Founders Hall gymnasium from 1:00 – 3:00 PM. Over 500 book bags filled with supplies will be distributed. The second half of the meeting we began to discuss what our focus will be for the remainder of the 15/16 school year. Our discussions centered around the impact that race and poverty have on students. Again this year we will focus on closing educational gaps. That concludes my report.

Education/Legislation/Policy – Mary Jane Keller – We did not meet in August, but we have several topics already for September.

Finance/Grants/Outside Funding—Tom Maglicco — Yes, Madame President, we did have a meeting and as always we talked about the budget shortages that we often encounter. Mr. Seropian had mentioned in the budget that our fund balance is projected to be slightly higher this coming year and I don't know Dave if you want to touch on the Moody or Standards and Poors reports.)

Mr. Seropian – We talked about it last month, but I think it's worth mentioning again because some of you may have seen an article in the paper and maybe even on the news about the Moody's coming out with a report and part of their review process on their ratings, it wasn't part of a bond issue but they did a routine review and came out with a rating and they lowered our bond rating down to a level that was pretty low. We strongly disagreed with that rating, think it's totally unwarranted, and so fast forward to the issue on here today, we got a rating for this bond issue that was on item #14, so we went to Standard and Poors which is another rating agency, and they rated us an A rating, much higher, like five levels higher than what

Moody's did. So, they validated what we thought and Alicia might want to add to that. The Moody's report is out there and it does have a negative effect in some ways because now buyers of bonds are looking at two different ratings and trying to make a decision about buying our bonds. It was unfortunate that Moody's took that ridiculous action that they took.

Mr. Smith – Was it not true that Moody's issued that report prior to doing the reassessment of all the schools in the State of Pennsylvania?

Mr. Seropian – My understanding from them when they first informed me of what the rating was and after I said a few things, they said don't get too upset because you're only the first in a number of districts that we're going to be doing. We've only done a handful so far and we're going to be doing this across the State so you're not going to be the only one with that rating. Then they came out with that report and it may look like we're the only ones in the whole country that has that rating.

Mr. Smith – So the report was potentially premature?

Mr. Seropian – They do that, but just the way it worked out them releasing it, it generated a lot of publicity which may or may not have been their intent.

Mr. Smith – So these ratings are very similar to my personal credit rating, but on a school basis. Typically my personal credit rating is based on my ability and past history of making payment on my debt. That's how my personal credit works, I know Moody's and Standard and Poors should be similar and I guess my question to Dave is, how many payments have you missed?

Mr. Seropian – We have never missed a payment obviously, and I explained to the gentleman that we have had a fund balance for 17 years in a row, have never been in deficit, it was uncalled for.

Alicia Phillips explained.

Just wanted to finish up Madame President, that's also true that we discussed at this meeting to continue to work toward reducing our budget over the next several years as the Board moves forward to always keep that in mind that any ways that we can save money, our revenues are fixed at a certain cost, we've raised some taxes, but we still have to find ways to lower our budget due to the fact that we don't have enough monies coming in and hopefully the State will be generous in their subsidies this year. As it was reported in The Daily News, I just want to say that it looks like I will be accepting a position in a couple weeks and I will be sworn in as the new City Controller for the City of McKeesport. My heart is heavy because I

am passionate about this school district and being a student of this district all my life, and my heart is in the City of McKeesport and this school district. I remembered when I opened my jewelry box, I saw this little red wagon in there. Instead of putting the American flag on today that I wear so proudly, I grabbed the little red wagon and the little saying here by Margaret Katter was pretty nice, I read it as I was coming in today, but I would just like to read it. It says, some days we skip along pulling our wagons with great confidence so full of energy, but the load seems light. Some days the load seems heavy and we need someone to help us pull our wagon over the bumps in the road. Some days we are just tired. We sit in our wagons and let someone else pull us along for a while. And some days it's kind of nice to share our little red wagon with a friend. As you think about yesterday and make plans for tomorrow, keep in mind that there will be times when we can all help pull someone's little red wagon for a little while. After all, helping pull each other's little red wagon is what makes it possible to face the challenges the day brings. This is even touching because of where I got this was in Washington DC after I was injured in the Operation Iraqi Freedom actually in a training mission, it wasn't in a war conflict. I was a whirlwind when I got sent back to Kuwaiti Hospital, to a hospital in Germany when to Walter Reed Hospital in Washington DC. The one doctor there knew that I had worked in the Boys and Girls Club and was in that movement and he offered me to go down to the Reagan Center to see General Colin Powell. That's where General Colin Powell handed me this card and this little red wagon. I hear what Mrs. Walker had said earlier today, but I've go to say that a person that grew up in the town and our mentor, Tim Brown's in this audience, Sam LaRosa, we all have red blood in our veins. That's what I look at when I look at people and I look in their eyes, I look at them as people and we all have red blood. We all believe the same passion for kindness, peace, love, joy whatever it might be. I look to white, black, yellow, brown for guidance for spiritual leadership for motivation. That's what's true in my heart and I hope that's what's true in everybody's heart. Madame President, it's an honor to serve with everybody. As I get sworn in a couple of weeks, I'm going to accept that position and I will be resigning next month as an MASD school director. My heart will never leave here, I may pop in the audience and see everybody and Mr. Brown's coming aboard here shortly so I will be cheering you on there as I will be cheering on the City of McKeesport and rolling up my sleeves and getting back to my roots at the Boys and Girls Club and in the community to do clean up days or whatever it might take to help make our city great. I just want to say thank you, you guys are more than just colleagues here, we're family, we've spent many nights together, days together and sometimes mornings and I consider you all family. Sometimes we all didn't agree all the time, but to let you know, I consider each one of you a friend and I look forward to working with you in another capacity now. Thank you. (Mrs. Maksin – not a dry eye here. Thank you.)

Personnel –Joe Lopretto/Tom Maglicco – Mr. Maglicco reported. The personnel sheets reflect what the Administration had put together and the Board and we welcome all of the new

employees to the district on this sheet and thank you for all your hard work and effort in putting this together.

Safe Schools – Joe Lopretto – Dr. Skezas reported. Mr. Lopretto and I scheduled a meeting for August 25th. Day before the teachers come back.

Solicitor's Report -

I have two items that will need action this evening Madame President. One if Grievance #5-14-15. I would be requesting that the Board deny that grievance at this time, I would need a motion on that matter.

Grievance – Mr. Smith moved to deny MAEA Grievance #5-14-15. Seconded by Mrs. Kisan.

Also, I would need approval of Resolution #1127. If I may Madame President, instead of reading the whole resolution, I would like to explain to the community what this is. As everybody is aware, there are properties within our school district and within our city that are delinquent and in a blighted state. The City has approached the school district on a proposal that when we have properties that are in this condition that we may be able to join together in eliminating penalty and interest, but still receiving all of the back taxes due on those properties and get them into projects that can be recreated to put them back on the tax rolls. district, each Board Member here and the Administration feel that this is a very good project that we can partner with our communities and make certain that we are finding areas of our community that are not tax generating at this point and make them tax generating properties and establishing anchors in certain communities with projects that will help develop not only the exact piece of property that is in question, but also properties surrounding it. So, this evening if the Board would choose to approve this resolution it would give the Administration and Business Manager specifically the ability to work with the city on projects of this type to help economic growth within the school district and the city. I would ask approval this evening of that resolution.

Resolution – Mr. Kondrosky moved to approve Resolution #1127 - a Resolution of the Board of School Directors of the McKeesport Area School District, establishing a policy to forgive penalties and interest on certain properties as identified as an exhibit to this resolution. Seconded by Mr. Halaszynski. Discussion followed.

Mrs. Gadson - I would like to make a comment, Madame President. So I first want to acknowledge the heartfelt comments made by Mr. Maglicco. I want to personally say it has been a privilege and an honor to sit beside you in the room. I have learned from you and I have grown from you. You have literally driven me around the district when I first was appointed by the courts before winning the election and I appreciate your guidance and support. We have even had some very courageous conversations where it has been tense between us, but we have been able to work it out. I appreciate you for that. However, I have to say something as a member of the district, as a mother of two graduates, as a professional and as an African American woman. My friend, race does matter, it does matter to us and I cannot sit here and say it does not enter into the equation when I am terrified about my son walking or driving in our community or any community at certain times or when I am looking at the outcomes of children who are my friends' children and my son's and my daughter's friends. When I look at the families that look like me, race does matter and we were talking about that today in the Diversity Committee, we can't say it doesn't because it does so I think what the constituents were saying is that they are hoping that this Board will give consideration to qualified people of color to represent and to provide a different voice and a different perspective and a different color to the conversation to the meaningful and important conversations and because we want to see that does not take away from the contributions, your hours, your dedication, it speaks volumes Tommy, I'll never forget it and I will always be indebted to you for the way that you have helped me, but race does matter. But, I wish you well my friend, and I sincerely mean that.
