GENERAL EXPECTATIONS

Academics

All students are enrolled in English, math, science, and social studies and exploratory classes. In order to be fully promoted for the year, Nighthawks must:

- · earn passing grades (60 or above) in all of their classes,
- · attend school at least 170 days out of 180 school days.

Grading Scale – Students will receive grades using a 100-point grading scale. The following are examples of numerical and letter representations found on the 100-point grading scale.

The expectation is that NWMS students will do their best work on every assignment. If additional time is needed to learn or complete assignments, the teachers will work with the students through tutoring time before or after school. **Not doing work or doing poor quality work is not okay or accepted.**

Academic Awards— NWMS is focused on academic excellence and growth. In a continued effort to acknowledge the academic achievement of NWMS students, academic awards for A/B Honor Roll (all course grades at 80 or above for the 9-week grading period) and A Honor Roll (all course grades at 90 or above for the 9-week grading period) will be awarded on a quarterly basis. Students who make the "A" Honor Roll all 4 quarters will receive the Principal Honor Roll. In addition, students receiving A/B and All "A" Honor Roll will attend special quarterly incentives to reward them for their hard work and dedication.

Homework Policy -Meaningful homework is assigned and explained to help students practice what they are learning in class. Students should use their agenda to organize assignments.

ATTENDANCE

Attendance - Students cannot learn, if they are not at school! Students need to be at school EVERY DAY unless they are sick or have an emergency. If a student misses too many days (more than 10), the student may be retained in their current grade. Excused absences include being sick, going to court, or a serious family emergency (with documentation). Students can only use a parent excuse note for a total of 10 days; after the 10th absence, the student will need a doctor's excuse or other official documentation.

An excused lawful absence shall permit a student to make up missed work, in a timely manner. Any absence determine to be unexcused will not entitle a student to make up the work missed during the absence.

In order to receive credit for a full day, students must be at school until 12:00 pm. If a student needs to leave early or if a parent brings a student late, the parent must sign the student in or out at the Main Office.

Leaving Class - should be limited to emergency situations. Students must always have their agenda and ID to leave during class instruction

Tardy to School - If students arrive after 8:30 am, their parent must sign them in at the main office. They will get a pass to class; however, not all tardies to school are excused.

For example, late buses are excused tardies...teachers will be informed of late buses, and students will report to class when their bus arrives. However, if a student oversleeps and come in late, that's not excused.

Leaving Early-Parents must sign students out by 3:00 pm if they have to pick students up before dismissal. Students will not be allowed to leave after 3:00 pm due to interference with the end of the day dismissal.

ARRIVAL/DISMISSAL

The school day begins at 8:30 am and students are dismissed at 3:30 pm. Students are not allowed on campus prior to 8:00 am, as there is no supervision for them before 8:00 am. Students are allowed to enter the building at 8:15 am and need to be in their homeroom by 8:30 am. Once on campus, students may not leave campus for any reason during school hours, without being signed out by a parent or guardian in the main office. Any student arriving to school after 8:30 am is considered tardy and must sign in at the main office.

DANGEROUS ITEMS

Do not bring anything that is dangerous, inappropriate, or illegal to school or to the bus stop. This includes anything that could be considered in the family of weapons, drugs, medicines, cigarettes, tobacco, lighters or fireworks. Students will receive a consequence if they bring these items to school or the bus stop—this can include arrest and/or a recommendation for expulsion from school.

OTHER PROHIBITED ITEMS

Games, toys, metal picks and magazines/catalogs are not acceptable during school time. Items may be confiscated.

ELECTRONICS/CELL PHONES

Per the CCSD Code of Conduct, "Middle School Students (6th - 8th grade) may possess mobile telephones, smart phones or other such devices on school property and school-sponsored transportation, provided they are not visible, used or activated, and are kept in a silent or "airplane" mode, blocking all alerts throughout the instructional school day and while on school-sponsored transportation. Middle school students must keep their mobile telephones, smart phones or other such devices in a vehicle, locker, pocket, purse, backpack, or other non-visible secure location.

Those devices not stored properly by students, and visible at unauthorized times during the day, can be confiscated by NWMS staff and stored in the school vault. Confiscated cell phones will only be returned to students when the parent or guardian of the student meets with an administrator about the device.

*** Please note that devices confiscated three (3) times will only be returned at the end of the school year.

Responsibility/Liability: Any student who chooses to bring a cellular phone or other wireless communication device to school shall do so at his or her own risk and shall be personally responsible for the security of his or her cellular phone or wireless communication device. Neither the school personnel or Board will assume any responsibility or liability for loss, theft, damage or vandalism to a cellular phone or other wireless communication device brought onto school property, or for the unauthorized use of any such device.

BULLYING, CYBER BULLYING, SEXUAL HARASSMENT

CCSD Schools adhere to a 3 Level Offense and Action System. **Bullying, Cyber Bullying** and **Sexual Harassment** are considered **Level 3** offenses, the most serious of offenses. Level 3 offenses are automatically treated as **Criminal Conduct** which means they significantly disrupt the learning environment or pose a direct and serious threat to the safety of oneself or others. These activities require administrative action and may require action by law enforcement, Office of Student Placement, Associate Superintendent, or the Constituent District Board. **Bullying, Cyber Bullying,** and **Sexual Harassment** will not be tolerated. If you feel you have been a victim, you must report the incident immediately so the school administration can take action. Please see your 'Student Code of Conduct' for a detailed explanation of the Level 3 Offense and Action System.

Bullying inflicts physical hurt or psychological distress on one or more persons through unwanted, purposeful written, verbal, nonverbal or physical behavior. Bullying may include:

- Saying mean or hurtful things to someone, making fun of someone or calling someone mean or hurtful names
- Completely ignoring or excluding someone from their group or other activities on purpose

- Hitting, kicking, shoving, or restricting movement
- Telling lies or spreading rumors about someone
- Sending mean notes (on paper or electronically)
- Trying to make other students dislike someone and doing other hurtful things

Cyber Bullying is willful harassment and intimidation of a person through the use of digital technologies, including, but not limited to, email, blogs, texting, social media (i.e., Facebook, Twitter, etc.), chat rooms, sexting, instant messaging, or video voyeurism. Cyber bullying may include:

- Repeatedly sending offensive, rude and insulting messages.
- Distributing information about another that is derogatory or untrue through social media postings or any other digital method
- Online "fighting" using electronic messages with angry, vulgar language
- Breaking into an email or social networking account & using ones online identity to send vicious or embarrassing material.
- Sharing someone's secrets or embarrassing information, or tricking them into revealing secrets or embarrassing information and forwarding it to others.
- Repeatedly sending messages that include threats of harm or are highly intimidating, or engaging in online activities that make a person afraid for his or her safety; cyber stalking.

Sexual Harassment

CCSD is committed to maintaining a learning environment for all students which provides for fair and equitable treatment, including freedom from sexual harassment. It is prohibited for any person, male or female, to harass another person by making unwanted sexual advances or requests for sexual favors or engaging in verbal, written, electronic, or physical conduct of a sexual nature. Sexual harassment includes, but is not limited to:

- Unwelcome leering, sexual flirtations or propositions
- Unwelcome sexual slurs, epithets, threats, verbal abuse, derogatory comments or sexually degrading descriptions
- Graphic comments about an individual's body or overly personal conversation
- Sexual jokes, drawings, or pictures
- Spreading sexual rumors
- Inappropriate or suggestive sexual gestures
- Touching an individual's body or clothes in a sexual way
- Cornering or blocking of normal movements with sexual intent
- Displaying sexually suggestive objects

Any student who believes he/she has been subjected to bullying, cyber bullying, or sexual harassment by another student, teacher, administrator, adult, or agent of CCSD should file a complaint of the alleged act immediately with the school's principal, assistant principal, or another adult in the building. The complaint should be made in writing. False charges of sexual harassment shall be treated as a serious offense, and those persons making false charges shall be subject to disciplinary action.

BUS EXPECTATIONS

CCSD students are afforded the privilege of bus transportation to and from their home schools daily. Appropriate behavior by students is essential to maintaining safe transportation. Students are expected to behave in a manner, similar to that of a classroom environment. Inappropriate conduct on the school bus may result in a bus conduct referral. Said referral will be reviewed by school administrators for discipline based upon the CCSD Progressive Discipline Plan. Consequences for Code of Conduct violations on the school bus will be addressed by the school principal or designee, following the CCSD Progressive Discipline Plan. These include, but are not limited to, parent contact, student conference, assigned seat, and/or bus suspension. Serious or continuous Code of Conduct violations on the bus may result in bus suspension for the remainder of the year.

Nighthawks must ride the bus to which they are assigned and must use their assigned bus stop. If a student wishes to ride home with another student, the parent should send a written permission slip, and the student must submit the note to the Attendance Clerk for a temporary pass.

PARENT VISITS

We would LOVE to have parents visit school. Due to safety reasons, parents will need to sign in through the front office and get a visitor's pass prior to entering any classrooms. Following check-in, an administrative staff member or school representative will remain with the parent or guardian for the visit and escort individuals to and from the classroom. Although drop-ins are welcomed, to ensure that visitation arrangements are in place it is best that parents make an appointment through the front office at least 24 hours in advance for visits. We want all parents to see what class is really like – that means that the teacher won't be able to stop the lesson to talk to parents during class. Parent conferences to discuss individual student progress can be scheduled by contacting one of the team teachers by phone or email or Ms. Rhonda Curtis in the front office . ****Other family members or special guests must have specific permission from the principal to visit a classroom.

MEALS

Lunches will be served every school day with the option to buy extra milk. Food and drinks are to be consumed in the cafeteria unless specifically arranged by a teacher or the administration. This includes gum, drinks and other snacks. Breakfast is served as soon as students arrive in the building. Students may **not** have food or drinks outside of the cafeteria after breakfast. Students are not permitted to enter the building with opened, outside food items.

TELEPHONE POLICY

There is only one student phone in the building which is in the main office. Students will only be allowed to use the phone with a pass from their teacher. Teachers will not give a pass unless the call is an emergency. Because there are so many students at school, we will not call students out of class or deliver phone messages to them.

If a student is sick and may need to go home, the student must go to the nurse and call home from the nurse's office. This helps us make sure that each student gets the care they need until their parent is able to pick them up. Using a cell phone on campus during the school day is against school policy.

DRESS CODE

Northwoods Middle School students are expected to dress, be groomed, and otherwise conduct themselves in such a way as to not distract or cause disruption in the educational program or orderly operation of the school. Personal appearance and conduct of students should promote health and safety and contribute to a climate conducive to teaching and learning. School administrators will be responsible for determining violations of this policy.

The administration will make the final judgment on the appropriateness of a student's clothing, appearance, and/or display of symbols, messages, or statements on school grounds and reserves the right to prohibit students from wearing any articles of clothing or other items or displaying any symbols, messages, or statements which lead to or may foreseeably result in the disruption of or interference with the school environment.

Clothing, articles, hair, and/or other displays should not be so extreme or inappropriate to the school setting as to disrupt the educational process. Therefore, any items deemed distracting, revealing, overly suggestive, or otherwise disruptive will not be permitted. Wearing items that could pose a safety threat to one's self or others is not allowed.

Clothing, articles or other items, which display advertisements for, or messages or pictures depicting or suggesting, alcohol, tobacco, drugs, weapons, or sex are prohibited.

Clothing, articles, or other items, which display symbols, messages, or statements, which would distract others, interfere with the instructional programs, or otherwise cause disruption, are prohibited.

Attire must not be immodest, obscene, profane, lewd, vulgar, or indecent.

Violations of this policy will result in the following:

- In the event the administration determines a student's dress, articles, or display of items is inappropriate for school in accordance with this policy, the administration will require the student to remove the articles or items, turn inappropriate clothing inside out, or change inappropriate clothing and make alternate clothing available for the student to wear.
- If, upon request, the student refuses to follow the directive of the administration in accordance with this policy, the student will be sent to in-school detention and the parent/legal guardian will be contacted.
- Repeated violations of this policy will be treated as disruptive behavior in violation of the student code of conduct.

There are two reasons for a Dress Code at NWMS: Safety & Self Respect. Uniforms allow faculty and staff to identify trespassers as well as NWMS students who are out of area. Also, uniforms help create an

environment of professionalism and respect. The NWMS administration, faculty, and staff expect students to dress appropriately for school. High expectations of dress contribute to high performance in the classroom. Dress with self-respect.

UNIFORMS

Pants --Khaki colored 'chino' pants or shorts. Shorts must be finger-tip length Females may wear skirts/skorts. Skirts/Skorts must be finger-tip length

Tops -- 6th grade/ROYAL BLUE shirt or NWMS t-shirt 7th grade/GRAY shirt or NWMS t-shirt 8th grade/BLACK shirt or NWMS t-shirt

UNIFORM AND DRESS CODE CLARIFICATIONS:

NWMS ID: Students are required to wear their NWMS ID as part of their NWMS uniform. Students will receive one ID at the beginning of the school year. Additional IDs are for purchase through the library for five (5) dollars.

Sweatshirts/sweaters: Students must wear NWMS grade level sweater, or solid color grade level colored sweater/sweatshirt/fleece with visible polo underneath. **Hoods**, writing or designs are not permitted. One small logo is permitted, but must be smaller than a quarter in size.

Jackets: Unless instructed otherwise, heavy jackets/coats/windbreakers are to be placed in lockers.

Leggings: Solid color leggings (white, black, brown) are allowed to be worn underneath skirts or skorts. No leggings or tights are permitted underneath shorts.

Shoes: Shoes must have a back or ankle strap. Flip flops, slides, backless sandals, bedroom shoes, including slipper boots, are not permitted. Students are not permitted to tuck clothing into shoes or socks.

Necklaces: No policy on length. However, medallions larger than NWMS ID or distracting in nature are not allowed. Additionally, students are only allowed to wear one (1) necklace in addition to their NWMS ID.

No jewelry will be permitted that displays profanity, weapons, violence, suggestive phrases, alcohol, tobacco, drug advertisements or other inappropriate phrases or symbols as determined by the administration.

Backpacks/String Bags/Purses: Backpacks and string bags must be kept in locker during school hours. Female students may carry (1) one purse no larger than a ½ size of notebook paper. Clear backpacks are okay.

OTHER UNIFORM INFORMATION

Student will not be allowed to wear uniform or club shirts that have been altered from their original condition (i.e... writing/drawing, cut sleeves, large holes or tears)

- Students are not permitted to wear decorative scarves around their neck.
- Bandanas of any type are prohibited.
- Bonnetts or distracting head pieces are prohibited.
- All headbands should be worn for the purpose of retaining hair. Headbands must be no larger than the width of the NWMS ID.
- Sunglasses are not to be worn at school.

Northwoods Sports Shirts - Shirt and tie/professional dress or jerseys may be worn over uniform shirt on **Game Days Only.** No High School gear is permitted. Sports shirts may only be worn on Fridays.

CLINIC SERVICES

Screenings - The nurse will help students stay healthy by checking them each year for health issues below:

- 6th Grade Scoliosis
- 7th Grade Vision
- 8th Grade Blood Pressure and Scoliosis

Immunization-Section 44-29-180, SC Code of Laws, and SC Regulation 61-8 state "... no institution of learning ...no school board or principal of a school...may..enroll or retain a child or person who cannot produce satisfactory evidence of having been vaccinated or immunized so often as directed by the Department of Health and Environmental Control" (SCDHEC).

Current immunization requirements for students enrolling in CCSD 5-K – 12 schools are; Diphtheria, Tetanus and Pertussis, Tdap Booster, Polio, Rubeola, Rubella, Mumps, Hepatitis B, Varicella. Medication - Only medicines prescribed by a doctor are allowed at school and must be kept with the nurse. Under NO circumstances may a student have any type of medication in his/her possession (including book -bags, pocketbooks, pockets, etc) while on school grounds. Students in possession of any kind of medication on campus may be referred for disciplinary actions.

Clinic Visits - Every student must have a pass from a teacher to be admitted to the clinic. The only exception would be an <u>emergency</u>.

Health Problems - Students with specific health problems like diabetes, asthma, or allergies should make sure the nurse knows about their illness. The nurse will create a plan to help them with their needs at school.

Emergency Cards - A parent or guardian must fill out the student's emergency card completely at the beginning of the school year or immediately upon enrollment at NWMS. CCSD policy requires that each student have a completed, updated emergency card on file in the school clinic. It is crucial that your emergency contacts are people who are usually available to pick up your child. Any significant health problems should be noted on the emergency card. The emergency card authorizes the school to obtain emergency medical care in case of a serious accident or injury or medical situation.

STUDENT ACTIVITIES

School Comes First - Just like in high school and college, students cannot play sports or be a part of a club/program unless they are passing and in good standing at school. This means that in order to participate in extracurricular activities students must have a 60 average or better in every class, attend school, and demonstrate good behavior. To be active in extracurricular opportunities, you will need: teachers' recommendations

- **appropriate school conduct and behavior as outlined in the CCSD Student Code of Conduct.
- **passing grades (60 or higher) in all classes*
- · If you do not meet the two starred items above, you may be accepted on PROBATION. If your grades, attendance, or behavior do not improve while you are on PROBATION, you will be cut/lose program privileges such as playing in concerts, attending field trips, or other events.
- · If you are not on probation and a problem develops, you will be benched for at least one game/event. Failure to improve your grades, attendance, or behavior will cause you to be cut/lose program privileges.
- If you are ABSENT /OSS on the day of an event, you may not participate or attend.

Sports -The following sports are currently offered: football, basketball, soccer, volleyball, and cheerleading.

NWMS students also benefit from sports programs available through Stall or North Charleston High Schools and North Charleston Parks and Recreation. Nighthawks must register with North Charleston Parks and Recreation, North Charleston High School, or Stall High School and follow all of the regulations set up by the school or recreation department.

Academics-In order to be promoted students must pass all CORE classes. Students may be administratively promoted if they fail one CORE class. Students failing 2 or more CORE classes can be retained.
