#### INTRODUCTION

Under the Elementary and Secondary School Emergency Relief II Fund (ESSER II), authorized by the Coronavirus Response and Relief Supplemental Appropriations (CRRSA) Act, the Pennsylvania Department of Education (PDE) awards grants to School Districts and Charter Schools to address the impact that Novel Coronavirus Disease 2019 (COVID-19) has had, and continues to have, on elementary and secondary schools across the state.

Please explain how the LEA will determine its most important educational needs as a result of COVID-19. (3000 characters max)

McKeesport Area School District has spent most of the 2020-2021 school year determining how education within our school district will look moving forward. MASD partnered with the University of Pittsburgh to conduct three surveys, a parent, a student (3rd – 12th grade) and a teacher survey that focused on the needs of education currently and moving forward. A brief summary of the results of the survey revealed the following: students working in an online environment reported a higher level of stress, social support was significantly lower for students participating in an online environment, students receiving in person instruction reported significantly higher teacher feedback and online students lacked a daily routine which was a challenge for learning. MASD has evaluated our students' academic needs using a variety of assessments to determine learning loss. We have determined the areas of instruction that need to be changed and modified moving into the 2021-2022 school year. We have also looked at our students' social and emotional well-being and have put into place people and programs that will provide them much needed supports as we move into the next school year. Additionally, we have interviewed different stakeholder groups throughout this year to determine what each group feels are the most important educational need of the school district. We have talked to teachers and administrators at all levels, district support staff, students at the high school level, and parents from a variety of demographic and economic backgrounds to make sure that we have received information from a diverse group of people. All of the information that we received has gone into determining McKeesport Area School District's three most important educational goals (needs) of the school district. These undertakings have resulted in the determination that MASD has three goals (needs) that will drive our planning forward. MASD will find ways to increase student learning and decrease student learning loss for all students, all students will have access to technology while in our schools and in their homes so that no additional learning time is ever lost again, and we will provide for all students and staff a healthy and safe place to learn and work.

Please explain the LEA(s) proposed timeline for providing services and assistance to students and staff. (3000 characters max)

MASD will begin with the purchasing of 3000 Chromebooks in April of 2021. This will assure that

as the school year begins in August all students will have a working device to be used both remotely and within the school. During June, July and August of 2021 all Chromebooks will be set up for student learning. Distribution of the Chromebooks will take place during the first two weeks of the school year. We will in April of 2021 start and complete by June 2021 the Heat Pump Control Replacement at Francis McClure. This will provide better ventilation and control of air flow within the school. Beginning in July of 2021 and again in July of 2022 and continuing into each of the respective school years, MASD will renew all necessary software maintenance agreements and support agreements to ensure that the technology necessary for instruction and school operation is current and functional. MASD will also renew all licensing agreements and internet agreements related to technology that allows for student learning, staff teaching, staff student management, administrative management and parent information and communication. MASD will purchase 90 high end desk top computers to be utilized in our High School CTC Engineering, Graphic Design and Business programs. This will allow students to have access to and utilize the software that will allow them to become more prepared for life after graduation. We will also renew our agreement with Edmentum to provide High School online courseware for all 9th-12th grade students. For both the 2021-2022 and the 2022-2023 school years, MASD will create learning environments with smaller class sizes and more effective remote learning opportunities for all students. To accomplish this MASD will utilize ESSER II funds to pay for teaching staff that may otherwise be eliminated and pay for newly created teaching positions. Smaller class sizes as well as remote learning opportunities will allow for social distancing between students and increase opportunities for individual remediation strategies to address individual learning needs. MASD will also utilize ESSER II funds to provide student support services for both the 2021-2022 and the 2022-2023 school years. These services include guidance counselors, police officers, school psychologist and nurses. MASD will also continue to have a Pandemic Team that addresses all issues regarding the Pandemic. The ESSER II funds will pay for 35% of the Pandemic Team Coordinator and 35% of the Pandemic Team member's salary and benefits for both the 2021-2022 and the 2022-2023 school year. Beginning in September of 2021 and continuing through December of 2022 we will replace our outdated interactive white boards with new and updated types. This replacement will allow for more student engagement and interaction for both students within the classroom and students learning at home. We will also look at other hardware such as phones that may be outdated and replace those items.

Please explain the extent to which the LEA intends to use ESSER II funds to promote remote learning. (3000 characters max)

MASD intends to use ESSER II funds in various ways to promote remote learning. We intend to have two types of remote learning. Full time remote learning and remote learning in the event there is a need for a school closure. Full time remote learning will occur in both a synchronous and an asynchronous way. All remote learners must have the ability to connect to supportive and knowledgeable staff members, a rigorous research-based curriculum, and the technology that they need to become better situated for remote learning. Specifically, the ESSER II funds will be used to hire four full time online teachers and five teachers who will work part time in the online program. Chromebooks will be purchased for all students as well as the district will renew all necessary software maintenance agreements and support agreements to ensure that the technology necessary for instruction is current and functional. The newly hired staff will work over the summer with the building level teams to make sure that the MASD Online Curriculum is aligned to the curriculum for in person learners. This curriculum alignment will allow for seamless transitions in and out of the online program. This is important for students who may need

extended periods of time out of the schools. MASD will also purchase the Edmentum Plato Courseware for 9th – 12th grade, this will assist the high school online teachers in developing engaging, rigorous assignments in an online environment. Teacher instruction for the full-time remote learners will occur both synchronously and asynchronously. Students and parents will have the option to choose how they want to be instructed, however all students will be expected to log in and complete the work. The second part of the remote learning plan is in the event of a total school closure and all students must become remote learners. All MASD teachers have been trained on Google Classroom and this is the district platform for hosting all students in a virtual environment. All teachers would be given access to the MASD Online Curriculum to utilize. This instruction will occur in a synchronous manner and all students will be expected to log in daily and complete their assigned work. MASD plans to implement counseling services for all students who are remote learners. These services will be the same that are available to students attending school in person. The counselors will work over the summer to design out this will be provided. Remote learning will continue to be accessed and modified as the needs of our students and the school district change.

Please describe how the LEA intends to assess and address student learning gaps resulting from the disruption in educational services. (3000 characters max)

MASD will address student learning gaps resulting from disruption in educational services in a variety of ways. All students Kindergarten through 12th grade have been and will continue to be assessed for learning loss and gains. We will use different types of assessments including national normed standardized tests, local assessments, state assessments, formative assessments, summative assessments, and diagnostic assessments. Results of these assessments will drive instruction and instructional changes moving forward. Our schools have implemented flexible grouping in various ways to address specific areas of need. The after-school program for Kindergarten through 8h grade has been adjusted to have a strong focus on Literacy and Math skills that may have been lost due to the disruption in educational services. MASD will also have an in-person six-week summer program that will focus on skills that students may have missed during the school closure. Also, MASD will offer all special education students that need the service an Extended School Year program. During the summer of 2021 we will review curriculum and re-align our curriculum to meet the needs of students determined by assessment results and the expectation of the PA Academic Standards. Our elementary schools will also implement an "usual review time" at the start of the new school year. This will allow all teachers extended time to review lost/missed learning standards and content missed from the previous year. MASD is also planning to reduce the number of students in each classroom next year. Smaller class sizes will allow for more individualized instruction and flexible grouping. We are also adding tutoring directly tied to classroom content, training staff to recognize early student warning signs regarding trauma and how to work with students experiencing trauma. We will be implementing new schedules and routines that will help students recover emotionally and engage in their learning more effectively. MASD recognizes that this past year has not only been traumatic on our students but their families as well. We will look to address the needs of our students and families' social and emotional challenges in a variety of ways. We will provide counseling services in school as well as offering outside agency information to help with housing, food, counseling, mental health, and basic needs for all families.

MASD's current proposed procedure to evaluate the loss of learning due to the closure of all schools started with taking a deep look at the current PA Academic Standards. The PA Academic Standards is used as a guide to remind all educators of what students should know and be able to do by the end of each grade level.MASD has used various assessments across all grade levels during the 2020-2021 school year to determine baseline academic data for all students. The results of these assessments have allowed us to focus our instruction on the skills that our students have missed and the skills they need to move forward. We have continued to use formative assessments throughout the year to make changes to instruction to better meet the needs of our students. We have also implemented some online remediation software programs that are individualized to each students' needs.MASD has continually worked on the development of our Continuity of Education plan. Our emergency response effort which is documented in this plan has changed and evolved as we have learned more about living during a pandemic and educating students during a pandemic. Initially, when MASD schools were closed a Continuity of Education Plan was written by the district leadership team and posted on the school district website as well as other social media outlets like Facebook. The original plan outlined the process for families to retrieve educational materials and resources as well as provided information about the locations families could take their children to pick up free meals. The plan still addresses that information, but it has evolved into a comprehensive plan of all aspects of student and family needs during this time. Committees were established to address five areas of the plan and these committees continue to meet regularly to modify and adapt the plan as new information becomes available. To support the vulnerable student populations and their families during the COVID-19 pandemic the school district added a tab on the school district web site with a link to a guide written by The National Child Traumatic Stress Network (NCTSN). The guide was written specifically for families to provide them with information about COVID-19 and it provides strategies and resources to deal with the stress that could result from dealing COVID-19. MASD takes the safety and health of students, staff, faculty, and the community into every decision that is made. Educating our students has always been our top prior. We will continue to work with our families to provide the students' academic materials and resources, mental health services and food. Whether school is held face to face or online we will continue to monitor the progress of the students and adjust the instructional plan as needed.

ESSER II funding will be utilized in several ways to increase student learning and decrease student learning loss. During the summer of 2020 and moving into the 2020-2021 school year MASD began to establish a long-term plan for instruction that included learning both in school and remotely. Teachers have worked during the 2020-2021 school year to develop and align curriculum that can be taught both in school and remotely for all students. This curriculum addresses activities to decrease learning loss and move students forward. Moving into the 2021-2022 this curriculum alignment will be for both in school students and remote learners. During the 2020-2021 school year remote learners used exclusively an asynchronous learning program. With ESSER II money, MASD will provide both an asynchronous and synchronous learning program aligned to the district curriculum for all students. MASD has continually evaluated the remote learning that is occurring throughout the 2020-2021 school year. Policies and procedures were established throughout this school year regarding online learning. As issues arose and concerns expressed the administrative team and teachers worked together to resolve as many problems as possible. Larger issues and systematic changes will take place over the summer of 2021 and be implemented for the 2021-2022 school year. The second activity that ESSER II funding will assist with is allowing all students access to technology while in our schools and in their homes. Never again do we want our students not to be able to access instruction regardless of location or circumstance. The ESSER II funding will help pay to have a variety of technologies, including software, hardware, and support services in place and functional every day so that in the event that we must close the schools, learning will not stop. Finally, our schools must be safe and a free of health concerns so that the students can learn, and the staff can teach. A major component that we are addressing during the 2021-2022 and then into the 2022-2023 school year is the social and emotional issues that are occurring in our students because of the pandemic. We have and will continue to train our counselors on recognizing and helping students who have experienced trauma due to the pandemic. Additionally, ESSER II will help pay for staffing to continue this important service for our students. We also have a Pandemic Team that has the responsibility to lead the development and implementation of the district-wide Health and Safety Plan. This plan looks at the immediate needs of the district as well as the future needs of MASD so that we can continue providing high quality rigorous education for all students.

Please describe specific plans, measures, and longer-term evaluative strategies concerning student learning gaps - as well as opportunity to learn factors - stemming from COVID-19. (3000 characters max)

MASD is in the process of developing several specific plans concerning student learning gaps. Plans being established are primary (K – 2nd grade), intermediate (3rd – 5th grade), middle level (6th – 8th) and a plan for each content area at the high school. The primary and intermediate level plans will be an expansion of the schools' schoolwide plans. The team consist of administrators, teachers, parents and academic coaches. Areas to be examined are assessment data, curriculum realignment ideas, flexible grouping, class sizes, scheduling changes, staffing changes and student learning objectives. The plan will include year-long (2021-2022 school year) evaluation strategies concerning student learning gaps. The evaluation will look at baseline student data from September of 2021 using Acadience Reading and Math assessment scores, PSSA scores and other assessments that will be determined by the team this summer. Teachers will be expected to do formative assessments continually and report individual student results to the team during morning meetings throughout the year. The team will evaluate the baseline data against the mid-year and end of the year data to determine successes and areas of need. The team will meet continually throughout the year and during the summer of 2022 to make changes

to the plans based on data for the 2022-2023 school year. The middle level team will use their existing CSI Plan to evaluate the areas of need for Founders' Hall Middle School. The team has already established a method of evaluation and will continue to follow this plan. The team currently looks at areas of need and has implemented strategies to address student learning loss. The team currently looks at PSSA data, CDT data, ExactPath data and classroom formative and summative assessments to determine changes that need to occur. The team will meet this summer to implement changes to scheduling and curriculum to better meet the needs of their students. The team will continue to evaluate data and make necessary changes as new information becomes available. The high school plan will be divided into sub parts based on the departments (English, Math, Social Studies, Science, Foreign Languages, and CTE) at the high school. The high school principal will lead this initiative and make sure all departments are making decisions based on data. All departments will meet during the summer of 2021 to develop their sub-plan. Each sub-plan will measure what was taught this year (2020-2021), what was not taught due to school closures and what content will need to be added to next years curriculum. Each team will use data to realign their curriculum to allow for leaning loss to be made up in the next school year. The teachers will use formative and summative data to assess how students are regaining knowledge and skills. During the summer of 2022, the team will meet again to realign the curriculum for the 2022-2023 school year to address any new or remaining need.
