
Pregnant and Parenting Students Welcome Packet



The Bakersfield City School District (BCSD) is committed to equal opportunity for all individuals in education and in employment. BCSD prohibits discrimination, harassment, intimidation, and bullying in any employment practice, education program, or educational activity on the basis and/or association with a person or group with one or more of these actual or perceived characteristics of age, ethnicity or race, which is inclusive of traits historically associated with race, including but not limited to, hair texture and protective hairstyles, such as braids, locks, and twists, color, ancestry, nationality, national origin, immigration status, ethnic group identifications, religion, pregnancy, marital status, parental status, physical disability, mental disability, sex (including sexual harassment), sexual orientation, gender, gender identity, gender expression, medical information, genetic information, homelessness, foster status, military veteran status, political affiliation or any other basis prohibited by California state and federal nondiscrimination laws consistent with Education Code 200, 220 and 234.1, Penal Code 422.55, Government Code 11135, and Title IX. Not all bases of discrimination will apply to both education services and employment. If you believe you, or your student, have been subjected to discrimination, harassment, intimidation, or bullying you should contact your school site principal and/or the District's Chief Compliance and Title IX. Background

Married, Pregnant, and Parenting Students

Early marriage, pregnancy, or parenting may disrupt a student's education and increase the chances of a student dropping out of school. Bakersfield City School District desires to support married, pregnant, and parenting students to continue their education, to attain strong academic and parenting skills, and to promote the healthy development of their children.

Education codes, Laws, and Policies are in effect to ensure that married, pregnant, and parenting students are fully supported. EC §§ 221.51, 222, 222.5, 46015.

Know Your Educational Rights

Right to Access to Education

- Married, expectant, and parenting students shall have the same educational and extracurricular opportunities as all students.
- The District does not exclude or deny any student from any educational program or activity solely on the basis of pregnancy, childbirth, false pregnancy, termination of pregnancy, or recovery there from and shall treat these conditions in the same manner and under the same policies as any other temporary disabling condition.
- For school-related purposes, married students under the age of 18 are emancipated minors and have all the rights and privileges of students who are 18, even if the marriage has been dissolved.

Know Your Educational Rights

Right to Enrollment and Participation

- A student may elect to attend an alternative education option instead of returning to the school in which he or she was enrolled prior to parental leave.
- Participation in special programs or schools shall be voluntary and shall be equal to the regular program.

Right to Parental Leave

- A pregnant or parenting student is entitled to 8 weeks of parental leave, or additional leave if deemed medically necessary by the student's physician.
- During parental leave, absences shall be excused and the pupil shall not be required to complete academic work or other school requirements.
- After returning from parental leave, a student may resume the course of study in which he/she was previously enrolled and is entitled to make up work missed.

Right to a Safe School Climate

- Pregnant and parenting students have the right to attend school in an environment free from discrimination, harassment, intimidation or bullying. School site leadership and all school personnel should work collaboratively with school community stakeholders to create and maintain a school culture where students feel welcome, safe, and respected.
- A pregnant or parenting student will not be treated differently based on pupil's potential parental, family, or martial status that treats pupil differently on the basis of sex.
- Pregnant and parenting students have the right to privacy. Schools cannot draw public attention or reveal a pupil's pregnancy without their permission.

Know Your Educational Rights (cont.)

Right to Accommodations During Pregnancy

Reasonable adjustments, implemented on a case-by-case basis, might include, but are not limited to:

- Developing a 504 plan to discuss accommodations to support the pregnant or parenting student
- Allowing the pregnant student to participate in classes and extracurricular activities including honor classes, school clubs, sports, student leadership opportunities and other school related activities
- Give the student the choice to participate in special instructional programs or classes for pregnant students
 - Students can participate if they want to, but cannot be pressured to do so by the school
- Provide reasonable *adjustments*, like a larger desk or allowing the student to make frequent trips to the restroom, when necessary because of the pregnancy

Right to Accomodations After Pregnancy

Schools shall provide reasonable accommodations to a lactating student on a school campus to express breast milk, breast-feed an infant child, or address other needs related to breastfeeding. School sites with at least one lactating pupil shall provide the reasonable accommodations specified below. School sites may use an existing facility. Reasonable adjustments, implemented on a case-by-case basis, might include, but are not limited to:

- Access to a private and secure room, other than a restroom, to express breast milk or breastfeed an infant child
- Permission to bring onto a school campus a breast pump and any other equipment used to express breast milk
- Access to a power source for a breast pump or any other equipment used to express breast milk
- Access to a place to store expressed breast milk safely
- A lactating pupil shall be provided a reasonable amount of time to accommodate her need to express breast milk or breastfeed an infant child
- Student shall not be given academic penalties, as a result of their use of accommodations during the school day, and shall be provided the opportunity to make up any work missed due to such use

Know Your Educational Rights (cont.)

Right to Attendance Accommodations

Reasonable adjustments, implemented on a case-by-case basis, might include, but are not limited to:

- Parental Leave
- Excusing absences due to pregnancy or childbirth, for as long as your doctor says it is necessary
- Allowing student to return to the same academic and extracurricular status as before the medical leave began, which should include giving the student the opportunity to make up any work missed while the student was out
- Ensure that teachers understand the Title IX requirements related to excused absences/medical leave
 - Teachers may not refuse to allow student to submit work after a deadline missed because of pregnancy or childbirth
 - If a teacher's grading is based in part on class participation or attendance and student missed class because of pregnancy or childbirth, student should be allowed to make up the participation or attendance credits
- Provide pregnant students with the same special services it provides to students with temporary medical conditions; this includes home instruction or independent study

Right to Campus Accommodations

School staff shall make reasonable adjustments to facilitate the full participation of pregnant and parenting students in all school programs and activities. Reasonable adjustments, implemented on a case-by-case basis, might include, but are not limited to:

- Providing passes for bathroom use as needed
- Scheduling classes in more accessible locations when possible
- Providing additional time for class changes
- Providing alternative activities in physical education programs when requested by the student and her medical provider
- Making allowances and arrangements, such as reduced schedule of classes or student contracts – as would be done for students with other medical conditions that prohibit full-day school participation
- Arranging for an independent study program when a student is absent because of pregnancy or while recovering from childbirth, if the student's health permits

Know Your Educational Rights (cont.)

Right to Grievance

Bakersfield City School District has a grievance procedure for addressing grievances related to discrimination/disability-related complaints.

- A complaint alleging shall be filed with the principal or designee at the school in which the complaint arises.
- The principal or designee shall forward a complaint about problems beyond his/her authority to the Superintendent or designee in a timely manner, but not to exceed 10 working days.
