Please see the attached Letter of Agreement with the Public School Employees of Stanwood-Camano outlining the process that will occur if no qualified Health Room Assistant (HRA) substitute is available. Paraeducators who are trained and available to work in the Health Room will be paid at the HRA rate of pay or their current rate of pay, whichever is higher.

This agreement is for the 2024-2025 school year only.

LETTER OF AGREEMENT

THE PURPOSE OF THIS LETTER OF AGREEMENT IS TO SET FORTH THE FOLLOWING AGREEMENT(S) BETWEEN PUBLIC SCHOOL EMPLOYEES OF WASHINGTON/SEIU LOCAL 1948 STANWOOD/CAMANO CHAPTER #1125 AND THE STANWOOD-CAMANO SCHOOL DISTRICT #401. THIS AGREEMENT IS ENTERED INTO PURSUANT TO THE CURRENT COLLECTIVE BARGAINING AGREEMENT.

The parties agree to the following:

In order to ensure adequate staffing in classrooms and programs, when an HRA substitute cannot be located in a building, the following process will be used by building/program administrators:

- By September 15th, building/program administrators will send a notice to para educators asking for two individuals to serve as emergency substitutes for the HRA position.
- These two individuals will be selected based on seniority.
- The para educators will receive training to be an emergency HRA substitute.

The para educator whose duties are reassigned to HRA on an as needed basis will receive their rate of pay or the HRA rate of pay, whichever is higher.

This Letter of Agreement shall become effective upon the signature of all parties involved and will be in effect for the 2024-2025 school year only.
