**A RESOLUTION** of the Board of Directors of the Stanwood-Camano School District No. 401, Snohomish County, Washington, certifying receipt of the approval amendment concerning the addition of the Stanwood-Camano School District to the Skills Center Consortium.

**WHEREAS**, the Board of Directors of Mukilteo School District No. 6 (hereinafter referred to as "host") and the following districts of Educational Service District No. 189 each hereinafter referred to as "participating districts" provided for the establishment and implementation of a Vocational Skills Center:

**WHEREAS**, a formal proposal was received from the Stanwood-Camano School District requesting to be admitted to the Sno-Isle TECH Skills Center Consortium,

**WHEREAS**, a quorum of the Sno-Isle TECH Skills Center Administrative Council of the Sno-Isle TECH Skills Center voted unanimously to admit the Stanwood-Camano School District No. 401 to the group of "participating districts" on October 13, 2023.

**WHEREAS**, the Sno-Isle TECH Skills Center Administrative Council determined the conditions of admission, including the required initial capital investment of \$4,000.00.

**WHEREAS**, according to the Interlocal Cooperative Agreement for Sno-Isle Technical Skills Center for 2018-28, after approval of the request by the Sno-Isle TECH Skills Center Administrative Council, an amendment to the Agreement must be approved by the boards of directors of all the Consortium Districts before the new district can become a Consortium member.

**WHEREAS**, each of the Consortium Districts has approved the amendment to the Agreement, with a copy of the approved amendment received by the host district,

**NOW, THEREFORE, IT IS HEREBY RESOLVED**, that the Board of Directors of Stanwood-Camano School District No. 401, Snohomish County, Washington, does hereby certify approval of the admission of the Stanwood-Camano School District to the Sno-Isle TECH Skills Center Consortium.
