SUBJECT: CHROMEBOOK PURCHASE

TYPE: ACTION REQUIRED

On February 13, 2018 , voters approved the School Facilities and Technology levy. Providing technology for student use was a primary purpose of the technology portion of that levy.

One of our major initiatives was to provide technology for all students by providing our student population with one to one devices. Over the past four years, we have accomplished this by providing Chromebooks for all students. As part of our plan for technology levy funds, we are committed to keeping our technology up to date. This summer, 1,087 Chromebooks will reach their Automated Update Expiration (AUE). These Chromebooks now need to be replaced as they have reached the end of their useful life expectancy for our District.

We are seeking approval to purchase 1,100 Chromebooks that will replace these devices along with a few devices that are no longer functioning. These Chromebooks will come with an AUE of June of 2027, which will allow us to keep them in use for up to six years.

Recommendation:

We recommend the board move to approve payments totaling \$327,927.60 for the purchase of 1,100 Chromebooks.
