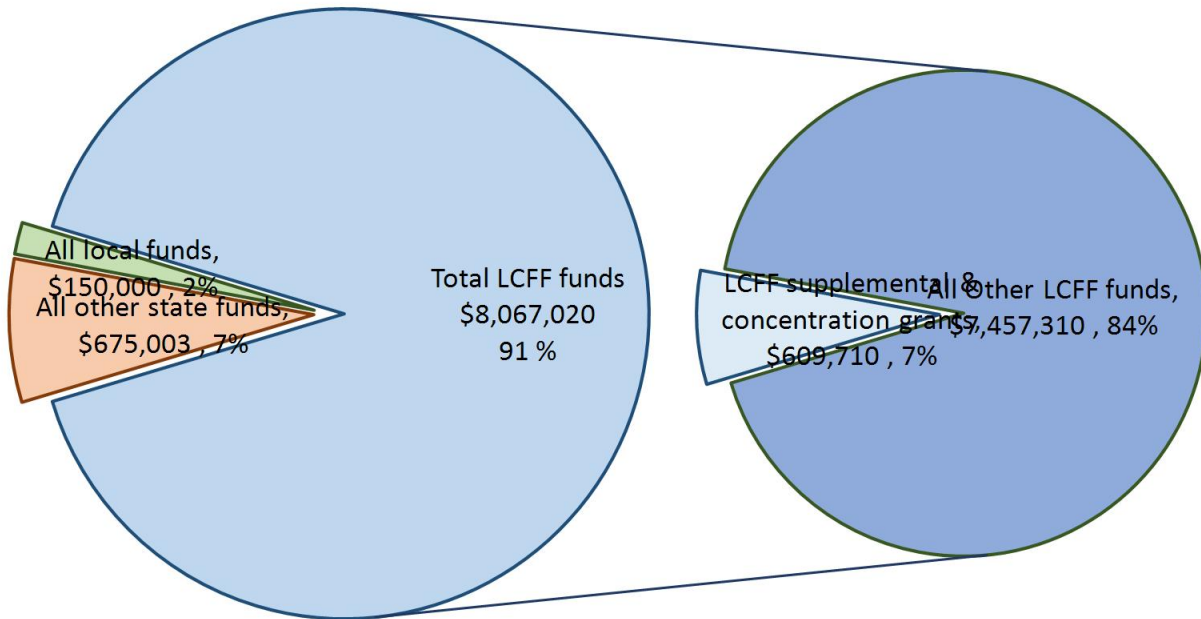

Projected Revenue by Fund Source

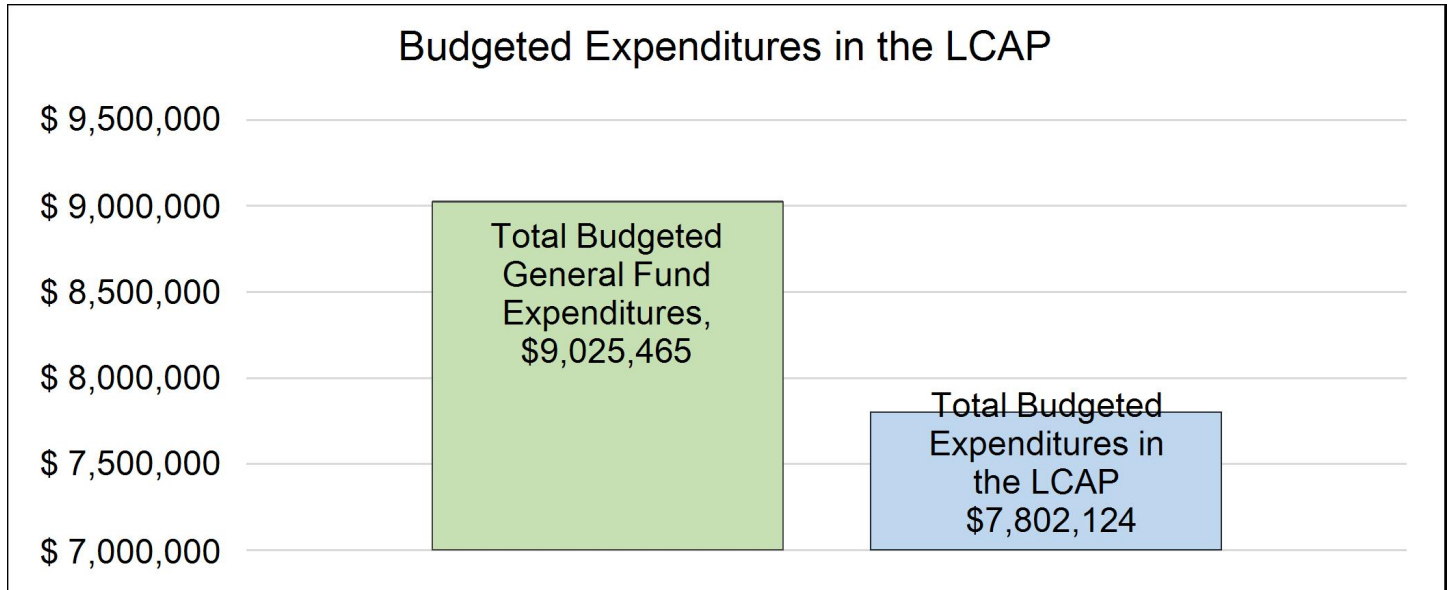


This chart shows the total general purpose revenue Natomas Pacific Pathways Prep High School expects to receive in the coming year from all sources.

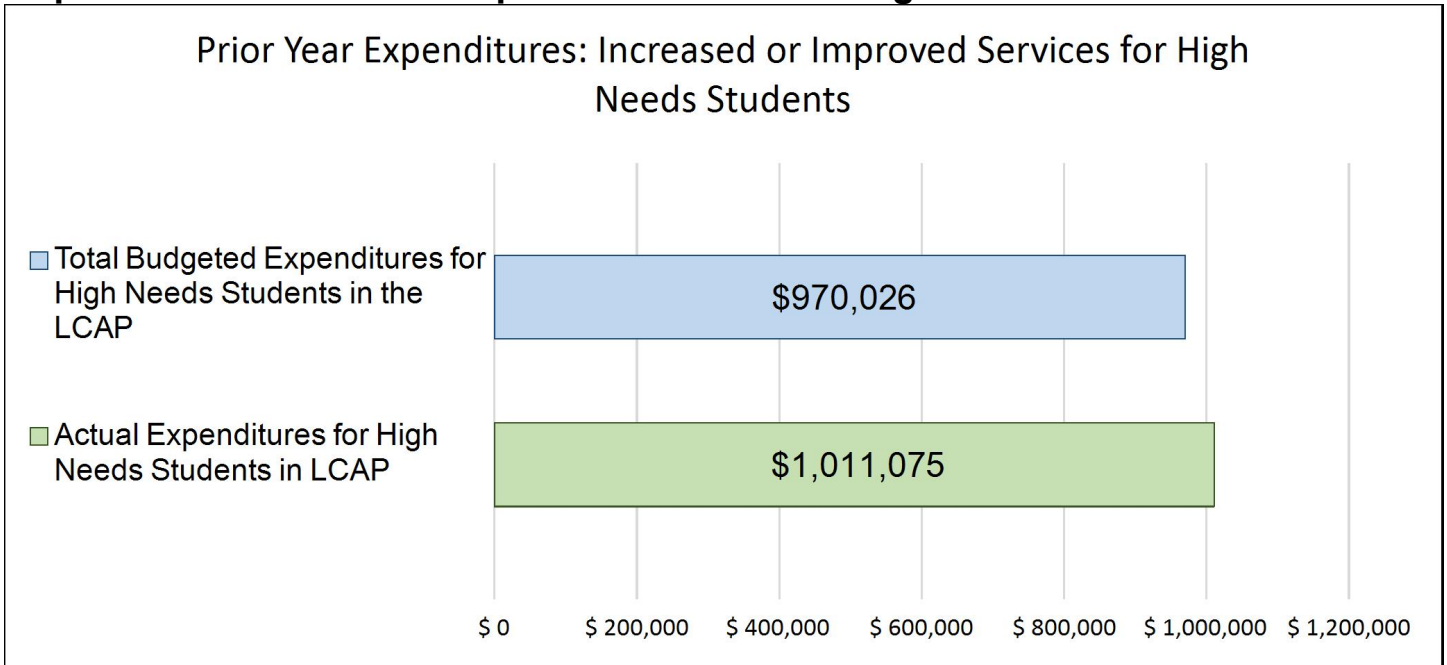

Plan Summary [2024-25]

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

The Natomas Pacific Pathways Preparatory High School (NP3 High) is a charter school authorized by the Natomas Unified School District. The School serves approximately 620 students. Seven of 10 NP3 High School students reside in the Natomas Unified School District’s boundaries, with the remaining coming from outside of the area. The School’s unduplicated pupils comprise 41% of the School’s student body population. NP3 High promotes students who are thoughtful, prepared, and engaged citizens. The School emphasizes conceptual understanding, and teaches the Common Core State Standards through year-long themes. The School focus on understanding, evaluating, and creating with the goal of providing our children the tools for citizenship and life. NP3 High was recently recognized as a Gold Ribbon School, and received the Civic Learning Award for Excellence.

Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

There are 535 Charter High Schools in California, 65 are very diverse - with at least 7 different student groups receiving a rating on the College/Career Indicator, NP3 has the 2nd Highest average score among all of those districts with 6 of 7 groups receiving a BLUE rating and 85% of graduates prepared for college/career. With 77% students meeting state standards in English Language Arts and 46% meeting math standards, NP3's performance is well above California's performance of 55% and 27%.

On the Ca School Dashboard, NP3 received a BLUE rating for the graduation rate and 5 purple bars for College/Career Readiness. Additionally, a GREEN rating for ELA achievement, YELLOW rating on Math, and ORANGE ratings on EL Progress and Suspension Rates. When looking at graduates, 98% had at least a 3.0 GPA, 113 earned the Golden Sate Seal of Merit, 93 earned the California State Seal of Civic Engagement, 23 earned the California State Seal of Biliteracy, 2 completed the AP Capstone program, and 80% went to college.

Among 29 similar high schools in California that are Charter Schools with an enrollment lower than 2,000 and an unduplicated rate between 30% and 55%, NP3 ranks 1st on the California School Dashboard for EL Progress, Grad Rate, and College Career Indicator.

Preparing students for their future is a core component of the NP3 K-12 continuum. NP3 graduation requirements are closely aligned to the UC “a-g” requirements which enables nearly all of our students to graduate prepared for college. The focus on civics and law coupled with a rigorous curriculum set NP3 apart from traditional high schools. In creating a law-themed curriculum and college preparatory charter, the administration and core teaching staff researched the skills necessary to achieve success in a college environment. After meeting with university professors and deans, it became evident that students must engage in critical thinking, write frequently, and build literacy skills.

The field of law lends itself well to these stated objectives. In addition, the staff used data and research that demonstrates the decaying civic values among youth. In an article entitled, “The Civic Achievement Gap,” Meira Levinson discusses a gap in civic achievement between students of different races and socio-economic classes. She indicates that poor, non-white students demonstrate lower levels of political knowledge and civic participation than white students. With this information, it became clear that our community could benefit from law-related educational programs that stress literacy and civic education. Our student body is highly diverse and nearly half of our population receives free or reduced lunch. Our student body represents the groups that are traditionally not involved in civic activities.

- **5. Total Planned Percentage of Improved Services (%)**

- This amount is the total of the Planned Percentage of Improved Services column.

- **8. Total Estimated Actual Percentage of Improved Services (%)**

- This amount is the total of the Estimated Actual Percentage of Improved Services column.

- **Difference Between Planned and Estimated Actual Percentage of Improved Services (Subtract 5 from 8)**

- This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8).

LCFF Carryover Table

- **10. Total Percentage to Increase or Improve Services for the Current School Year (6 divided by 9 plus Carryover %)**

- This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover – Percentage from the prior year.
- **11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)**
 - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
