

College Credit Plus Student/Family Guide

The College Credit Plus (CCP) Programs provides students opportunities to earn college and high school credit at the same time. CCP courses are rigorous, and the tuition, fees, and books are paid by the district if the guidelines below are met.

Eligibility

- Students in grades 7-12 are eligible to take CCP courses.
- Students must submit a **College Credit Plus Intent to Participate** form annually by April 1st prior to the CCP program participation school year.
- Students must meet the college requirements for any CCP course(s) they want to enroll in. Please contact a Great Oaks counselor for more details regarding college course requirements.
- Students must complete a **College Credit Plus Counseling** form each year prior to the start of CCP course(s).
- Students cannot exceed a combined 30 hours of high school and college courses each school year.

Formula for calculating credits: (High school credits x 3) + CCP credit hours must be less than 30 total credits

Costs

- Tuition costs for college credit hours beyond the combined allowable 30 hours per school year are the responsibility of the student/family.
- Students who withdrawal after the course withdrawal date and/or fail a course(s) may be financially responsible for the tuition, fees, and textbook(s) associated with the course(s).

Note: Failed or withdrawn classes with an “F” (or equivalent failing grade) will receive an “F” on high school and college transcripts. The “F” will be computed into the high school and college GPA.

Underperforming and Ineligible Students

- Underperforming students are defined as:
 - Failure to maintain a grade point average of 2.0 or higher in the college; or
 - Withdrawing from or receiving no credit for two (2) or more courses in the same term.
- If a student maintains underperforming student status for two (2) consecutive terms of enrollment, the student is deemed *ineligible* to enroll in CCP courses.

Probation

- Underperforming students are placed on probation within the CCP program.
- Students on probation:
 - Can only enroll in one (1) college course during any term.
 - Cannot retake a college course in which they earned a grade of “D”, “F” or earned no credit.
 - Must request the college to unenroll them from the course(s) that conflict with the terms of the student's probationary status if registered for more than one college course for the next term prior to being placed on probation.
- If the student fails to unenroll from any courses that conflict with the student's probationary status, the student's family assumes responsibility for tuition, fees, and textbooks. The student is deemed ineligible (dismissed) to participate in CCP next term.

- Students will be removed from probation if they enroll in and successfully complete a CCP course that raises their cumulative grade point average to 2.0 or higher. The student may participate in the program without restrictions unless the student is declared to be underperforming again.

Dismissal

- Students deemed ineligible to participate in the CCP program will be dismissed from the program.
- Students will be dismissed from the program if they enroll in a course after being placed on probation and the CCP course grade does not raise the cumulative grade point average to 2.0 or higher.
- Students who are dismissed from the CCP program must request to be unenrolled from any college courses in the upcoming term.
 - If a dismissed student fails to unenroll from college course(s), their dismissal from the program will be extended/continue for an additional term.
