

Budget Overview for the 2024-25 School Year Projected Revenue by Fund Source

Breakdown of Total LCFF Funds





These charts show the total general purpose revenue California Montessori Project - Elk Grove Campus expects to receive in the coming year from all sources.

The total revenue projected for California Montessori Project - Elk Grove Campus is \$8,139,779, of which \$6,317,996 is Local Control Funding Formula (LCFF), \$1,288,024 is other state funds, \$364,662 is local funds, and \$169,097 is federal funds. Of the \$6,317,996 in LCFF Funds, \$322,574 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

The LCFF gives school districts more flexibility in deciding how to use state funds. In exchange, school districts must work with parents, educators, students, and the community to develop a Local Control and Accountability Plan (LCAP) that shows how they will use funds to serve students.

California Montessori Project - Elk Grove Campus plans to spend \$7,976,921 for the 2024-25 school year. Of that amount, \$7,451,613 is tied to actions/services in the LCAP and \$525,308 is not included in the LCAP. 

Plan Summary 2024-25

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

The Mission of the California Montessori Project is to offer a quality, tuition-free Montessori Education that challenges our students to reach their full potential. The Vision of the California Montessori Project is to provide a Montessori education that supports the intellectual, social and emotional development of every child. This will be achieved by: * Promoting independence * Teaching respect for oneself and others * Building confidence * Creating a sense of social responsibility, and * Empowering every student to be a global citizen. CMP offers an environment which has the programs, resources and school climate to enable students to become educated to high academic standards and to develop themselves to their fullest capacity as competent, happy, productive individuals, family members,

workers, and contributors to a better society and a peaceful world. This mission is achieved through the dedication and commitment of the CMP Learning Community: parents, teachers, community groups, the legislature, CMP Governing Board, Campus Advisory Committee (CAC), and, most importantly, the individual child. CMP is committed to small class size, highly-qualified Teaching Assistants and highly-qualified, dual-certified Teachers (California Teacher Credential and age appropriate Montessori Certification) in every class. The CMP-Elk Grove Campus is comprised of two sites. The original facility located on Elk Grove Blvd is a former public school campus leased through the Cosumnes Community Services District. The facility houses an office and six traditional classrooms. This site serves students in Transitional Kindergarten thru 3rd grade. The school grounds include a spacious field, a playground, and a large asphalt play area with a basketball court. The second facility is located just 2.2 miles from the original site on Bradshaw Road. Ten acres of land houses school offices, 16 classrooms, a library/Club M room, Learning Center and a large multipurpose room. This site serves students in Transitional Kindergarten thru 8th grade. The school grounds include a separate Kindergarten play area, a large asphalt play area, and a large play field. Custodial and maintenance services are provided in the late afternoon and evening through contractual services and parent volunteers. CMP-Elk Grove Campus serves students in Transitional Kindergarten through Eighth Grade. As a public charter school, there is an open enrollment policy.

Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

California Montessori Project (CMP) saw some success with overall academics. CMP-Elk Grove was in the Orange category for both Suspensions and Chronic Absenteeism and the Yellow category for both English Language Arts and Math, CMP students with Two or More Races saw growth in both Math and ELA and Students with Disabilities saw an increase in Math. CMP implemented a new, evidence-based, Tier 1, Science of Reading early literacy program in 2022/23. This program has already shown strong results with students. In 2023/24 CMP implemented new, more rigorous, grade level and standards aligned math practices. On our internal assessments CMP saw greater growth in math than we have ever seen previously. CMP will seek further improvement by continuing its work with its dedicated math committee to ensure that all students received high quality grade level and standards aligned math instruction every day, maintaining its focus on evidence based early literacy instruction, and maintaining its committment to high-quality Tier 1 instruction. CMP-Elk Grove received an orange status (low performance in this category) overall for chronic absenteism. CMP-Elk Grove recognizes the need to focus on chronic absenteeism and, because of this, CMP enhanced its efforts this school year by launching an attendance campaign to encourage students to come to school more regularly and to debunk attendance myths throughout the community. CMP-Elk Grove received an orange status overall for Suspension Rate for the overall population. To make progress on suspensions and student behavior, CMP re-established the Positive Behavioral Inverventions and Supports system (an evidence-based framework for supporting students' behavioral, academic, social, emotionial and mental health need) that had become dormant after the pandemic, CMP also partnered with Sacramento State University for professional development in diversity, equity and inclusion training. This resulted in the drafting of a network-wide 'Acceptance, Belonging and Care' Statement.

Reflections: Technical Assistance

Under the Every Student Succeeds Act (ESSA), CMP-Elk Grove qualified for Additional Targeted Support Identification (ATSI) using Criteria 2: Schools with a student group(s) with all indicators at the lowest status level but one indicator at another status level. The ATSI qualification is based on indicator results shown on the CA School Dashboard. At CMP-Elk Grove, the 'Students with Disabilities' student group showed the following results on the CA School Dashboard: * Chronic Absenteeism - Orange (Low) * Suspension - Orange (Low) * Academic English Language Arts - Yellow (Medium) * Academic Math - Yellow (Medium) CMP will provide additional supports to the 'Students with Disability' student group, particularly surrounding absenteeism and suspension. Chronic Absenteeism: All students had higher than usual chronic absenteeism rates than they have had historically. This is attributable to the effects of the pandemic, the requirement to isolate and guarantine, and families being more cautious about sending students to school with cold symptoms. CMP conducted a robust student attendance campaign to encourage stronger student attendance. CMP plans to continue efforts to bring students back to school on a more regular basis. Suspension: CMP-Elk Grove had a "red" suspension rate, 8%, for the student group "Students with Disabilities". CMP-Elk Grove intends to continue with the efforts to restore the schoolwide Positive Behavior and Intervention Support system, build upon efforts this year to implement more robust restorative practices, and more deeply integrate the social emotional curriculum into classroom practices.

The California Montessori Project - Elk Grove Campus has provided numerous opportunities for stakeholder engagement, as part of the greater California Montessori Project (CMP), as well as an individual charter school within the Elk Grove Unified School District (EGUSD). Members of the CMP Learning Community, as well as the public-at-large, have been invited to attend monthly meetings of the CMP Governing Board, and to provide input regarding the creation and implementation of the Strategic Plan and Local Control Accountability Plans (LCAP). During the month of April, CMP's Superintendent, Brett Barley, met with 4 distinct groups of educational partners at each site, to receive input. Members of the community (including parent/guardians, credentialed staff, classified staff and students) were invited to meetings where the LCAP, and Strategic Plan goals and action steps were shared. Educational Partners were asked to help prioritize goals for the following year. Following the meeting, a survey was sent to Educational Partners giving an additional opportunity to provide input. Feedback was also solicited from the SELPA, ELAC, and the entire community at the May Board Meeting through a public hearing. Input from the Educational Partner meetings and the survey input was reviewed for common threads. Considerations of fiscal impact and timeline were considered when reviewing this input. Survey respondents encouraged CMP to continue focusing on the following: * Maintain a low student to teacher ratio. Commit to maintaining a Credentialed, Montessori Trained teacher as well as a trained Teaching Assistant in every classroom, lowering the overall student to adult ratio.
