#### VIII. COMMENTS FROM THE PUBLIC

Citizens are invited to make comments regarding agenda items and are limited to three minutes, according to the Pascack Valley Regional High School District Board of Education policy number 0167. Persons wishing to speak must, upon being recognized, rise, sign in and state their name, town of residence, and which agenda item(s) they are referencing.

Michael Fox of Hillsdale mentioned a letter sent to the Board regarding midterms and finals. He indicated that he met with Dr. Bachenheimer, Ms. Graziano and Dr. Russo on January 9, 2024 and he asked for data on student averages before and after midterms. He followed up with emails in January and February and received no response which he said is unprofessional. He referenced Dr. Bachenheimer's presentation citing that if a student does not do well it will not hurt them badly. He commented that Dr. Bachemheimer referenced data that students do not see any major change. This data was not provided. Mr. Fox mentioned that Dr. Bachenheimer's team did a deep dive in obtaining student feedback, but nothing has been presented and no one he spoke to was not consulted. He referenced a slide in the presentation indicating that midterms and finals would not exceed 7.5% of the total grade and another slide indicating that it is 5-7%. Mr. Fox said that he has multiple syllabus indicating that the effect is 7.5% for the midterm and 7.5% for the final for a total of 15%. He mentioned that some courses did not indicate the weight of those exams. He commented that science and math have other assessments such as benchmarks, Linkit, testing, and NJSLA scores, so why are midterms and finals necessary. He said Dr. Bachenheimer claimed that colleges give midterms and finals, but there is no data to support it. He commented that colleges do not give exams on five months and 10 months worth of material. He said feedback from students after the finals is too late since the year is done. He asked Ms. Bilotti to

pause the exams for the 24-25 year since they negatively impact the regional students. He mentioned that Bergen Academies, Ridgewood, Northern Valley, and Cresskill do not administer these exams which harm GPAs. He said the students are at a disadvantage as they compete against other students for college acceptance and merit money. He asked the Board to look into this matter as they are responsible to look after the best interest of students. Gerod Dogan of Hillsdale whose children attended Pascack Valley. He said overall he was happy with the education his children received. He said it was a credit to all. He commented that midterms and finals were something that he and others grew up taking. He believes things have changed. He has heard his youngest and his friends talk about their concerns with grades, GPA clubs, the rigor of the classes (AP and honors), SAT, college prep, sports, volunteerism, and holding down jobs. He indicated that the college applications have changed since he applied. He commented that the process is brutal. He mentioned that many colleges are test optional and GPAs have become the main factor, so students may be separated by a tenth of a point. He indicated that this is fine if it's a level playing field. He said that the district cannot control what others do, but can control what is done in the district. He commented that his son would get anxious when midterms and finals were approaching and he normally is not anxious. He said as a former law enforcement officer, it's important to follow best practices and it does not appear that it's being followed here. It has put the students at a disadvantage where they are unable to go to their dream school or receive scholarships.

#### XIV. OLD BUSINESS

Monthly Suspension Report (attached)

Mrs. Martin shared the concerns of Mr. Fox and Mr. Dorgan over midterms and finals. She asked about the uptick in the Wellness Center and the additional tutoring at this time of year. She agreed that colleges do not ask students to memorize things from 10 months, it's a semester. She indicated that in the last three years the district has done better preparing students. She mentioned that her son did not have review packets or answer keys. She commented that she does not know if we're moving in the right direction because that is the way we did it. She added she would like to see the impact on wellness.

Ms. Stephans said she is in agreement with Mrs. Martin and she would like to see more data. She indicated that she would like to see the difference between the assessment of the midterm and the final.

Mr. Stankus said that midterms and finals are important. He said as an AP instructor there is an exam that summarizes the entire course. He said it's like a college course. He indicated that the AP finals mimic what is going on in colleges. He commented that colleges are going back to standardized tests as a measurement for admission. He believes midterms and finals are

necessary, but to take a look at the weighting of them and the impact. He said to abandon them would put our students at a disadvantage. He indicated that his children have benefited because it mimicked what they are doing in college.

Mr. Weaver said he would like to know the accuracy of what has been stated. He hopes that the messaging is consistent throughout all grades and departments. He commented that the issue doesn't sound like it's the finals rather it's the scheduling. It's the crush at one time when there are three exams in one day or assessments. Also how that affects wellness. He indicated that the district needs to do a better job of communicating and scheduling assessments, so students are not bombarded.

Mrs. Martin said as educators the use of assessments helps to improve/tweak instruction. She said something needs to be done when 50% of the students fail an assessment and there needs to be a huge curve. The use of the curve to push students through is not a solution. She said most kids need to be successful in the tests.

Mrs. Varghese commented that it shouldn't be about the name of the assessment which creates stress. There should be instruction and the assessment with results. If there is a curve does it mean the kids did not understand the way it is taught or the teacher did not connect with the students. She added that the data will provide the reason(s).

Mr. Stankus commented that the AP exam does it the right way. He indicated that at the start of an AP course, students are presented with a sample exam and given a breakdown of any weighting. This allows students what they can expect. He said finals are not about cramming the night before, it's a learning process of the course throughout the year.

Mr. Weaver commented that we think we're preparing students for college when it does not exist in college. It is to have the understanding of what is expected at the next level. He mentioned that we're too quick to say we're preparing students for the next thing, but the students are not there. However, we need to be mindful of where they are developmentally.

Ms. Stephans agreed with Mr. weaver. She indicated that we didn't spend eight hours a day in college classes. She said there was more time to prepare and study for midterms and finals. She indicated that AP is different from honors or CP classes.

Ms. Bilotti mentioned that the administration has been looking into this. She commented that a final report will be produced and shared with the Board.

Mrs. Martin asked if they could get more information on wellness visits, case managers, guidance counselors, and absences. She commented that students are getting sick and staying home or they feel like they need to stay home to prepare for the exams.

Mr. Weaver indicated that his kids want to go in late so they may study.

Ms. Bilotti confirmed that finals will be given this year. She said adjustments have been made over the last two years and the final exam schedule has been adjusted based on feedback. They are looking into how to use assessments.

Mrs. Martin understood that finals are occurring earlier in an effort for students to review their finals.

Ms. Bilotti indicated that finals may not occur as early as in the future. She mentioned that there will be a feedback day and they will look at how they re-structured extra help to see if there is an opportunity to help students with that function. She reminded everyone that the final exam period is only science and math and the other classes are giving end of the year assessments. Mrs. Varghese said she would like to see the data after finals and that math and science can be very intimidating for students.

Mr. Weaver indicated that for the sake of time he will share with the administration the theater, Hills softball field and the climate survey. He gave his thanks and disappointment that PV athletic director will be leaving. He said through his volunteer work, Mr. Spafford is one of the most respected AD in the county and state. He shared that he has heard from members of the

communities. It's an unfortunate loss to the district. He thanked Mr. Spafford and wished him luck in the future.

Ms. Stephans asked if course evaluations could be mandatory.

Ms. Bilotti mentioned that Dr. Bachenheimer conferred with the supervisors about course evaluations. They are discussing how to receive the feedback and see a sample. She would like to see a highlight reel of anonymous comments that highlights their favorite part of the year or their biggest takeaway. She said they are looking at it as optional at this time.

Mrs. Varghese said if the district was a different entity then customer feedback would be sought. She believes the information would be valuable for improvement and she would like to see it become mandatory.

## XV. NEW BUSINESS

Mr. Usami mentioned that the NJ School Boards Association Workshop will begin on October 21 to October 24. He indicated that this was in the Briefing and he will need to know if anyone is interested in attending and for how many nights.

#### XVI. COMMENTS FROM THE PUBLIC

Citizens are invited to make comments and are limited to three minutes, according to the Pascack Valley Regional High School District Board of Education policy number 0167. Persons wishing to speak must, upon being recognized, rise, sign in and state their name and town of residence. Deb Horn of Belleville and president of the PVREA for the past eight years commented that she is stepping down and Maria Hinrichsen will be president and Matt Will will be vice president. She expressed her gratitude. She mentioned that she presided over some of the most tumultuous years in the district. She saw three superintendents, a total change in building administration, a pandemic, and divisive mascot change. She said she is proud to work at Pascack Valley Regional and to have served her fellow teachers. She indicated that she has heard horror stories in other districts and she is lucky to be part of this district. She said the reason is that we treat each other with dignity and respect. She commented that they have discussed rather than involve lawyers, as president she praised the Board, and she added the mutual respect and trust among the Board and superintendent and the teachers. She added that one should never bad mouth someone in public and never blindside anyone. She said she has been fortunate to work with a strong and thoughtful administration and Board that shares the understanding of how to work together with mutual understanding and respect..

# XVII. ADJOURNMENT

A motion was made by Mr. Stankus to adjourn the public meeting at 10:19 p.m. Ms. Stephans seconded the motion, which was unanimously carried.
