Recognitions:

- Mrs. Olson and Mrs. Schrick, FBLA Sponsors, were on hand to share the results from their recent trip to Baltimore, Maryland for the FBLA National Leadership Conference. The Blair FBLA program received the Gold Seal Chapter Award of Merit, Brett Petersen (also present) earned a top 15 National placing for Future Business Leader, and Sydney Andreasen earned the National Business Achievement Award, which is a top award in their four-level program. More than 390 Nebraska students, advisers, and guests recently attended the Future Business Leaders of America (FBLA) National Leadership Conference. Nebraska FBLA members competed June 28 July 1 in 71 competitive events. More than 9,000 FBLA members from 46 states, as well as U.S. territories and international chapters, attended the conference.
