## Plan Summary [2024-25]

### General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

Primary Charter School is a five-(six, if attending TK)-year program that provides four organizational classroom models: Transitional Kindergarten, Initial Phase (kindergarten), Phase One (grades 1 and 2), and Phase Two (grades 3 and 4). The instructional program focuses on a multiage setting for Phases One and Two. Kindergarten is not multiage due to the wide variety of life experiences these students have when entering school. Because of the multiage approach, the instructional program is designed with a two year curriculum cycle in each phase. Teachers teach in teams to support small group instruction and the multiage setting. The instructional program also focuses on developing school wide outcomes in each of the grades. All students are expected to exit Primary Charter School demonstrating the following characteristics:

- Polite Citizenship
- Productive Workers
- Proud Individuals
- Positive Cooperators

Primary Charter School's demographics include the following: Enrollment, 402 students TK-4th grade, Socioeconomically Disadvantaged, 21.6%, English Language Learners, 14.4%, and Foster Youth, 0.5%.

### Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

Primary Charter School continues to exceed standard in English Language Arts (ELA) and Mathematics based on data reported on the California School Dashboard. In ELA, Primary's performance color is Yellow, and 9 points above standard. In Mathematics. Primary's performance color is Green and 23.9 points above standard. Primary Charter has ten performance groups, however only three who are

statistically significant. Those groups are White, Socioeconomically Disadvantaged and Hispanic. In the Chronic Absenteeism category, Primary is Yellow, with 17.4% of students reported as chronically absent. This is a decline of 3.8% from the previous year. The Suspension Rate is Blue at 0% suspended at least one day, which is a decline of 0.5%. All local indicators were met. In the English Learner Progress category, although no color was assigned for the 2023 school year, 58.1% of English Learners are making progress which was an increase of 11.9% from the previous year. I-Ready assessment data reports revealed continued improvement in all grade levels over the course of the school year.

**An explanation of why the LEA has developed this goal.**

This goal was developed in response to the needs identified through data analysis and input from educational partners.

The analysis of California School Dashboard (Dashboard) data indicated a clear need to continue supporting English Language Arts (ELA) and English language development (ELD). For example: 56.34% of all students in grades 3–4 met or exceeded standard in English Language Arts on the Smarter Balanced assessments. However, this is a decrease of 13.9 points from the previous year which showed 62.67% of students meeting or exceeding standard. 58% of English learner students progressed at least one English Learner Progress Indicator (ELPI) level in 2023, and increase from 46% in 2022, however, more progress can be made.

During the LCAP development process, educational partners identified the need for:

- Ongoing instructional support for ELA and ELD
- Increased collaboration time for teachers
- Assistance to low-income and English learner families in understanding the online tools and student management system so that they can better support their student(s) at home
- Expanded learning opportunities for students who are low-income, English learners and foster youth
- Access to reading materials for low-income students to be used at home
- Supportive learning environments at home for foster youth
