Q: This RFP states that you are looking for proposals from Group Purchasing Organizations. We are a wholesale food distributor not affiliated with and GPO's, does this mean we would not be bid on this?</p> <p>A: The MSBSD seeks proposals from any firm that can meet the requirements as set forth in the RFP documents. The term GPO is intended to encompass a wide range of organizations which exist to assist end users with the efficient and cost-effective procurement of food supplies.</p> <p>2. Q: Appendix 4 - Our distributor manages ordering, delivery, and payment of all products. We do not need purchase orders, and will not receive any payments from the school district. Is it ok to not check the boxes in the bottom section that pertain to the types of services will not be providing? Or will that disqualify our company?</p> <p>A: The MSBSD prefers that Appendix 4 be completed to the fullest extent possible. However, in this case, if the terms of the proposal do not require payment from the MSBSD to the proposer, an incomplete Appendix 4 would not be automatically disqualifying.</p> <p>3. Q: Please clarify what is meant by 'delivery time' on market Basket Excel sheet.</p> <p>A: Delivery time is defined as the amount of time the vendor expects delivery to take after receipt of an order for that item.</p> | | |
