Terms of Sponsorship and Advertising Agreement

Payment — All Sponsorship and Advertising Placement requires payment in advance by October 1st of the current school year. With the exception of the Platinum Package Billing Plan (up to 9 equal installments of \$1,111.11) as determined between the Sponsor/Advertiser and Rancho Santa Fe Education Foundation. In the event that the Advertiser fails to pay, the Rancho Santa Fe Education Foundation may immediately cancel Advertiser's contract, and Advertiser agrees to indemnify and hold harmless the Rancho Santa Fe Education Foundation for all expenses incurred in connection with the collection of amounts payable, including, but not limited to, court costs and attorney's fees.

Rates & Rate Changes — The Rancho Santa Fe Education Foundation may revise its rate schedule, and should rate schedule changes occur, you will be given a 30-day notice. You may, without penalty, cancel within 30-days written notification, your Sponsorship & Advertising Agreement with the Rancho Santa Fe Education Foundation. All elements for each Sponsorship Package are based upon Sponsor/Advertiser commitment prior to October 1st of the current school year.

No Commission — All Sponsorship Packages and Advertising Rates are net. No commissions are allowed to advertising agencies for Sponsorship or Advertising.

No Results Guarantee — The Rancho Santa Fe Education Foundation does not guarantee that Sponsorship or Advertising Placement will generate response or results for the Advertiser.

Acceptance & Standards — The Rancho Santa Fe Education Foundation may, in its sole discretion, edit, classify or reject, at any time, any Sponsor/Advertiser, Advertising Copy, Imagery and/or Photos. Furthermore, the subject matter, size wording, illustration and typography of all advertisements are subject to the approval of the Rancho Santa Fe Education Foundation.

Indemnification — Sponsor/Advertiser agrees to indemnify, defend and hold harmless the Rancho Santa Fe Education Foundation from all claims, administrative filings, suits, judgments, proceedings, losses, damages, costs and expenses, of any nature whatsoever (including reasonable attorneys' fees and costs) for which the Rancho Santa Fe Education Foundation or any of its affiliates, subsidiaries, agents, employees, contractors, trustees and volunteers may become liable by reason of the Rancho Santa Fe Education Sponsorship Packages or Advertising vehicles of Advertiser's advertising.

Copyright — All advertising copy which represents the creative effort of the Rancho Santa Fe Education Foundation and/or the utilization of creativity, illustration, labor, composition or material furnished by it, is and remains the property of the Rancho Santa Fe Education Foundation, including all rights of copyright and trademark there in. Sponsor/Advertiser understands and agrees that it cannot authorize photographic or other reproduction, in whole or in part, of any such advertising copy for use in any other medium without the Rancho Santa Fe Education Foundation's prior written consent.

No Sequential Liability — The Sponsor/Advertiser's contract renders void any statements concerning liability or indemnity which appears on correspondence from Sponsor/Advertiser or its Agency, and is irrevocable without the written consent of the Rancho Santa Fe Education Foundation. It is further agreed that the Rancho Santa Fe Education Foundation does not accept sponsorships, advertising orders or space reservations claiming sequential liability.

Taxes — If any federal, state or local taxes are imposed on the printing of advertising material or on the sale of advertising space, such taxes shall be assumed and paid by Sponsor/Advertiser.

Cancellations — Cancellation of Sponsorship Packages and ad space must be done with 30-days written notice, prior to the time that the artwork is due. Sponsorship Packages cannot be cancelled after October 30, 2022.

Responsibility of Errors — The Rancho Santa Fe Education Foundation will not be responsible for any errors on any communication, message or advertisement. Errors noticed should be called to the attention of the Rancho Santa Fe Education Foundation. No credit will be provided to any Sponsor/Advertiser.

Typographical Errors, Incorrect Insertions or Omissions — The Sponsor/Advertiser's contract cannot be invalidated, and the Rancho Santa Fe Education Foundation will not be liable, for (a) the incorrect publication (including, without limitation typographical errors), or insertions or omissions in advertising published by the Rancho Santa Fe Education Foundation or (b) any resulting losses.

Proofing Policy — Submission of your ad copy is confirmation that you have proofed the ad, and affirm that all content in the ad is correct, and hereby release the Rancho Santa Fe Education Foundation from liability of any content errors that should be discovered after production begins. Changes from original copy and resetting for any reasons will be charged to the Sponsor/Advertiser.

Assignment — Sponsorship and Advertising contracts may not be assigned or transferred by Sponsor/Advertiser or its Agency if any.

Positioning of Advertisements — The Rancho Santa Fe Education Foundation shall have full decision making authority with respect to positioning all advertisements.

Photo Releases — Photographs of individuals to be used in advertising must be accompanied by a signed release from the individual permitting the use of the photograph(s).

Use of School Directories — The Rancho Santa Fe Education Foundation will provide Sponsors/Advertisers with a copy of the Annual School Directory in which student information has been redacted, to be used as a reference tool for individual, non-commercial and confidential use. The contents of the Annual School Directory may not, in whole or in part, be reproduced, copied, disseminated or entered into a computer database in connection with a mailing list by any means. Use of Directory information for commercial, political or promotional (marketing and sales) purposes is strictly prohibited.

This Agreement is entered into by and between the Rancho Santa Fe Education Foundation and the Sponsor/Advertiser listed on the reserve side of this form.
