

Fee Schedule

Early Years

Applicable from 1 August 2024

From 1 August 2024, ELA Basel Early Years timings will change to align with Basel-Stadt requirements. Families will be able to choose from 4 different time segments each day (see below). Children must be enrolled for a minimum of 40% each week.

Fees include all meals, snacks, outings, curriculum materials, resources and hygiene products (wipes, nappies etc). ELA Basel has one powder-milk option for babies available.

Please note that there is no registration fee or deposit required for Early Years families.

The full-time fees per month from August 2024 are:

- Infants up to 18 months of age CHF 3,750-
- Children 18 months - 4 years CHF 2,800-

Calculating Fees

Fees are calculated based on your percentage of enrolment and the maximum fee.

For example 62% enrolment of a 2 year old child is calculated as CHF 2,800 x 62% = CHF 1,736

Other ELA Basel Fees and Discount Information - from August 2024

- ELA Basel provides a family discount of 10% of the second child's fees and 15% for the fees of the third child or any further child enrolled.
- No discounts are given to families with any portion of their fees invoiced directly to an employer or for families who also have a portion of their fees covered by Basel-Stadt.
- A registration fee of CHF 500- per child is due upon **Primary Years** contract signing.
- ELA Basel requests a one-time donation of CHF 1,500 for the first child and CHF 1,000 for each child thereafter, to its Development Fund, at the time of **Primary Years** contract signing. This donation is tax deductible.
