A. Finance

1. Comprehensive Agreement Between Ohio Association of Public School Employees/AFSCME Local 4/AFL-CIO and Bellefontaine Board of Education

The Comprehensive Agreement between the Ohio Association of Public School Employees/AFSCME Local 4/AFL-CIO and Bellefontaine board of Education expires July 31, 2022. The current contract contains a provision to reopen the "Wage Equalization Payments" during the second and third years of the contract. Representatives of the OAPSE and Board have negotiated the Comprehensive Agreement and have reached an agreement. Members of the OAPSE ratified it August 25, 2022. It is the recommendation of the Superintendent that the Board approve the Negotiated Agreement between the two parties effective August 1, 2022 through July 31, 2025.
